

11/30/15 Statement from City of Rio Dell, City Manager Kyle Knopp in response to Public Records Act request:

Dogs that are brought to the attention of the City are handled by the Police Department. Priority is given to animals that are considered a threat to the health and/or safety of the general public. If the owner of a dog cannot be located or identified within a reasonable amount of time, the dog would be transferred to the custody of the Fortuna Police Department under the current agreement. This arrangement continues to this day. Currently, there is no formal agreement with Miranda's Rescue. The City had a formal relationship with Miranda's Rescue that ended in 2013. The City is not currently seeking to enter into a formal relationship with Miranda's Rescue. However, the City has offered to help raise funds for Miranda's Rescue through advertisement in the newsletter. Since November of 2014, the City has been billed and paid for 40 dogs turned over to the Fortuna Police Department for a total cost of \$8,000. The budget for FY15-16 animal control, across all animals, is \$6,500.

Comments : **On 11-12-14 the Rio Dell Police Department was informed a pregnant dog had been located near Grundman's Sporting Goods. The animal was located on 11-08-14 and was subsequently transported to Miranda's Rescue. At the time the dog was reportedly in active labor and later gave birth to 10 puppies. The reporting person, [REDACTED] completed a document while at Miranda's Rescue indicating where the dog was located.**

On the above date and time Chief Hill and I went to Grundman's Sporting Goods and spoke with employees about the dog. None of the employees including Fred Grundman who was working on 11-8 saw the dog in or around their business. Chief Hill and I also contacted neighboring residents and patrons at Mingo's Sports Bar. None had seen the dog in Rio Dell.

While speaking with Bar Patrons, [REDACTED] told us she had seen a similar dog in the Williams Street, Scotia are a couple weeks ago.

Chief Hill and I then went to the R/P's residence located at 746 Williams Street, Scotia. While speaking with [REDACTED] we learned that the dog had in fact been located on her front porch. She further explained that dog had been wandering around the Williams Street area for about a month and may have belonged to a man who was recently evicted from a Scotia residence. She only knows the man's first name as, [REDACTED].

Upon further questioning [REDACTED] stated she thought she had seen the dog in the Rio Dell area once in the past. A copy of the Miranda's rescue form was shown to her and she admitted to being the person who filled it out. When questioned about why she indicated



**on the Miranda's Rescue form that she had located the dog at Grundman's [REDACTED] stated
that the woman at Miranda's Rescue asked her to write down the location even though that
was not where the dog had been located. I recorded our conversation with [REDACTED] and a
copy of the recording was later entered into the Department's digital evidence archive.**

**Upon our return to the Rio Dell Police Department Chief Hill Contact Robin Paul of the
Fortuna Police and informed her of our findings. Paul later indicated that she would contact
Miranda's rescue and informed them of our findings and their need to contact the Humboldt
County Sheriffs Department if further assistance was needed.**
