Narrative Report

On 01/02/09 at about 1650 hours, I was dispatched to the Shell gas station located at 582 Wildwood Avenue for a report of a physical fight between two male subjects. I responded from The Rio Dell Police Department and arrived within a minute. I was driving a fully marked police car and in full uniform. Upon arrival I noticed two male subjects standing next to a parked county truck. As I exited my patrol car and ran towards them one subject backed away. I separated the suspects and walked one of them to the side of the gas station. I recognized him as the cities Public Works Director Jim Hale.

Chief Hill arrived and contacted the other party in the altercation who was identified as Ronald Cross. He stood by Cross while I talked to Hale.

I contacted Hale who stated that he stopped at the Shell station to get gasoline when he saw Cross arrived. He stated that Cross flipped him off so he gave the gesture back. Haie said that Cross walked up to his vehicle and yelled get out of the car. Hale stated that he exited his vehicle and started to take off his jacket when Cross punched him on the jaw. He said that he swung back hitting Cross in the face. The two then started to fight. He said he didn't remember how many times he punched Cross. He said he thought he broke cross finger but was not certain. Hale said he was still fighting when police arrived. I asked Hale if he needed medical assistance and herdeclined.

I contacted Cross who stated he pulled up to the Shall to buy something when he noticed Hale giving him a finger gesture. He said he flipped him off back. He said he got angry and walked over to Hale's vehicle to talk to him. He stated that Hale exited his vehicle and purched him. He said he fought back in self defense. Cross said that the fight lasted until police arrived. Fasked Cross if he needed medical assistance and he also declined.

I contacted Michelle Hale who stated in summary that she and her husband Jim Hale were stopped at the Shell gas station getting fuel when Ronald Cross drive by, She stated that Jim flipped him off. She said that Cross pulled into the parking lot and walked towards their chainle. As he stood next to the drivers side Cross yelled " come on get out". The stated that Jim grinnes, at him as he was sitting in the truck. She stated that Cross said again "come on, come on I'll kick your ass". Hale stated that Jim stepped out of the vehicle and they exchanged words. She did not see who started the fight or who threw the first punch. She said as the two men fought she called the police.

I contacted a Shell station employee who was identified by a California ID card as Silas Brewer. He stated that he was working the cash register of about 1645 notice and it shot icea two male subjects outside near pump # 4 fighting. He stated that he didn't know who started the fight only that they were both throwing punches. He stated he then notified police

I made a digital recording of my conversations with late, Crees Brewer and placed it into the digital evidence archive. The Shell station manager Sheila Howles (manager of Shell) provided me with a video of the incident. I placed the video into evidence.

On 01/06/09, I contacted The City or Nie Dell public works employed James Barrington. He stated he had no knowledge of any incidents that essurred at work or eutside of work involving Ronald Cross and Jim
