

EUREKA POLICE DEPARTMENT PRESS RELEASE

The Humboldt County Drug Task Force, with the assistance of Eureka Police Officers conducted a Maximum Enforcement Operation on Wednesday, February 18, 2009 in the downtown area of Eureka. This enforcement came as a result of citizen and EPD officer's complaint about crime in the downtown area

The operation lasted approximately eight hours and resulted in the arrests of thirteen persons. By the end of the day the word was out and the presence of the known criminal types left the area. The success of the operation is not the number of arrests that are made but the impact on the criminal element that frequent that area. The arrests are as follows:
