Please note that the ones flagged in yellow highlight were a bit unclear about what they referred to, so we answered as best we could based on what we thought was meant. And 1 question is actually a question for Ali, since none of us works directly with Hope Crisis.

**For Cati's questions:**

- Total # Habitat structures repaired: **0**
- How many DCM clients has Habitat assisted:
  - including renter/landlord program: **24**
  - just USDA: **19**
- How many USDA applications have been turned in to USDA: **5 completed with all documentation submitted to USDA**
- How many USDA applications have been accepted by USDA: **5**
- How many USDA are currently in process: **8 (\*note: some clients started the application process, but were not able to continue. For example, several had more assets than they originally thought and those total assets made them over income; a few opted out; at least one who did qualify area wise, was not considered rural by USDA definition)**

**Nick's questions:**

**USDA Program:** 10 dwelling applications – updated total: 19

**Habitat for Humanity (rental income properties):** 10 single or multi unit properties – updated: 5 total; 4 landlords, 1 with 2 properties

**Habitat for Humanity Renter Program:** 10 active low income renter applications – updated: only 1 renter (\*note: the program has changed procedures. Now landlord are being accepted and there is a partnership with the City of Rio Dell, County of Humboldt, and local housing non-profits to match renters with landlords who will participate in this program.)

**Hope Crisis Response Network active cases:** 23 dwellings – this is a question for Ali

**Total Dwellings with active applications and/or work started:** 55 dwellings/applications – unclear what this refers to. Is this all applications/clients, including Unmet Needs, USDA, HSH, and Hope Crisis? Just need a little more clarification to be able to answer this one. There are currently 54 active clients in process with gathering documents, waiting on SBA loans, or are in the process of having Unmet Needs work that was approved move forward; or who have asked to pause their process due to other commitments

**Additional pending applications working through the vetting process, not yet in a specific program:** 10 – does this mean any DCM clients who have not be assigned to specific programs yet? There are 5 new clients that we are starting the needs assessment process with after the flyer went out

**Cases closed to date:** 10 (work furnished and completed), 60 (opt out or not eligible) – updated total: 155 closed; there are 10 additional clients who have completed work through the Unmet Needs approved, with 5 more pending. Total amount to date approved by Unmet Needs Committee is \$84,072

**Client type by percentage:** - not sure where these stats came from (maybe from the City or the County), but I don't think these have changed too much
