WHEREAS the City has reviewed and process the proposed Zone boundary adjustment in conformance with Section 17.30.010 of the City of Rio Dell Municipal Code; and

WHEREAS the City finds that based on evidence on file and presented in the staff report that the proposed amendments are deemed to be in the public interest; and

WHEREAS the Planning Commission held a duly noticed public hearing on July 27, 2011 and conditionally approved the proposed amendments and adopted Resolution No. 40-2011 recommending approval to the City Council; and

WHEREAS the applicant's fulfilled the condition by recording the required Notice of Lot Line Adjustment and Certificate of Subdivision Compliance on December 8, 2011; and

WHEREAS the City received a copy of the recorded Notice of Lot Line Adjustment and Certificate of Subdivision Compliance on December 29, 2011; and

WHEREAS the City finds that based on evidence on file and presented in the staff report that the proposed amendments are consistent and compatible with the rest of the General Plan and any implementation programs that may be affected; and

WHEREAS the City finds that based on evidence on file and presented in the staff report that the potential impacts of the proposed amendments have been assessed and have been determined not to be detrimental to the public health, safety, or welfare; and

WHEREAS the proposed amendments have been processed in accordance with the applicable provisions of the California Government Code and the California Environmental Quality Act (CEQA); and

WHEREAS the City has determined that the project is Statutorily Exempt pursuant to Section 15061(b) (3) of the CEQA Guidelines, Title 14, Chapter 3 of the California Code of Regulations.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Rio Dell approves the Broussard minor plan and zone boundary adjustment amending the General Plan Land Use Diagram to re-designate approximately 5050+/- square feet from Town Center (TC) to Urban Residential (UR).





Broussard General Plan and Zone Boundary Adjustment





Background

Attached is the 2011 Police Department Annual report which provides some general statistics and general information about police department activity during 2011.

Introduction/General: This was an interesting year for the police department that presented several challenges, the most significant of which was a reduction in staffing that took place in February. We have worked hard this last year making the necessary adjustments to make sure that the community is getting the best possible level of service, and all of the internal departmental tasks are being completed. Our staff has responded extremely well, and while we certainly experienced a few bumps along the way we have adjusted accordingly.

Training Accomplishments: This year we sent Officer Harralson to H&S 11550 training and I attended POST Management Training. We also sent Officer Beauchaine to training that was provided pursuant to our participation in a Alcoholic Beverage Control grant along with the Fortuna Police Department and the Ferndale Police Department.

We conducted some interdepartmental training, however the majority of this year was spent adjusting to staffing levels by identifying new areas of responsibility, and addressing shortfalls in service levels and making the necessary adjustments. In November of this year the department participated in a daylong meeting during which we discussed our role in the city and our approach to law enforcement in our community. Much of what came out of that meeting will be reflected in our goals for 2012.

Fleet: Based on smaller staffing levels we reduced our patrol fleet by two vehicles. The two vehicles we surplused were the oldest vehicles in the fleet and would have required replacing in the near future. We will be proposing a fleet replacement program during 2012 to be considered for implementation in the future to reduce maintenance costs.

Technology: We implemented our new server last year and added lap top computers to our vehicles during 2011. This has made a significant impact on our ability to keep our officers in the field and has also changed the way we document information. We are more efficient and effective as a result of implementing the lap top computers in conjunction with our server. The server has accomplished taking four databases of information and combining them into one central database with multiple back-up capabilities. The in-car computers allow officers to remain in the field to complete much of their documentation as well as access information making our patrol efforts considerably more efficient. It does not eliminate the need for officers to be in the office, but reduces the amount of time.

One of the chief complaints we received this past year was a lack of someone in the office to handle walk-in traffic at the Police Department. We tried several approaches and finally settled on a phone system at the front door. The new system allows people who come to the front door of the police department for service to simply pick up the line and be connected to our dispatch service who then can have an officer respond to the station to assist. We have received very positive comments from the community on this arrangement and it seems to be working well.

Personnel: We maintain five full-time sworn positions (which include the Chief of Police position). We experienced some issues while adjusting to different workloads and responsibilities; we have adapted and provide a quality service to the community. During most of 2011 we maintained two Reserve Police

officer positions; however we lost one officer near the end of 2011 when he was hired on as a full time officer out of the area. We have completed the background process on another candidate and expect to swear him in this month which will bring us back up to two positions. It is our goal in 2012 to increase the number of reserve police officers. We also have had some community members express interest in volunteering at the police department. We are working on defining what role a volunteer could play in our department and intend on taking advantage of volunteers this year.

We have also been able to take advantage of the Cal Works Program for short periods of time during 2011 which provided some brief extra assistance while we adjusted to changing roles in the departments. We are starting this year with a Cal Works employee who will likely be with us through the next six months.

Statistics: Attached are statistics for 2011 (January 1st through December 31st). As has been explained we are using the Calls For Service Module differently which results in smaller numbers reflected in that category toward the end of the year, however the information we are not capturing in that module is being collected in another module. We used the new system for such a short period the difference is negligible for 2011.

You will note a significant drop in Total Offenses on the Incident Offense Three year Comparison chart (this drop only applies to the listed crimes on the form). While statistically we have experienced a slight decrease in criminal activity, this also reflects a reduction in staffing to a certain degree. When there are fewer police then fewer crimes can be documented.

We also started collecting accident data a little differently during 2011 than in prior years. While our change has made us a little more efficient I have noted where certain information was not collected that reflects accident numbers. I have attached a separate call sheet at the end of the report for both traffic accidents and animal control incident that more accurately reflect the departments activities in these areas.
