SPECIAL PUBLIC HEALTH EMERGENCY ALTERATIONS TO MEETING FORMAT CORONAVIRUS (COVID-19)

Motion was made by Johnson/Woodall to approve the consent calendar including approval of the Minutes of the December 15, 2020 regular meeting, the Minutes of the December 18, 2020 Special Meeting, the Adoption of Resolution No. 1474-2021 Approving the billable rates for staff, Authorization for the Mayor to sign a letter of appreciation to Supervisor Estelle Fennell and the authorization for the Mayor to sign a letter of support for Gordon Johnson to be appointed to the Local Agency Formation Commission (LAFCo). Motion carried 5-0.

REPORTS/STAFF COMMUNICATIONS

City Manager/Staff Update

City Manager Knopp reviewed highlights of the staff update and reported that the City has been invited by CalOES to apply for Hazard Mitigation Grant funds for water storage enhancement and seismic resiliency for the water connection to Metropolitan Wells. The City Manager reported that staff was looking at new public garbage bins for the city and stated an Ad Hoc Committee would be requested of the council to assist in the process. The City Manager also talked about requests for assistance from MIST for additional homeless outreach and the Davis Street Sidewalk.

Councilmember Woodall asked about a sidewalk along Eeloa Avenue. The City Manager reported that the sidewalk was being replaced because of damage caused by the contractor.

Councilmember Woodall asked about calls for police services at the Danco project which she observed as increasing and asked about meetings with Danco. The City Manager reported that meetings had taken place last year and that the issues present at that time seemed to have been resolved and that there had been agreement to hold the meetings on an as needed basis. Mayor Garnes encouraged individual councilmembers to approach DanCo management with questions.

Councilmember Woodall asked staff who was cleaning up after the homeless along the river bar. The City Manager reported that Public Works and the Police Department were cleaning garbage on Edwards Drive Monday the 4th.

Councilmember Johnson asked staff about the next steps for the two water grants. The City Manager reported that next level applications were due towards the end of March and that the City's engineering form, GHD, would be working on it.

Councilmember Wilson asked staff about work reported being done on North Pacific Avenue. Police Chief Jeffrey Conner stated that the Police Department and Public Works were also recently on North Pacific cleaning trash.

Councilmember Wilson asked whether the river trail on Davis still existed and the City Manager reported that he believed so.

Mayor Garnes reported seven additional COVID-19 cases represented by County Health Department's latest report.

Councilmember Woodall requested and was granted permission to ask an additional question to the Chief of Police regarding the new Police Officer and if he was now working. Police Chief Jeffrey Conner reported that Officer "Conan" was starting tonight and would be working closely with Sergeant Beauchaine and the Chief over at least the next six weeks. Chief Conner mentioned a 10-week Field Training program.

Dear Chairman Pai,

We write this letter to you from the City of Rio Dell in northern California as a public agency in the broadcast Designated Market Area of Eureka, CA.

Failures in our communications and information ecosystem are harming our community. The latest example is the loss of carriage of Cox Media Group's two network broadcast TV stations' over Suddenlink Cable (Altice), the system operator serving most of the region's population. As a result, local news and information provided by Cox Media Group (CMG) owned stations KIEM (NBC) and KVIQ (CBS) are not available to cable subscribers.

We call upon those corporations to consider the impact on local communities, and note that Altice has offered CMG to continue carrying those stations while they negotiate their retransmission consent agreement. Ultimately, these absentee corporations are negotiating a cost that will be born by local cable subscribers in our region.

We also call upon Congress and the FCC to address the underlying policy actions needed to secure and protect media localism. Efforts like Congressman Huffman's proposed legislation, the Local and Independent Television Protection Act, deserve immediate attention and widespread support.

The FCC could reconvene their Localism Task Force to address the loss of diverse local voices. And State policymakers can reform the failed framework promoted by industry capture - like California's Digital Infrastructure and Video Competition Act which eviscerated local jurisdictions' authority to protect ourselves.

Ultimately, we need our federal and state policymakers to recognize the essential role that local media play to meet local needs for: public health and safety; education; economic and

community development; culture and arts; and civic engagement. Local governments and our communities stand ready to take back local media and rebuild our information ecosystem to secure competition, diversity and localism in the marketplace of ideas.

During the period December 30, 2020, to January 12, 2021, there were thirteen calls for service related to animal control issues. No animals were transported to Miranda's Rescue. On January 7, 2021, CSO Matthews responded to a report of an emaciated dog near the end of Davis. Officer Matthews was unable to catch the dog. However, she contacted Miranda's Rescue and made arrangements to borrow their live trap.

On January 5, 2021, Officer Russell "Conan" Johnson started his first shift as a Rio Dell Police Officer.

On January 8, 2021, Sergeant Beauchaine and Officer Johnson noticed two off-road vehicles headed east on Center Street. When the motorcyclists saw the police car, they immediately turned around and headed west at a high rate of speed. They ran the stop sign at Wildwood and then at Pacific, turning south. A pursuit was initiated. It continued west on Monument for about three miles before the motorcyclists elected to yield. The two teenage boys were handcuffed and their vehicles were towed. They were cited for avoiding an officer and running three stop signs. Their parents were contacted and picked them up on scene.

On January 12, 2021, the Department received multiple calls about a car intentionally ramming the Proper Wellness Dispensary. Officer Fielder and Chief Conner responded. Officer Fielder contacted the victims and was able to obtain an accurate description of the car and the suspect. A short time later, Officer Fielder located the car parked in Scotia. As he got out of his car, he realized that there was a struggle ensuing on the property. He quickly learned that the suspect had mental health issues and his family was trying to restrain him. Officer Fielder, with the family's assistance, was able to get the man into handcuffs and in the rear of his patrol car. The man was kicking at the windows and door, so Officer Fielder rapidly transported him to the hospital. During the trip he was able to talk the man down so that he was calm when he arrived. Officer Fielder then stood by until the man was sedated. This

proved to be necessary as he again suffered a mental crisis when he learned he would not be leaving anytime soon.

Code Enforcement

During the period of December 30, 2020 to January 12, 2021, the Department opened six new cases dealing with junk vehicles and closed two. Both of the offending vehicles were towed by the city. There were ten open cases at the end of this reporting period.







IT IS RECOMMENDED THAT THE CITY COUNCIL:

Authorize the City Manager to Execute the Scope of Services Agreement and approve Resolution No. 1476-2021

BACKGROUND AND DISCUSSION

In August of 2018, a coalition of Humboldt County cities and special districts began a planning process to prepare for and lessen the impacts of specified natural hazards by updating the Humboldt County Operational Area Hazard Mitigation Plan. Responding to federal mandates in the Disaster Mitigation Act of 2000 (Public Law 106-390), the partnership was formed to pool resources and to create a uniform hazard mitigation strategy that can be consistently applied to the defined planning area and used to ensure eligibility for specified grant funding opportunities.

On December 1, 2020 the City Council of the City of Rio Dell approved Resolution 1469-2020 adopting Rio Dell's annex to the Humboldt Operational Area Plan.

Recently, staff and the City Engineer submitted two HMGP pre-application proposals to CalOES for grant funding of two projects, including seismic resiliency upgrades for our connection to the Metropolitan Wells water source backup and the seismic retrofit and expansion of the Douglas tank for additional water storage.

The Pre-Applications were successful and the City was invited to proceed with an actual application. Staff believes the projects and the City are in a good position to receive grant funding. The City will need to further utilize GHD to move the applications forward at a cost of \$22,800.

If approved, the City would need to contribute \$562,550 out of the Water Fund in order to leverage \$1,687,500 in federal funds. Additionally, if the City is successful and the Metropolitan

Wells connection project continues, the City would likely need to contribute additional funds at a cost share of 25 percent of the cost of the project. This cost share could come from the Water Fund, other grants or a mixture of the two.

GHD is pleased to present Rio Dell with the proposed Scope of Services below to complete applications under California Office of Emergency Services (CalOES) Hazard Mitigation Grant Program (HMGP) for the City of Rio Dell Bridge Utility System Seismic Retrofit Water Project and Seismic Retrofit of Douglas No. 1 Redwood Tank. The City submitted a notice of interest for these two projects in November 2020 which were accepted in early January 2021 and Rio Dell was invited to submit full applications for the projects, which are due by March 5, 2021.

The scope of services below describes the tasks to complete the HMGP Application for the two projects. A separate cost breakdown is provided at the end of this proposal.

Task 1 – HMGP Sub-Applications

Under this task, the CalOES HMGP project sub-applications will be completed. This task will include the completion of the following sections:

- 1. **Subapplication**: General information, contacts, planning information, discussion of hazards and project alternatives and incorporation and reference to other application sections.
- 2. **Scope of Work**: The scope of work will be based on the engineering report previous completed.
- 3. **Design**: The preliminary design information from the State Water Resources Control Board planning grant will be used to support this section.
- 4. Studies: IT is not anticipated that any additional studies will be needed for the application.
- 5. **Maps**: Complete maps showing the full proposed project areas in the required HMGP format will need to be developed. Maps showing the project site, likely staging areas, access routes, natural resources, FEMA flood plains, and other required data will be developed for this section.
- 6. **Photos**: Photos of the project areas and key feature that support the hazard issues will be taken and organized and labeled for the application, to meet the application requirements.





- 7. Schedule: A project schedule will be developed meeting HMGP requirements.
- 8. **HMGP Cost Estimate and Cost Estimate Narrative**: A concept level cost estimate conforming to FEMA HMGP format and supporting cost data and a narrative will be developed.
- 9. Match Commitment Letter: GHD will prepare a draft letter for the City to complete.
- 10. **Benefit Cost Analysis**: The effort is described in Task 2, and results will be transferred to the subapplication.
- 11. **Maintenance Assurance Letter**: GHD will prepare a draft letter for the City. The City will provide GHD with a staff and materials estimate of maintenance costs.
- 12. **Environmental Documentation**: The effort is described in Task 3, and results will be transferred to the subapplication.
- 13. **Authorization**: GHD will draft an authorization resolution for the City to execute.
- 14. Supporting Documents: (as needed)

GHD will develop the draft application and sections above for Rio Dell review and comment. Word versions of the Match and Commitment Letters will be provided to Rio Dell.

Task 1 Deliverable:

- Draft HMGP Application and Attachments in electronic format
- Final HMGP Application and Attachments in electronic format for submission to Cal OES.

Task 2 – Benefit Cost Analysis

The BCA software version 6.0 will be used to conduct a preliminary benefit cost analysis (BCA) to ensure the project meets the threshold eligibility criteria of a benefit cost ratio (BCR) greater than 1. The damage frequency assessment module of the BCA software will be used.

Data on earthquake recurrence, peak ground accelerations, and damage estimates will be conducted. A structural engineer will be consulted on the nature of damage to both the Eel River pipeline crossing and the water tanks to validate to FEMA the need for the project. This will be combined with data from the Humboldt County Multi-Jurisdictional Hazard Mitigation Plan (MJHMP) on earthquake severity historic damages as well as data pulled from FEMA BCA guidance documents or models and USGS data to support earthquake analysis.

The findings of the preliminary BCA will be written up for City review and consideration, and if the BCR is confidently above 1, the final BCA will be prepared, which would include additional documentation on



structure values and percent damage, earthquake event history and recurrence, and mitigation benefits. A Benefit Cost Analysis Report is prepared as an attachment to the analysis to document all the project assumptions and outcomes.

Task 2 Deliverables:

- Preliminary BCA Analysis in electronic format
- Final Benefit Cost Analysis Report and Attachments, Final BCA Model Files

Task 3 – Environmental Checklist

Under this task the Environmental Checklist attachment will be completed. The environmental review is an important part of the HMGP process. Under this task, GHD staff will use the information collected during the CEQA process to complete the environmental checklist. Discussion

As the Council is aware the City was awarded a planning technical assistance grant for \$160,000 last year to conduct a sewer lateral study in the Belleview/Ogle neighborhood. The purpose of the study was to identify those properties that have failing sewer laterals which contribute to inflow and infiltration (I/I). A copy of the Staff Report is included as Attachment 1.


The purpose of SB2 program is to provide funding and technical assistance to all local governments in California to help cities and counties prepare, adopt, and implement plans and process improvements that streamline housing approvals and accelerate housing production.


One of the concerns in accepting the grant and implementing the study is that we believe there is a significant number of properties that have failing laterals and as such these property

owners could be responsible for replacing the laterals. The average cost for a lateral replacement is about \$5,000. This is likely a burden that most of the property cannot afford.

Staff recently met via "Zoom" with representatives from the Department of Housing and Community Development (HCD) to discuss our concerns and possible other options utilizing SB2 funds. HCD staff clearly understood our concerns and encourage us to explore other options.

One of the options we discussed was possibility of developing pre-approved site and architectural plans that facilitate non-discretionary permitting for housing, including mixed-use (commercial/residential) projects. HCD was very supportive and encouraged by such a concept.





SB2 Planning Grant Staff Report January 19, 2021

The four properties are: (1) the Baptist Church property at the corner of Wildwood Avenue and Belleview Avenue; (2) the property between Painter Street and the southbound Highway 101 on-ramp along Wildwood Avenue; (3) the Rio Dell Mobilehome Park; and (4) the Todd property at Davis Street and Highway 101.

Staff, with the Council's approval, would contact the property owners to see if they have any objection to the City developing site and architectural plans/drawings for a mixed-use project on their properties. Once developed, the plans can be used to market the property with pre-approved plans. A significant benefit to not only the property owner but to potential developers as well. In addition, the City would benefit by meeting our Regional Hosing Needs Allocation (RHNA) obligations should development result from the pre-approved plans,

Once we har back from the property owners' staff will return to the Council requesting that the Council identify the priority site.

Council Options

1. Mover forward with the original I/I study; or

2. Modify the HCD application to pursue grant funds for developing pre-approved site and architectural plans that facilitate non-discretionary permitting for housing, including mixed-use (commercial/residential) projects and direct staff to reach out to the four property owners; or

3. Do not pursue any SB2 funds at this time.
