addressed the Council regarding abandoned and/or junk vehicles and the need for a new sign at the Davis St. Park and asked if staff had ordered a new sign.

City Manager Knopp commented that his understanding is that the Police Department has made progress on the abandoned vehicles. He said that staff would be following up on the new sign at the Davis St. Park regarding no overnight parking. He indicated that abandoned vehicles go through the Nuisance Committee and that they had a meeting this afternoon and discussed various nuisance issues.

Councilmember Strahan asked that staff report to Council on the status of the sign. She then questioned whether Chief Conner had responded to Mayor Pro Tem Johnson's question as to whether the driver of the motorcycle traveling at a high rate of speed had been identified.

Chief of Police Conner stated that they have a likely suspect but no arrests have been made.

Councilmember Strahan then asked if staff had followed up on the issue regarding the need for the City to provide property insurance coverage on CDBG properties.

Finance Director Kerrigan explained that under the CDBG loan program, recipients are required to maintain insurance coverage on their properties. As such, staff would be sending out letters requesting the recipients provide proof of coverage followed by further discussions with SCORE representatives to determine what the City needs to do to protect its interest with regard to those properties without coverage.

Councilmember Strahan reminded staff to be sure to follow up with an update to Council on the outcome of those loans.

Motion was made by Johnson/Marks to approve the minutes of the November 20, 2018 regular meeting. Motion carried 4-0.

Approval of a 6-month Extension of the City's Track and Trace Services Contract with SICPA Security LLC and Update on Activity in the Humboldt Rio Dell Business Park

Councilmember Strahan referred to the staff report indicating that it was anticipated that the Board of Supervisors would approve a six-month extension and asked if they had approved it at their board meeting earlier in the day.

City Manager Knopp commented that he was not able to watch the televised board meeting today but in the event the extension was not passed, staff would bring it back to Council for further discussion.

Councilmember Strahan asked if the item could be tabled pending action by the Board of Supervisors.

City Manager Knopp recommended approval of the extension with the agreement that if anything changes with regard to the County, staff would bring the item back to the Council for further discussion.

Councilmember Strahan asked for clarification on how the accounts were set up for the cannabis related revenue.

Finance Director Kerrigan clarified that separate accounts were set up for cannabis related activity so the revenue can easily be tracked.

Councilmember Strahan then questioned the total revenue of \$420 for Track and Trace revenue and asked if the City had received any revenue from gross sales from the Glenn White Group.

Finance Director Kerrigan explained the breakdown of revenue and said the \$420 was for the product stamps sold at five cents each.

City Manager Knopp noted that there were no trackable sales from the Glenn White Group for the previous quarter due to a delay in getting their State Distribution License however; they did finally receive it so they will be submitting taxes to the City on a quarterly basis from this point forward. He explained that the City collected \$23,000 in operating fees in addition to the \$420 in Track and Trace fees, and \$23,416 in building permit fees for total revenue to date of \$47,256.

Councilmember Garnes arrived at this time, 6:45 p.m.

Motion was made by Johnson/Marks to approve a 6-month extension of the City's Track and Trace Services Contract with SICPA Security LLC. Motion carried 5-0.

REPORTS/STAFF COMMUNICATIONS

City Manager/Staff Update

Mayor Wilson said that he noticed that vehicles from the Davis St. Park were removed and asked if the city initiated the removal or if the owners removed them voluntarily.

Chief of Police Conner explained that the problem with the vehicles is that there is a residence on 4th Ave. where they have more vehicles than they have room to park which is why one of the vehicles was parked at the Davis St. Park. He noted that the police department will tag the vehicles with a 72-hour notice and before the time is up, they manage to move them around to avoid getting them towed.

He said that at the Nuisance Committee meeting today, staff provided the police department with a list of abandoned vehicles so they will be working on it.

Councilmember Strahan asked about the potential cancellation of the December 18th regularly scheduled city council meeting.

City Manager Knopp said it was the City Council's discretion whether to cancel the meeting and said there were no urgent matters pending before the Council at this time.

After brief discussion, the consensus of the Council was to hold the meeting as scheduled, swear in, and seat the new city councilmembers.

Councilmember Strahan referred to the City Manager's update regarding off-site improvements for the DANCO project and asked if they would be required to do any water or sewer system improvements.

City Manager Knopp stated that staff has been in discussions with DANCO regarding off-site improvements including improvements to the sidewalks on Davis St., street improvements on Rigby Ave. and Center St., improvements to the Center St. Bus Stop, addition of a fire lane around the perimeter of the site as well as water and sewer improvements.

Councilmember Strahan asked if the current water and sewer system could handle the additional service connections. City Manager Knopp indicated that there would be no problem.

Councilmember Strahan then asked about the status of Measure J.

City Manager Knopp explained that the County Elections department has until the end of the day on December 6th to certify the election results and estimated an additional 50 ballots to be tallied with passage of Measure J currently trailing by 22 votes.

Councilmember Strahan asked for an update on the bicycle accident that was reported in the previous staff update.

Chief Conner explained that the child riding the bicycle turned from Painter St. to Ireland Ave. without looking; taking her into the path of a passing motorist so, it was not the drivers fault.

Councilmember Strahan commented that this accident is exactly why she wanted to see a crosswalk in that area.

Chief Conner pointed out that crosswalks are for pedestrians, not bicycles.

Sharon Wolfe, asked for clarification that what is being proposed for the DANCO project are improvements to the sidewalks from Davis St. to Wildwood Ave.; not bus stops.

City Manager Knopp clarified that it would only be improvements to sidewalks.

SPECIAL CALL ITEMS/COMMUNITY AFFAIRS

Laboratory Annual Cannabis Activity Fees

Community Development Director Caldwell provided a staff report and said that in February, the Council made a compromise and amended the Cannabis Regulations to allow adult "A" cannabis activities provided the operators obtained both the "A" and "M" licenses and paid both the \$4,000 annual operating fee and \$300 renewal application fee. He noted that the State didn't distinguish that testing laboratories be required to hold both "A" and "M" licenses. He said staff would like clarification from the Council on the annual fee as it applies to testing laboratories. He said based on the State's regulations, staff's initial thought is that they would not be subject to both fees.

Mayor Wilson asked if the regulations for testing laboratories were clear when they were presented to the Council.

Community Development Director Caldwell noted that they were not clear in the beginning and were later amended.

Mayor Pro Tem Johnson agreed with staff that laboratories should only be charged one fee.

Councilmembers Marks and Strahan felt that testing laboratories should pay for both the "A": and "M" \$4,000 annual operating and \$300 renewal application fee and that the regulations remain unchanged.

Councilmember Garnes expressed concern about driving businesses away and agreed with staff's recommendation to only charge one fee.

Mayor Wilson felt it made sense to charge one fee as it applies to laboratories.

Community Development Director Caldwell pointed out that these laboratories also test water and soil, not just cannabis and operate in the same manner as North Coast Laboratories.

Mayor Wilson called for public comment in which no public comment was received.

Motion was made by Johnson/Garnes to clarify that testing laboratories not be required to pay both the "A" and "M" \$4,000 annual fee and \$300 renewal application and that they only be required to pay one fee. Motion carried 4-1; Councilmember Strahan dissenting.

Provide Staff Direction on Syringe Exchange Program

City Manager Knopp provided a staff report and began by clarifying that the City is not proposing a needle exchange program or a ban as some may have thought based on the article in the newspaper. He said the supplemental information included in the packet is to provide factual information to the Council on Syringe Exchange Programs.

Councilmember Strahan commented that she was interested to see what the current laws are regarding syringe exchange programs and visited a local clinic for information. She said that she also went to Palco Pharmacy and was told that approximately 10 years ago, the City purchased ten (10) sharps containers and provided them to the pharmacy to be available to give out. She said that they still have some of the containers and that they indicated that there are not many people in the program locally.

She expressed concern regarding the State having the ability to come in and mandate cities to have a syringe exchange program and thought it would be a good idea for the City to have something in place ahead of time, which may satisfy the State.

Mayor Pro Tem Johnson commented that in walking around town, he has occasionally seen used syringes thrown along the gutters. He said there is a right or wrong way to dispose of needles and he doesn't know if having an exchange program would change people's attitudes but educating people might help.

Councilmember Garnes commented that this is something the City may not have the ability to ban and it seems there would be no harm in having sharps containers available in town in addition to having them at Palco Pharmacy. She also indicated that Palco sells syringes rather than giving them away.

Councilmember Marks said that he is not sure putting sharps containers in town would change people's habits. He noted that he is definitely not in favor of having a syringe exchange program in town. He asked Chief Conner's opinion on the subject.

Chief Conner commented that the police department has had to go out and pick up syringes four or five times since he has been around and there was one incident where they retrieved 250 syringes from a vehicle, which they fished out of a homemade container. He said on occasion syringes are turned into the department and it's usually during the cleanup of a drug house. He noted that the police department has sharps containers and Recology Eel River takes them free of charge. He commented that those people that throw them in the street would likely continue to do so. He said boxes for waste meds might be more appropriate to help the environment although that is a different topic.

Mayor Wilson pointed out that the California Department of Public Health is required to provide public notice and consult with local law enforcement and local health officials but they are not required to seek local government permission to authorize a needle exchange program. He said he would like to see anything that happens in the City to come to the Council first. He said that he doesn't want to see the City spend any money on this issue or see any programs in the City that the City Council doesn't approve.

City Manager Knopp reviewed potential options for the City Council to pursue including an ordinance ban on syringe exchanges or a regulated approach such as active needle clean-ups as proposed in the City of Eureka.

Mayor Wilson called for public comment on the matter.

Julie Woodall suggested option #3 with the City issuing an advisory letter or resolution to the State and other involved parties expressing the City's position on syringe exchange programs being authorized or active in Rio Dell. She also suggested watching what happens through the Orange County Courts regarding the time-limited ban on syringe exchange programs in the City of Costa Mesa. She didn't see any reason to get the City Attorney involved at this time and suggested the public be informed of the City's position.

Mayor Pro Tem Johnson asked Dave Griffith how many syringes he has seen while picking up cigarette butts.

Mr. Griffith indicated that he had not seen any syringes thrown along the roadway.

Mayor Wilson commented that perhaps the City is making an issue out of nothing, not to say that there is not a drug problem in Rio Dell, like there is in every other city.

Bryan Richter informed the Council that he was contacted by a number of residents who said that they do not want a needle exchange program in town and asked for clarification of the City Council' position. He said he doesn't want to propagate bad behavior by exchanging old needles with new ones. He added that it is impressive for the City Council to stand up and say that they don't want this and felt the Council should issue a statement to the State on the City's position. If the courts determine in Orange County that cities can have a on needle exchange programs, then the matter should come back to the Council for further action to mat same direction.

Mayor asked for a consensus of the Council.

Mayor Pro Tem Johnson, Councilmember Marks and Councilmember Strahan were not in support of a needle exchange program in Rio Dell.

Councilmember Garnes agreed but felt the Council couldn't issue an intelligent position on the subject with only having the information presented a few days prior. She suggested the item come back to the Council for further discussion and that health department representatives be invited to come and speak on the matter.

Mayor Wilson commented that he did some research on the issue and said there is no shortage of information out there. He said he was in favor of Option #3 regarding issuing as position statement that the City does not want a needle exchange program in the City.

City Manager Knopp stated for clarification that the direction of the majority of the Council is that they immediately be notified of any proposed needle exchange program in Rio Dell and to

issue a statement on the City Council's position to the State and other involved parties that the City does not want a needle exchange program in Rio Dell.

Council concurred.

ORDINANCES/SPECIAL RESOLUTIONS

Approve Resolution No. 1405-2018 Adopting a Revised Water Bill Claim Adjustment Policy

Finance Director Kerrigan provided a staff report and noted that the last update to the City's Water Bill Claim Adjustment Policy was in January of 2011 with passage of Resolution No. 1102-2011. She explained that the current policy allows for a maximum of \$100 to be waived in circumstances where a customer has incurred an extraordinarily high water bill by reason of excessive use due to a leak or excusable neglect. She said that since the time of adoption of this policy the water rates have increased significantly so the \$100 maximum is no longer equitable.

She continued with review of the recommended revisions to the Water Bill Claim Adjustment Policy and said that staff is recommended the \$100 maximum adjustment be increased to \$150. In addition, a clause was added to allow the City Manager, in rare instances to adjust a customer's bill that has grossly exceeded both the \$150 maximum credit in addition to three (3) times the amount of an average water bill. She explained the customer would then be billed three (3) times the amount of an average bill for the month in which the problem occurred. The other recommended revision was to increase the minimum amount in which a claim could be considered to go from \$10 to \$20.

Mayor Wilson called for public comment on the proposed resolution.

Julie Woodall asked how other cities handle water claims and referred to the \$1,200 claim approved at the last meeting and said she doesn't want to see those types of adjustments coming before the Council in the future.

Finance Director Kerrigan said that she found that many jurisdictions take the average bill and subtract that amount from the high bill then adjust the difference by 50%. She explained that with revision of the policy, the City Manager would be allowed to make adjustments beyond the \$150 in rare or extreme circumstances.

Julie Woodall noted that she would have preferred to have the Council wait for adoption of the revised policy before approving a water claim that did not follow the current policy.

Mayor Pro Tem Johnson referred her to Section 3(g.) of the Resolution that states that "nothing herein shall, however, be construed to prevent the City Manager from seeking City Council approval of any claims presented pursuant to this Section" stating that it was in existence at the last meeting when the claim was approved.

Discussion continued regarding the City of Fortuna's policy and whether the City used the same 50% rule for adjustments.

Staff clarified that that the existing resolution contained that language and it remains the same in the revised resolution. The only difference is that the cap was increased and from \$100 to \$150, the minimum claim amount was increased from \$10 to \$20 and the clause was added to allow the City Manager to approve unusual claims administratively.

Mayor Wilson said he would prefer that all claims exceeding \$150 be required to come before the City Council for approval.

Councilmember Garnes asked if water claims go before the City Council in Fortuna. She said it seems that unless a customer disputes a claim, there is no need for it to come before the City Council.

Finance Director Kerrigan explained in Fortuna, the City Manager or a designee settles claims.

Motion was made by Johnson/Garnes to approve Resolution No. 1405-2018 adopting a revised Water Bill Claim Adjustment Policy. Motion carried 3-2; Mayor Wilson and Councilmember Strahan dissenting.

COUNCIL REPORTS/COMMUNICATIONS

Mayor Pro Tem Johnson reported on his attendance at Humboldt County Association of Governments (HCAOG) and said the board authorized him to continue as a member on the Last Chance Grade and said he was looking forward to it and would be happy to report on the progress of the project at the pleasure of the Council.

He also reported on the meeting of the Nuisance Committee earlier in the day and that it was snice to get everyone on the same page and that staff was making quite a bit of progress.

Mayor Wilson announced that the new Councilmembers would be sworn in and seating at the December 18th regular meeting along with the selection of Mayor and Mayor Pro Tem. He recommended the committee assignments be done at the January 3rd meeting.

Mayor Pro Tem Johnson announced that LAFCo has two impending vacancies on its Commission and is requesting interested City Councilmembers submit letters of interest prior to their January 4th meeting.

ADJOURNMENT

Motion was made by Johnson/Garnes to adjourn the meeting at 7:50 p.m. to the December 18, 2018 regular meeting. Motion carried 5-0.

RECOMMENDATION

It is recommended that the City Council approve Resolution No. 1410-2018 amending the Operating and Capital budget to include previously approved appropriations for the Wastewater Compliance Project.

BACKGROUND

On December 5, 2017 your City Council approved Resolution 1367-2017 designating funds of \$47,075 for the North Coast Regional Water Quality Control Board Compliance Project (NCRWQCB). The NCRWQCB allowed the City to make an improvement to the wastewater treatment plant in lieu of penalties. The Mandatory Minimum Penalties (MMPs) being imposed at the time were \$27,000 for exceeding allowable amounts of nitrogen, ammonia, and nitrate during the period of January 31, 2014 to March 31, 2015. The violations resulted in large part due to the fact the wastewater treatment plant was in its early stages of operation.

The budget amendment amount of \$47,075 approved in December 2017 was for work to be performed by Aeromod during the time frame of October 2017 through June 2018; however the work was not completed by the end of the 2017/18 fiscal year and was

inadvertently left out of the current year's budget. Staff is seeking Council approval to add the item to the current year's budget for work that was completed in September 2018.



SUBJECT: Discussion and Possible Action to Approve Resolution No. 1367-2017 Approving the North Coast Regional Water Quality Control Board Compliance Project and Approval of Related Budget Adjustment.

IT IS RECOMMENDED THAT THE CITY COUNCIL:

Approve Resolution No. 1367-2017.

BACKGROUND AND DISCUSSION

The City of Rio Dell received twelve effluent limit violations from the North Coast Regional Water Quality Control Board (NCRWQCB) between the period of January 31, 2014 and March 31, 2015. These violations were primarily a consequence of bringing the City's new wastewater treatment plant online. Nine of these violations are subject to Mandatory Minimum Penalties (MMP's). The remaining three violations are exempt. Penalties are listed in Attachment A. On October 31, 2016 the North Coast Regional Water Board issued, under the authority of California Water Code section 13323, Administrative Civil Liability Complaint No. R1-2016-0050 related to the effluent limit violations. These MMP's total \$27,000 related to exceeding the limitations on Nitrogen, Ammonia and Nitrate.

The City of Rio Dell proposed a compliance project to the NCRWQCB in order to apply the penalty towards an improvement to the Waste Water Treatment Plant (WWTP). A compliance project allows the City to make an improvement to the WWTP and have those costs applied towards the fine, so long as the improvement is related to the violation. In this case, staff is recommending some modifications to the WWTP that will help prevent future violations of State standards. Total budget impacts are expected to be \$47,075. The project has been reviewed by the State and approved by the Regional Water Quality Control Board. Project details are listed in Attachment B. Once completed, all fines will be forgiven and the plant will have received needed improvements to help prevent future violations.

Enclosed is Administrative Civil Liability (ACL) Complaint No. R1-2016-0050 (Complaint) issued by the California Regional Water Quality Control Board, North Coast Region (Regional Water Board) in the matter of the City of Rio Dell Wastewater Treatment Facility. The Complaint covers the period from May 1, 2012 through April 30, 2016, and alleges that the Rio Dell Wastewater Treatment Facility violated effluent limits in Waste Discharge Requirements (WDRs) Order No. R1-2011-0054 (NPDES Permit No. CA0022748) twelve (12) times during that period. Of the twelve effluent limit violations, nine (9) are subject to Mandatory Minimum Penalties (MMPs), and three (3) are exempt from MMPs. The specific violations alleged are listed in Attachment A to the Complaint. The project that the City would like to present would be to upgrade the wastewater plant's computer, installation of 4 new Dissolved Oxygen (DO) probes, and installation of 4 air sensors with actuating valves to better control the air flowing to each aeration tank. Aeromod has implemented the changes described above in all of their new facilities after the completion of the Rio Dell Treatment Plant back in 2013. This a proven standard in the design of their newer facilities.


Purpose of the Project: The Wastewater Treatment Plant will greatly benefit from aeration processes to each aeration basin allowing the treatment plant to benefit from more precise control on the nitrification/denitrification process. Staff Update – 2018-12-18

City Council

The next City Council meeting will be held on Thursday, January 2, 2019.

City Manager

Staff are looking into the potential need to provide a fiber line into City Hall for internet access. This may be necessitate3d by the adoption of the RIMS system for the Police Department. RIMS is now deployed with all other local law enforcement agencies with the exception of Ferndale and Rio Dell.

CM working with State to finalize the City Engineer Contract.

The City was unsuccessful in moving to the next level on our River Parkways grant submission. Feedback on the grant indicated tough competition from other jurisdictions in Northern California.

The County has issued its Final Cumulative Report for the November election. Measure J, the extension of the Rio Dell Sales and Use Tax, has passed with 475 votes yes, and 463 votes opposed. A special thanks should go to Gordon Johnson who spearheaded the election effort.

The City's new Wastewater Superintendent will have his first day on Wednesday January 2, 2019. We plan to introduce him at the Council's meeting on the 2nd.

Held track and trace conference call update and was informed by SICPA our operators are doing a good job comparative to many operators outside of Rio Dell.

The City has received its first Measure X tax payment on December 12th 2019.

The CM met with representatives from Terra-Gen on 12/13 who are working on the nearby wind energy project. In the past, Terra Gen has insisted that the project would not use Monument Road for construction or operation of the facility. It became clear at the meeting that it was possible that Monument road may be used. The CM has issued an email to the County asking that the impacts of this new information be looked into in conjunction with the City.

The tasks of P/R, A/P, A/R, and monthly reconciliations of the G/L are on-going.

DocStar electronic filing continues and has become a daily task for filing and storage of City documents. DocStar has become instrumental in City-wide management of new and historical documents.

Water shut off notices were sent out on December 11th. Customers with past due and current charges (two months) are sent shut off notices (Ord. 13-05-250). Phone calls are also made as a courtesy to customers.

Decals have been placed on payment drop box and the box is available for use. A sign will be put into place identifying the parking spot for payment drop off. The drop slot at City Hall entrance is available for payments and Saturday mail delivery.

Training for AB 1825 Sexual Harassment Training is planned for February 11, 2019 at City Hall from 9:00 am to 12:00 pm. AB 1825, which is required for employees and City Council members, is through Employment Risk Management Authority (ERMA). The City is a member of ERMA through Small Cities Organized Risk Effort (SCORE), which provides liability insurance to the City through joint powers agreement (JPA). ERMA provides this training to member cities free of charge.

Customers have been requesting automatic payment set up for utility bills. Finance staff is researching whether or not this is feasible for the City.

The Department had the following statistics for the period of November 14 to December 11, 2018. This period of time saw a normal number of calls for service, but fewer incidents requiring reports. The number of arrests was also less than normal. This may be partially due to the colder and wetter weather keeping people inside more.

During the period of November 14 to December 12, 2018, the Department opened six new cases dealing with abandoned or junk vehicles. During the same time period, the Department closed five cases. Two cars were towed by the City while the others were removed by their owners. As of December 11, 2018, there were four open junk vehicle cases.

During the period of November 14 to December 11, 2018, there were fifteen calls for service related to animal control issues. Two dogs, eleven cats and seven newborn kittens were transported to Miranda's Rescue during this time period. Ten of the cats came from a house on Second Avenue that recently changed hands and the former occupants left many of their cats behind.

Chief Conner attended background investigator training in Sacramento.

On November 23, 2018, Officer Carnahan was dispatched to a domestic violence incident in progress. The victim escaped out of a bathroom window when the suspect tried to choke her. She then fled to a neighbor's house. The suspect followed and a physical fight ensued between the suspect and the man who lived at the second residence. The man was able to evict the suspect from his house, but the suspect then tried to break down the door. When he was unable to do this, he threw a pumpkin through a large picture window. He then started throwing objects at the couple inside including firewood and a gardening shovel. A large piece of firewood hit the female occupant on the top of her head, which caused a large laceration. The shovel hit the male occupant in the chest, also causing a large laceration. The struggle continued through the window until the suspect withdrew after suffering lacerations to his arm, hand and head. When Officer Carnahan arrived, he kept the peace while medical staff dealt with all four of the participants. Only the initial domestic violence victim was not transported by ambulance to the hospital. Sergeant Beauchaine and Chief Conner both responded to the scene from their homes to help interview the witnesses and to process the crime scene. The suspect has been charged with several felonies including burglary, assault with a dangerous weapon, and domestic violence.

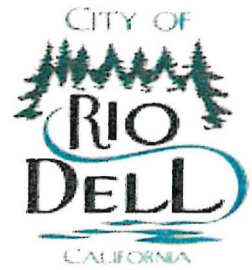

RECOMMENDATION

1. Follow City Council Procedure To Elect a Mayor and Mayor Pro Tem.

BACKGROUND AND DISCUSSION

Resolution No.1127-2011 provides a procedure for appointments by the City Council for vacant positions on the City Council and Commissions and establishes the procedures for selecting the Mayor and Mayor Pro Tem. Section 36801 of the California Government Code also establishes the procedures for choosing the Mayor and Mayor Pro Tem as follows:

Section 36801: The City Council shall meet at the meeting at which the declaration of the election results for a general municipal election is made pursuant to Sections 10262 and 10263 of the Elections Code and, following the declaration of the election results and the installation of elected officials, choose one of its members as Mayor, and one of its members as Mayor Pro Tempore.

All Councilmembers shall be considered nominated for Mayor and Mayor Pro Tem unless a Councilmember chooses to decline nomination. Each term will be for two (2) years ending with the 2020 General Election.

RESOLUTION NO. 1127-2011
A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF RIO DELL PROVIDING A PROCEDURE FOR
APPOINTMENTS BY THE CITY COUNCIL
FOR VACANT POSITIONS ON THE CITY
COUNCIL AND COMMISSIONS

WHEREAS, the City Council is authorized under RDMC Section 2.55 to establish and by a majority vote appoint individuals to commissions, boards and committees; and

WHEREAS, City Council desires to use the same system to select the Mayor and Mayor Pro Tempore as is used to appoint individuals to commissions, boards and committees; and

WHEREAS, when vacancies occur on the City Council and Commissions, the City Council will vote to appoint replacements for the duration of the term (or for a full term when an election is planned and less candidates file than the number of seats that will become vacant); and

WHEREAS, the City Council desires that a set of procedures be in place to formally guide the voting process;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Rio Dell that:

1. Upon notice of a vacancy, an application time period shall be designated whereby interested applicants may complete an application to fill the vacant seat.
2. Names of all qualified applicants shall be placed in nomination for the vacant Seat.
3. All Councilmembers shall be considered nominated for Mayor and Mayor Pro Tempore (with the exception of the newly appointed Mayor). Any Councilmember may decline nomination for Mayor or Mayor Pro-Tempore.
4. Applicants shall be given an opportunity to make a short presentation to the Council at a public meeting.
5. At a City Council meeting where the vacancy is akenized, each Councilmember will write the name of the applicant of their choice, and sign their ballot.
6. The ballots will be passed to the City Clerk to be counted and announced by name and for whom they voted.
7. If an applicant receives 3 or more votes, that candidate is chosen for the vacancy. Otherwise, there will be a runoff ballot between the top 2 applicants. Applicants receiving 2 votes will be placed in the runoff, and a separate vote shall be held for those receiving 1 vote if only 1 applicant has 2 votes (i.e. 2,1,1,1).

7. In the case of ties, a revote will be held.
8. After 3 ties, the Council will declare that the item be continued and placed on the next regular agenda.
9. At the next regular or special council meeting where the continued item is agendized, the Council shall re-vote up to 2 more times in the same manner as described above. In the event there is still a tie vote, the Council will declare a deadlock and reopen the application process.

BE IT FURTHER RESOLVED, that the procedure for establishing a system for City Council appointments to commissions, boards and committees and procedures for the selection of Mayor and Mayor Pro Tempore as described in Resolution Nos. 416, 625, 700, and 822-1-2002 are hereby repealed and replaced with the procedure described above.
