RIO DELL CITY COUNCIL **REGULAR MEETING MINUTES FEBRUARY 2, 2021**

The regular "virtual" meeting of the Rio Dell City Council was called to order at 6:30 p.m. by Mayor Garnes.

CEREMONIAL MATTERS

Moment of Silence in Memory of former Mayor/Councilmembers Bud Leonard Mayor Garnes called for a moment of silence and said that Bud was the person that convinced her to run for City Council, he was a great guy and would truly be missed.

Councilmember Woodall said that she knew Bud for over 20 years and during that time he was always involved with the City either as a councilmember or planning commissioner. His research skills were invaluable and right up until the end of his life, he made sure to listen to the council meetings.

Mayor Pro Tem Johnson said that Bud was instrumental in getting him into politics and that he began by replacing Bud on the Planning Commission when he was re-elected to the City Council in 2010. When Bud was no longer able to serve on the City Council, he was then appointed to serve for the remainder of Bud's term.

Nick Angeloff added that Bud was one of the most interesting persons he ever met. He was a true patriot and his stories about his work and past experiences were the best stories he had ever heard.

PUBLIC PRESENTATIONS

Mayor Garnes asked if there were any public comments. No public comments were received.

CONSENT CALENDAR

Mayor Garnes asked if any councilmember, staff or member of the public, would like to remove any item from the consent calendar for separate discussion. No items were removed.

Motion was made by Johnson/Woodall to approve the consent calendar including approval of Minutes of the January 19, 2021 regular meeting, approval of the appointment of Patrick Knight as a third member on the Nuisance Advisory Committee, and approval of Resolution No. 1477-2021 authorizing update of signature cards on all US Bank accounts. Motion carried 5-0.

REPORTS/STAFF COMMUNICATIONS

City Manager/Staff Update

City Manager Knopp provided highlights of the staff update and brought special attention to the January 26th County Board of Supervisors meeting wherein they reviewed the budget and found additional Measure Z funds. He expressed special thanks to Supervisor Michelle Bushnell for advocating on behalf of Rio Dell to approve \$33,000 in funding for the Police Department in the current Measure Z cycle.

He also reported that staff was working with a surveyor on the 2021 Pave Project, said that staff conducted the first Economic Development Ad Hoc Committee meeting on January 28th with experts from the County of Humboldt's GoHumCo and CALED, and asked Wastewater Superintendent Taylor to provide an update on the recent Sanitary Sewer Overflow (SSO) that occurred as a result of the recent heavy rain event.

Wastewater Superintendent Taylor reported that there were two SSO events that occurred on January 26th and January 27th at the end of Painter Street. He said that approximately 30,000 gallons were lost and they were able to recover 7,000-8,000 gallons due to staff's response to the occurrence. He noted that with the last rain events on Sunday and Monday of this week, the system was able to handle it. He commented that with the extended work of the Sewer Lateral Inspection program, there has been substantial improvement related to the decrease in I & I (inflow and infiltration) to the treatment plant. During these types of rain events they typically see 2.5 million gallons of flow to the treatment plant. With this rain event they saw 1.5 to 1.6 million gallons of flow to the plant.

Mayor Pro Tem Johnson asked when the last time they ran a camera down the line from Painter Street to the plant and subsequently did a cleaning, and if it was in the best shape possible.

Wastewater Superintendent Taylor explained that they did camera the entire line around 2019/2020 said that the pipe is an older AC line but in tack. He said that the unfortunate part of the line is the section between Walnut and Davis St. which has potential for collection of sediment noting that the area of that line was jetted last summer but their equipment is not quite suited for that size of pipe (12" main). In discussions with the City Manager, they are looking at having outside help to perform extensive cleaning of the line to see if there are any restrictions. The area in question has a low slope so it is a choke point for causing sewer to backup during heavy rain events.

Mayor Pro Tem Johnson asked if there were any comments from the State Water Resources Control Board.

Wastewater Superintendent Taylor said that he is required to report to the Office of Emergency Services (OES) within two hours of a sewer spill which he did. He also talked to the City's State regulator at State Water Resources Control Board and gave her a breakdown of the events. Because of the situation the City is in with the SSES it is a known problem and what they are doing is trying to mitigate damages. It is not a matter of "if" but "when" an SSO will occur and until they can target some of the problematic areas and reduce the flows into the system, that's how they will handle these types of events.

Councilmember Carter thanked Wastewater Superintendent Taylor and the public works staff for their efforts in coming out at night in bad weather to address the problem.

Councilmember Wilson asked if SB2 grant funds could be used to replace sewer laterals.

Wastewater Superintendent Taylor noted that with grant funding, the City would able to replace some of the old clay terracotta pipes but it was his understanding that the SB2 grant was for a study on possibly a mixed-use development project. He explained that the Sewer Lateral Inspection program has been successful and hopefully the City can secure additional grant funding to identify and repair problematic areas.

He further reported that an engineer from Oakland will be coming up at the end of the week and installing monitoring equipment in the collection system to come up with an assessment on the worse areas.

Councilmember Wilson asked if a previous study was done monitoring flows throughout the City.

City Manager Knopp noted that no comprehensive analysis was done on the collection system although the City did do some smoke testing to identify leaks in pipes.

Mayor Garnes said that she was happy to see that there were only two calls for service at 355 Center St. (River Bluff Cottages).

Mayor Garnes called for public comment on the Staff Update. No public comment was received.

SPECIAL PRESENTATIONS/STUDY SESSIONS

Receive Report and Provide Direction to Staff on SB2 Planning Grant

Community Development Director Caldwell provided a staff report and said that the City was awarded a \$160,000 planning and technical assistance grant last year to conduct a sewer

lateral study in the Ogle/Belleview neighborhood. The purpose of the SB2 program is to provide funding and technical assistance to help cities and counties prepare, adopt and implement plans and process improvements that streamline housing approvals and accelerate new housing production.

He expressed concern that accepting the grant and implementing the study is duplicative with respect to the ongoing Sanitary Sewer Evaluation Study (SSES). He noted that the SB2 grant was presented to the City Council at their meeting of December 3, 2019 and at that time, the SSES had not been approved by the State. Due to the competitive nature of the grant application, staff applied for the SB2 grant in the event the City was not awarded the SSES grant. He further noted that the SB2 grant is simply a study that provides no clear path to leverage grant dollars to actually implement construction or provide funding to homeowners with failed laterals.

He commented that in 2014 the City implemented the Sewer Lateral Inspection program which requires sewer laterals to be tested at the time of sale of a property. Since implementation of these requirements, there have been 18 tests in the Ogle/Belleview neighborhood which is about 11% of the neighborhood. Of those 18 laterals tested, 7 or about 38% had to be replaced or repaired.

Staff met with representatives from the Department of Housing and Community Development (HCD) to discuss staff's concerns and to discuss other possible options for utilizing SB2 funds. They understood the concerns and encouraged the City to explore other options.

One of the options discussed was the possibility of developing a pre-approved site and architectural plans that facilitate non-discretionary permitting for housing, including mixed-use commercial/residential projects. HCD was very supportive of the idea and thought it would be a game changer for Rio Dell.

Staff presented four (4) potential properties suitable for mixed-use development as:

- Baptist Church property at Wildwood and Belleview Ave.
- Property on Wildwood between Painter St. and Highway 101
- Rio Dell Mobilehome Park on Wildwood between Center St. and Painter St.
- Todd property at Davis St. and Highway 101

With Council approval, staff would contact the property owners to see if they have any objection to the City developing plans for a mixed-use project on their properties. Once developed, the shovel-ready plans can be used to market the property with pre-approved plans which is a significant benefit not only to the property owner but to potential developers as well. The City would benefit by meeting the City's Regional Housing Needs Allocation (RHNA) obligations.

City Manager Knopp explained that under the SSES, it looks at solutions for reducing the City's inflow and infiltration (I & I) and addresses the old clay pipes. He said that there are some creative solutions such as slip-lining the pipes rather than replacing them. This shows the State that the City is making progress which helps to pull down grant dollars. He reiterated that the SB2 grant is for a study only and does not provide funding to property owners with failed sewer laterals.

Councilmember Wilson asked if the study would distinguish between city and private property and if it covers all properties rather just the four properties identified in the staff report.

Community Development Director explained that only one of the property owners would be the recipient of the pre-approved plans for a mixed-use development. As far as identifying city versus private sewer lines, that is what the SSES does.

Councilmember Wilson asked for clarification that the idea would be to select one of the four properties and make the project shovel-ready.

Community Development Director Caldwell explained that one property would be selected and plans would be prepared with no discretionary review and those plans would then be available to the property owner to market the property.

Mayor Pro Tem Woodall asked if other jurisdictions have been successful with this type of program and if the property owner would be obligated to sell the property as a mixed-use project.

Community Development Director Caldwell indicated that other cities have developed shovel-ready projects but he was not certain about the success rate. He said that the property owner would not be obligated to sell the property as proposed.

Mayor Pro Tem Woodall commented that if money is put into the program and the property owner does not follow through with a development, the City would lose that money.

Community Development Director Caldwell agreed to reach out to HCD and relay her questions and report back to the Council.

Mayor Pro Tem Johnson referred to page 23 of the staff report with the map showing the locations of the four (4) proposed properties and thought that site 2 (Wildwood Ave. parcel between Painter St. and Highway 101), formerly referred to as the Albin property appears to be a great candidate for a mix-use development. He asked staff what they envision the project to look like if developed.

Community Development Director Caldwell envisioned multi-story, high density multi-family housing with highway commercial development such as a restaurant or small hotel. In

working with a design consultant, they would present three (3) conceptual plans which would be presented to the City Council. The Council would select one plan and final architectural plans would then be developed that facilitate non-discretionary permitting.

Councilmember Carter said that she was on board with the project as proposed and that it seems what is best for the City.

Mayor Garnes commented that she understands that utilizing SB2 funds for a sewer study is redundant with the SSES and if staff reaches out to the four property owners and someone is excited about the concept, she would tend to believe they would sell to a developer or develop the property on their own. She noted that they could potentially sell the property for a higher price since the planning/permitting process is already done.

City Manager Knopp reviewed staff's recommended action.

Mayor Garnes asked if there were any public comments received related to this item.

City Clerk Dunham read one public comment received from Sharon and Steve Wolff. (included as Attachment 1 to these minutes).

City Manager responded to the public comment and explained that there are a lot of mysteries related to the collection system and this is the first time a comprehensive study has been done. He noted that there are significant issues with the sanitary sewer system going back to its original design. He said while there are significant issues with the sewer system and private laterals in the Ogle/Belleview neighborhood, that is not the only area with issues. He said that there is a lot of work to do on the City-owned infrastructure and the hope is to be able to slip line some of the sewer lines and reduce I & I without having to take further steps beyond the Sewer Lateral Inspection program at the time of sale. In discussing the SB2 grant options with the State, they were on board with the mixed-use development plan. He said that this plan would help push forward economic development in the City and satisfy the State and the purpose of the grant to increase housing.

Community Development Director Caldwell reiterated that the SB2 grant cannot be used to assist property owners with replacement of failed sewer laterals. The I & I study is being conducted as part of the SSES which will put the City in a much better position for grants to potentially help property owners address those issues.

Motion was made by Johnson/Carter to direct staff to modify the HCD application to pursue grant funds for developing pre-approved site and architectural plans that facilitate non-discretionary permitting for housing, including mixed-use commercial/residential projects and to direct staff to reach out to the four (4) property owners.

Councilmember Wilson questioned whether this type of project would be a gift of public funds since the property owner would ultimately be benefiting from it.

Community Development Director Caldwell pointed out that the project would benefit the community as a whole by providing additional housing opportunities so did not believe that it was a gift of public funds. Nevertheless, he agreed to reach out to HCD to make sure.

Mayor Garnes stated for clarification that the Council was not committing to anything except for staff to reach out to the four property owners and said that she was open to the idea.

Motion then carried 5-0.

Financial Contribution to Chamber of Commerce for Holiday Decorations

Finance Director Dillingham provided a staff report and said that a request was received from the Chamber of Commerce for \$2,500 for reimbursement for 2020 holiday decorations. In the process of reviewing the invoices, staff realized that although the current budget had sufficient funds allocated, there was no agreement or approval by the Council regarding funding the Chamber for the current fiscal year.

Mayor Pro Tem Woodall noted that in the future she would like to have the funding request presented with approval of the budget.

Councilmember Carter agreed.

Councilmember Wilson thought the Council had previously approved the funding.

Mayor Garnes explained that there were prior approvals but not for the current year.

Finance Director Dillingham explained that in the 2019/2020 budget, \$3,500 was approved for holiday decorations but the actual amount of reimbursement was only \$2,072 based on receipts submitted. She noted that there is a line item in the budget as "Promotional" but the funds were not specifically earmarked for holiday decorations. She indicated that with the Council's approval she could put a note on that line item in the next year's budget.

Mayor Pro Tem Johnson agreed that it would be appropriate for the City Council to make sure the line item is identified as part of the budget process.

Mayor Garnes commented that she loved the lights and decorations but was not sure it was a function of the City to help fund it. She said that the amount seems to increase each year but it is either a Chamber responsibility or a City responsibility. She pointed out that since the City is a member of the Chamber, perhaps every member should contribute the same amount. She said that the City is not the Chamber's funding source. She said if the City

contributes \$2,500, then every member should perhaps contribute \$2,500 or everyone collectively contribute a total of \$2,500.

Nick Angeloff, Chamber of Commerce President said that they ask every business to donate and appreciate any donation large or small. He said that it is a collaborative effort to bring joy to the community during the holidays and they appreciate the City's generous donations to help make that happen.

He said that over the next couple of months the Chamber will be working on a kiosk project with the approval of the City but at the expense of the Chamber. He noted that the community has been really supportive of all of their activities.

Mayor Garnes asked if there were any public comments related to this item. No public comment was received.

Motion was made by Wilson/Johnson to approve a financial contribution of \$2,500 to the Chamber of Commerce for holiday decorations. Motion carried 4-0; 1 abstention (Woodall).

Councilmember Wilson commented that it has been a strange year and that businesses are struggling. He pointed out that the City has not been financially impacted by the pandemic and although the Council can learn by this, he is glad the City is able to contribute to the Chamber with everything that has been going on.

Mayor Garnes commented that this is something that needs to be on everyone's minds during the next budget discussions.

President Angeloff thanked the Council for the financial contribution.

Update on 2020 Street Projects

City Manager Knopp provided a brief overview of the 5-Year Streets Improvement Plan as approved by the City Council on November 17, 2020. He said that staff has been working on putting together a bid for the proposed work which is expected to be issued by the middle of February with the results to the Council for approval by the middle of March. This update will provide an opportunity for final input from the Council on the proposed work.

He pointed out that the City was able to accomplish a fair amount of street work in addition to the ATP Project last year. He presented maps of the streets identified for repair this year and explained that the white cutouts on Dixie St. represent areas proposed for overlay including some replacement of drainage inlets and manholes. With regard to the River/Ogle/Spring loop, he looked at various options with Water/Roadways Superintendent Jensen and is suggesting a maintenance pave with grind outs on a 20-foot width of the travel lanes including the placement of a new manhole and valve box repairs. He said that they are also proposing some slight drainage improvements on River St. with a new drain inlet (DI).

City Manager Knopp said that on Eeloa Ave. near CC Market they were hoping for slurry seal however, upon further investigation they discovered some pretty significant problems, particularly as you get closer to CC Market. The focus will need to be on drainage in this area.

They will be doing some gravel reconfigurations on the West side of Eeloa Ave. and was working through some issues with the surveyor. They are also looking at grading a portion of the roadway near the ditch to widen the corridor.

Rio Dell Avenue will include a simple overlay with valve boxes maximizing drainage potential to get water off the road. Staff talked to the property owners who are excited about solving these drainage issues.

He said that with regard to Miller Ct., when the housing development was put in, there wasn't sufficient drainage in this particular part of the road which is now failing. The idea is to get in and try to correct it and allow water to drain appropriately.

In addition, they are proposing another 200 sq. yds. of various grind outs and patches in around town in preparation of slurry seal and also would be putting a few tons of asphalt on Belleview Ave. to correct some the deficiencies in that area.

Water/Roadways Superintendent Jensen said that throughout this process, quite a bit of drainage improvements were identified but the goal is to smooth out travel lanes and do some aggregate base on the edges to take care of some of the pot holes and to contour slopes to the current drains. He noted that there would be additional drainage work needed down the road but this will smooth out the travel lanes. He said that he was looking forward to being able to accomplish this year's proposed street projects.

Mayor Pro Tem Johnson reminded everyone that although there will be vast improvements to the streets, not to confuse that with "perfect" noting that there is not enough money to make the streets perfect.

Councilmember Woodall expressed her excitement in doing street improvements that will be visual to the community.

Councilmember Carter said that she was also looking forward to the street improvements.

Councilmember Wilson thought it was the best use of the money for the time being.

Mayor Garnes thanked staff for their efforts and said that she was looking forward to seeing the accomplishments.

Review of Traffic Accident Report for 2020

Chief of Police Conner reported that as the Traffic Officer for the City, he is required to provide a report on traffic accidents for the year. He reported that there were 16 traffic accidents reported to the Police Department in 2020, three-quarters of which were hit and run accidents. Two of those drivers were found and taken into custody and also charged with DUI's (driving under the influence). One accident involved a car hitting a pedestrian and another with a car hitting a person on a bicycle, both of which suffered minor injuries. He noted that the majority of the hit and run accidents involved the driver hitting a fence, telephone pole or parked car. He noted that a couple of the accidents had to do with visibility issues.

Councilmember Carter asked if the visibility concern at Monument and Edwards Dr. was because of the way cars were parked on the street.

Chief Conner explained that with angled parking, the driver does have to ease forward before pulling out from Edwards Dr. onto Wildwood Ave. and while this is a visibility concern, it was not the cause of the accident.

ORDINANCES/SPECIAL RESOLUTIONS

Resolution No. 1478-2021 Authorizing Application for Local Early Action Planning (LEAP)
Grant to Supplement the SB2 Grant Funds

Community Development Director Caldwell provided a staff report and said that HCD encouraged the City to take advantage of \$65,000 in LEAP grant funds to supplement the SB2 grant funds.

Staff recommended the City Council authorize the City Manager to make application to the California Department of Housing and Community Development for LEAP grant funds in the amount of \$65,000 to supplement the SB2 \$160,000 PTA Planning Grant for a shovel-ready mixed-use development.

Community Development Director Caldwell noted that staff submitted the application on January 31st but it needs to follow with the Resolution.

He reviewed the Project Timeline and Budget with total project costs totaling \$230,000 to get a project shovel-ready.

Mayor Garnes asked if there were any public comments related to this item. No public comment was received.

Motion was made by Johnson/Woodall approving Resolution No. 1478-2021 authorizing application for Local Early Action Planning (LEAP) Grant to supplement the SB2 Grant Funds. Motion carried 5-0.

COUNCIL REPORTS/COMMUNICATIONS

Mayor Pro Tem Johnson reported on the first Economic Development Ad Hoc Committee meeting held on January 28th via Zoom and noted that the meeting lasted 2.5 hours. He said that the City Clerk kept notes on the meeting and pointed out some of the hi-lights of the meeting including participation of a representative from CALED which is a great resource and organization the City can join for free. He said that CALED pointed out that USDA funds are available for economic development. He commented that the committee covered several matters in depth but not everything, suggesting the need for another meeting.

He also reported that the Mayor Selection Committee held a meeting and considered the appointment of a new city member to LAFCo and that he and Mike Losey from Fortuna were in the running. Mike Losey was selected to serve as the new city representative on LAFCo. He said that another meeting will be held on Monday to appoint an alternate so he may be in the running for that position.

Councilmember Woodall reported that she would be attending a Humboldt Transit Authority (HTA) meeting on Wednesday and they would be providing an update on the bus service from Eureka to Samoa which began on January 4, 2021, and discussing the bus shelter replacement project in Eureka.

She asked City Manager Knopp if they would be scheduling another Ad Hoc Committee meeting regarding the Rio Dell School property.

City Manager Knopp agreed to schedule another meeting with the committee members.

Councilmember Carter reported on her completion of the League of California Cities New Mayors and Councilmember training and said that the training was very informative and gave her a lot of perspective on the nuts and bolts of city government. She thanked the Council and staff for being so supportive of her through the learning process.

She also reported on her attendance at the Redwood Region Economic Development Commission (RREDC) meeting where they received a presentation on Viro Fiber Network, the company that is laying the broadband fiber from Eureka to Redding.

Councilmember Wilson reported on his attendance at Redwood Coast Energy Authority (RCEA) where they elected a Chairperson and Vice-Chairperson. He reported that electric bills would be going up for customers with the RCEA component of the bill going down. The increase has to do with the transmission line portion of the bill because PG&E will be doing repairs to the transmission lines. He said that he would also be attending a Humboldt Waste Management Authority (HWMA) meeting next week.

Mayor Garnes reported on a meeting with California Cities Redwood Empire Division and that she was invited to join the California Mayor's Coalition. The action plan includes a monthly call to the Governor to try and increase equity and collaboration with the Governor and the

Mayors of smaller cities. The smaller cities would be allocating for new State funding on a per Capita basis and discussing such items as the COVID spread and safely reopening of economic sectors and the deferral of the State Sales Tax. She said that she was also appointed as President of California Cities Equity Advisory Committee which will meet three times to create equitable and just features for all Californians. She agreed to report back to the Council on those meetings later.

The residents of the Belleview/Ogle neighborhood have been coming to Rio Dell City Council meetings for many years now asking for help with the drainage and sewer issues in that area. The \$160,000 grant to conduct a sewer lateral study in the area was obviously thought to be a high priority need identified by the city back when the grant application was developed. The staff report for this item says "one of the concerns in accepting the grant and implementing the study is that we believe there is a significant number of properties that have failing laterals and as such these property owners could be responsible for replacing the laterals. The average cost for a lateral replacement is about \$5,000. This is likely a burden that most of the property (owners) cannot afford."

So what is the city's plan for addressing the significant number of properties that the city believes have failing laterals if the city decides to divert this grant money from the original study?

Have the property owners who reside in the original sewer lateral study area been consulted?

Could the city pursue any options or grants for helping property owners make the necessary repairs rather than just leave them with failing sewer lines?

Ratification of Letter Requesting Legislative Remedy for CRV Buyback

IT IS RECOMMENDED THAT THE CITY COUNCIL:

Ratify the letter, or take no action.

BACKGROUND AND DISCUSSION

Resolution 1443-2020 allows the Mayor of the City of Rio Dell to issue urgency correspondence with the legislators upon the recommendation of the League of California Cities. Due to a looming deadline of February 19, 2021 for new legislation to be introduced, the League recommended issuing the attached correspondence as soon as possible.

During initial stages of the COVID-19 Pandemic response, California Redemption Value (CRV) buy back recycling centers closed under Executive Order by Governor Gavin Newsom. This Order was in place through August 21, 2020. Once the Order expired, Humboldt Waste Management Authority was the only local CRV redemption center to attempt to reopen, which resulted in overflowing traffic backing up Highway 101. After three days of attempts to control traffic and flow they had to close. They then proceeded to modify their procedures to create a safe CRV recycling process but were unable to get approval for a modified plan from CalRecycle ultimately leaving Humboldt County without a CRV redemption facility. In the absence of a local redemption facility retailers of CRV materials have to either accept the materials back from customers, acting as the redemption center, or are fined \$100 per day.

The California Beverage Container Recycling and Litter Reduction Act of 1986 established the CRV fee deposit program with the intent to incentivize recycling practices by California residents. Beverage manufactures pay approximately \$1.6 billion annually to CalRecycle and pass-thru the CRV deposit fees to the consumers. Consumers are supposed to be able to redeem their container to obligated retailers or certified redemption centers. Retailer or redemption centers then recoup their costs of the CRV payment and operational costs primarily through the sale of materials on the scrap market.

Mirroring statewide trends in California, obligated retailers ceased offering CRV buyback services at stores and over the past five years over 50% of the state's certified redemption sites

have closed at an alarming rate due to an ongoing economic collapse in the recycling scrap market. This issue is much larger than Humboldt, and the responsibility falls on a State program that has been in active failure for years.

With that as a backdrop, redemption centers were initially closed when the COVID-19 Pandemic hit California to all centers to determine how to safely operate protecting both staff and consumers. When the Executive Order was lifted in August, unfortunately CalRecycle maintained a position that if sites wanted to remain "certified redemption centers" thereby able to receive payments from the State for operating they were unable to modify any process from the pre-Covid approved plans. This has resulted in the decertification of all local CRV buyback centers and residents in Humboldt are unable to redeem their beverage containers and be reimbursed their CRV deposits.

The inability of CalRecycle to assist or provide viable assistance to struggling CRV redemption sites and center has negatively affected Area residents and effectively created a tax. When a region does not have a certified redemption center retailers who sell CRV items are required to either provide buyback services to customers or are fined \$100 per day.

On October 22, 2020, after revoking a previous exemption, local retailers in Humboldt County received a first notice from CalRecycle requiring retailers to begin accepting empty CRV beverage containers at the end of a 60-day grace period or face the \$100 per day fine. During this "grace period" local retailers were encouraged to "work with property managers, local government, and recycling center operators to establish a recycling center in our area". This is a burdensome requirement on local retailers, who are also under tremendous stress operating during a pandemic.

To simplify, retailers would have to develop the necessary infrastructure to accept and redeem CVR recyclables, transport those containers to a certified recycling location. In Humboldt County the closest certified location is 80 miles away, a four hour round trip. In addition to the logistical hardship placed on local retailers, they have an obligation to employees, qualified as "essential workers", and the safety of our customers, not only morally, but under California Governor Executive Order N-54-20 to take necessary and mandated precautions to reduce the risk of exposure to Covid-19.

With Covid-19 cases once again on the rise, retailers have determined they cannot justify taking additional risk of virus spread by providing redemption services. The retailers are requesting local authorities send a letter requesting legislative assistance to require CalRecyle to recertify our local recycling centers and allow CRV redemption on an appointment basis, increase daily allowable limits to pre-2014 volumes to address the backlog of stored material, and reinstate handling fees to help financially struggling redemption buyback centers.

SUBJECT: REQUEST TO CONSIDER SPONSORING EMERGENCY LEGISLATIVE RELIEF FOR CRV REDEMPTION SERVICES IN HUMBOLDT AND OTHER SIMILARLY AFFECTED COMMUNITIES.

Dear Assemblymember Wood,

The City Council of the City of Rio Dell requests your urgent consideration to sponsor emergency legislative relief, or other appropriate mechanism, to enable CRV Redemption services in Humboldt County. The City of Rio Dell supports efforts by our local grocers to identify a mechanism by which the current operations of the CRV Redemption centers in Humboldt County could be modified to allow them to reopen in an orderly and safe manner. Temporarily modifying the restrictions on these CRV Redemption Centers would reduce nuisances that are now prevalent in our community as a result of people stock-piling recyclables, and will avoid the unnecessary fines that will be levied on our businesses that will undoubtedly be passed on to our residents, many of which are struggling during the COVID-19 Pandemic.

Residents of Rio Dell and throughout Humboldt County are currently stockpiling their CRV recyclables until such a time as they can redeem them. While some have yard space to stockpile, those residing in smaller units such as mobile homes and multifamily housing units do not have space to accommodate storage and are often some of the most economically disadvantaged members of our community. It is very frustrating that we find ourselves in this situation, as it is completely avoidable by implementing simple changes that would allow our CRV buyback facilities in Humboldt County to reopen.

We encourage our state representatives to assist recycling centers by modifying some of the existing Certified Buyback operating restrictions and identifying temporary relief measures that allow recyclers in affected communities to reopen until a comprehensive reform of CA's Beverage Container Recycling & Litter Reduction Act (aka "Bottle Bill") is approved and implemented. Specifically, we are requesting that the State immediately implement changes in legislation that:

- Allow for easy and expedited recertification of Humboldt County CRV Redemption centers that decertified in 2020.
- Direct CalRecycle to develop protocols with Humboldt recycling centers for operation of a Certified Buyback on an appointment-based model.
- Increase the Allowable Daily Load Limits of CRV material to pre-2014 limits for a period of no less than 9-months to allow recyclers/CRV redemption centers to accommodate the heavy demand built up since March 2020.
- Extend the grace period and do not impose fines on local retailers for failing to provide CRV buyback until such time as a long-term CRV Redemption solution can be implemented.
- Allocate any funds in CalRecycle's Penalty account (those retailers opting out of CRV redemption services) into a grant fund account to establish and support local redemption opportunities, or for handling fees for the CRV redemption facilities.

The City of Rio Dell appreciates your efforts to date and looks forward to providing input on future comprehensive Bottle Bill reform and zero waste efforts.

IT IS RECOMMENDED THAT THE CITY COUNCIL:

BACKGROUND AND DISCUSSION

The FY 2020-21 Budget includes \$20,000 to replace a failed security camera system at City Hall. The new system will include three interior cameras and six exterior cameras. A new base station will be installed in the Police Department. The cameras will cover both front and rear parking areas in addition to the lobbies of the Police Department and main City Hall entrance.

An RFP was issued last year and the City Manager, City Clerk and Community Development Director evaluation the three proposals received. Security Lock & Alarm received the most points in the evaluation and it is recommended that they receive the project. If approved, staff will develop and execute a contract for the project, which we hope to have completed before the end of June 2021.

Under California State law, this type of video recording must be maintained by the City for a period of one year. Ongoing storage maintenance costs are estimated at \$2,500-\$5,000 annually.

During the period January 13, 2021, to January 26, 2021, there were eight calls for service related to animal control issues. No animals were transported to Miranda's Rescue

Officer Johnson is continuing his field training with Chief Conner. He is scheduled to complete his field training in the middle of March

On February 5, 2021, Officer Mitchell responded to the intersection of Rio Vista Lane and Pacific. An unknown vehicle had left the roadway and struck the stop sign. A witness nearby gave a very detailed description of an unusual vehicle and its driver to Officer Mitchell. The sign pole had red paint transfers on it. He followed by going to some of the more troublesome houses. On Willow Lane, he located a car that matched the description provided exactly. He contacted the man who was associated with the car and he also matched the description provided. The car had an area of red paint on the right front fender that was scuffed. The color of the paint matched the paint on the pole. The driver claimed that he had not been in that area and it must have been another car that looked like his. Because it was not another car that looked like his, a warrant for his arrest is being sought from the District Attorney's Office.

On February 6, 2021, Officer Landry responded to a report that an ex-boyfriend had slashed the tire of a woman's car. Officer Landry spoke with the victim at length. She learned that while the victim had been sitting in her car at the beach, the suspect had ripped off both door handles trying to get in before eventually breaking a window. He tried to drag the victim out of the car, but was unsuccessful. The victim suffered bruises, cuts and other minor injuries in the struggle. A few days later, the suspect removed several hand and power tools from the victim's car while it was parked at the gas station. This event was captured by the station's video surveillance system. Most of the tools were recovered from a relative of the suspect, who appears to have fled Rio Dell. The report has been forwarded to the District Attorney's Office and a probable cause arrest has been requested from the other Humboldt County law enforcement agencies.

Code Enforcement

During the period of January 27, 2021 to February 9, 2021, the Department opened six new cases dealing with junk vehicles and closed two. One of the offending vehicles were towed by the city, while the other was removed by its owner. There were eleven open cases at the end of this reporting period.



BACKGROUND AND DISCUSSION

The Finance Director provides reports on the budget to keep the Rio Dell City Council and the public informed on the status of the City's finances. The attached Mid-Year Financial Report for FY 2020-21 summarizes budgeted versus actual amounts as of December 31, 2020 and describes any significant variances. At the time of the mid-year review staff did not see or project any substantial discrepancies in revenues or expenditures at both the department and fund levels.

ATTACHMENTS

FY 2020-21 Mid-Year Financial Report

This Mid-Year Financial Report provides a review of the City's financial condition for fiscal year (FY) 2020-21 as of December 31, 2020. The report describes the revenues received and expenditures incurred and explains any significant budget variances at mid-year or projected to occur at the end of the fiscal year.

SUMMARY

The FY 2020-21 adopted budget for the City of Rio Dell was \$4.78 million with estimated revenues of \$4.07 million. Total City revenues received at mid-year were \$2,382,703 which exceeded total expenditures of \$2,323,716 by \$58,987.

Revenues: The major funds of the City had received 49% of revenues as of mid-year. This compares to 42% for the same period last year. The primary change is General Fund revenues which were higher by \$250,379, due to a change in the estimating and disbursement of sales tax revenues and increased cannabis revenues. Streets revenues were lower and SLESF was higher than last year, both of these differences are primarily due to the timing of payments to the City.

Expenditures: City wide \$2.3 million or 49% of \$4.8 million in budgeted appropriations were spent as of mid-year. Operating expenses were 42% of budget at mid-year which is the same as last year. Police expenditures were 42% this year compared to 46% last year. This is primarily the

result of the department not being fully staffed for the first half of the year. It is anticipated that Police expenditures will end the year equal to or slightly below budget.


As of December 31, 2020 General Fund revenues received were \$491,821 and expenditures were \$643,117.

Revenues: At mid-year 40% of budgeted revenues had been received. Property tax and In Lieu VLF funds are usually received from the County in February which is why revenues are below estimates at mid-year. Revenues are anticipated to be at, or above, budgeted amounts by year-end. Cannabis revenues have already exceeded budgeted amounts at mid-year, with an additional input of \$200,000 being possible by year end.

The top three revenue sources in the General Fund are Property Tax In Lieu of Vehicle License Fees, Retail Sales Tax and Cannabis Tax. Cannabis revenues exceeded property tax revenues for the first time in FY 2020-21.

Expenditures: Budgeted appropriations for the General Fund for FY 2020-21 total \$1,670,265. This includes \$550,055 for capital and special projects. Total appropriations spent at mid-year were \$643,117 or 39%.

STREETS FUNDS

Revenues: FY 2020-21 Gas Tax estimates released by California City Finance in January 2021 for the City of Rio Dell were \$1,357 or 1.6% higher than prior estimates used to develop the budget. Revised estimates for SB1 RMRA revenues were \$2,855 or 5% higher than budgeted. Total Streets revenues for the current fiscal year are estimated to be approximately \$50,000 less than actual amounts received last year.

Revenues: The Sewer funds total budgeted revenues for FY 2020-21 were \$1.2 million. This amount includes all fees, charges, penalties and new connections for sewer service. Actual revenues received at mid-year were \$671,512 or 54% of the budget. Last year at this time revenues were \$669,193, the increase in the current year is primarily due to the annual CPI adjustment. This is the last year that a CPI adjustment is authorized. Revenues are on target to end the year as estimated or slightly higher.

BUDGET OUTLOOK

Actual beginning fund balances for FY 2020-21 were higher than estimated for most funds. The estimate used for budget development was \$6,731,591 and the actual amount was \$7,681,941. The mid-year review shows that predominantly revenues are coming at budgeted levels or slightly higher and expenditures are on target.

There are a few items that could negatively impact the budget outlook:

- The Sewer funds expenses are increasing faster than revenues due to additional costs associated with State mandated water quality regulations.
- State based formulas for streets revenues are still not sufficient to cover maintenance costs and have been reduced due to impacts from the pandemic, this has been offset by the General Fund.
- The economic outlook is hard to forecast due uncertainties related to the ongoing pandemic.
- Overall revenues into the city are at historic highs, however operating costs continue to grow (dispatch, animal care, public safety software, insurance).
- Gann Limit calculations based on City population change may limit tax revenue growth.

IT IS RECOMMENDED THAT THE CITY COUNCIL:

Receive the report, provide input if any.

BACKGROUND AND DISCUSSION

The City Manager will provide an update to the Council on an opportunity for Universal Collection of Solid Waste and Recycling materials in Rio Dell.

On December 3, 2019 the City Council received correspondence from the City of Rio Dell's Nuisance Advisory Committee (NAC) endorsing the concept of Universal Garbage and Recycling Services. On November 18, 2020 the Nuisance Advisory Committee issued correspondence to the City of Fortuna endorsing the adoption of Universal Garbage and Recycling Collection. Both letters are attached.

Over the years the concept of introducing Universal Garbage and Recycling Services (Universal Collection) has come up in discussions related to solid waste and recycling services. Universal Collection would create a mandatory requirement for residences and commercial businesses to have garbage and recycling services. Universal collection would aid the community in meeting and exceeding State recycling/waste diversion mandates in addition to reducing illegal disposal, nuisance conditions and public health concerns in Rio Dell. Current voluntary subscription levels are at approximately 50 percent of residences and commercial properties. If adopted, Universal Collection would extend garbage and recycling services to approximately 100 percent of residences and commercial properties under a mandatory program.

During its September 18, 2019 meeting, the NAC was briefed by Recology Eel River on the adoption of Universal Collection. The major hurdle posed by Universal Collection is related to cost. Significant investment must be made by Recology in order to execute the program, including new trucks and new bins. Rio Dell's relatively small subscriber base makes this uneconomical for the community to adopt on its own. Since September 18, 2019 staff has engaged in several informal discussions about Universal Collection with the neighboring cities of

Fortuna and Ferndale, as their participation would dramatically increase the subscriber base thereby spreading out fixed costs and creating a potentially viable option for the City of Rio Dell to consider a move towards Universal Collection.

On November 18, 2020 the NAC issued correspondence to the City of Fortuna, encouraging the adoption of Universal Collection. Fortuna's adoption of Universal Collection is a necessary prerequisite for Universal Collection in Rio Dell. The City of Fortuna is currently looking at their Solid Waste Franchise Agreement which expires soon. Rio Dell's Solid Waste Franchise Agreement does not expire until the end of 2026.

Since that time, staff has had several meetings with representatives from Fortuna, Ferndale and Recology Eel River to discuss implementation of Universal Collection. Staffs from both cities at this time are interested in exploring the concept. Recology Eel River has proposed a timeline that would include submission of a rate analysis, public workshop, ordinance drafting and adoption and franchise agreement renegotiation occurring between now and the end of June 2021.

This is a discussion item only. Future action items to continue the process (or discontinue) will be forthcoming.

On Wednesday September 18, 2019 the Nuisance Advisory Committee (NAC) received a presentation from Recology Eel River on Universal Garbage & Recycling Collection services. The NAC was interested in universal collection from the perspective of illegal dumping and the existence of properties throughout town that have refuse or other bulky items that can create nuisance conditions. Preliminary figures show that waste collection subscriptions would rise from approximately 50% of households to nearly 100% of households.

We believe Universal Collection will be beneficial to the City of Fortuna.

Review, discuss and take public comment. Approve Resolution No. 1481-2021.

BACKGROUND AND DISCUSSION

Under the Stafford Act, every time there is a Federally declared disaster, money is set aside to fund hazard mitigation projects. The intent of these moneys is to fund projects that reduce the effects of future natural disasters. In California, these funds are administered by the California Office of Emergency Services (CalOES). All of these grants require a 25% local match commitment.

Given the recently Federally declared wildfire disaster, FEMA has released funds for the "August 2020 Wildfires-DR-4558". This grant is a multistep process. As presented at the January 19th Board Meeting, the City was notified by CalOES that the Notice of Interests (NOIs) for the Eel River Crossing Pipeline Retrofit Project and the Douglas Tank #1 Seismic Retrofit Project were approved. The City council approved moving forward on Full Hazard Mitigation Grant Program (HMGP) applications are now due to CalOES by March 5th.

As part of the Hazard Mitigation Grant application process, a local funding match of at least 25% is required. A Maintenance Commitment Letter is also required, along with a letter attesting that the City is committed to perform the necessary maintenance for the entire useful life of the projects (50 Years).

The City should note that the letters and agreement to submit the Grant Applications does not bind the City to any expense until and if the City approves a Funding Agreement. This step will take place after CalOES/FEMA approves the full grant application and submits a grant agreement for City review and approval.

The City's engineer, GHD, is finalizing the project costs as part of the application development process. The estimated cost for Eel River Crossing Pipeline Retrofit Project is up to \$3,500,000 and the Douglas Tank #1 Seismic Retrofit Project cost is estimated to be up to \$4,000,000. However, since the City is only required to fund the grant match, the City would only be responsible for a maximum of up to \$875,000 and \$750,000 respectively for each project.

Maintenance costs for the two projects are being finalized with input from City staff, and are estimated to be a maximum of \$7,500 for the Eel River Crossing Pipeline Retrofit Project and up to \$7,500 per year for the Douglas Tank #1 Seismic Retrofit Project. Because these pieces of infrastructure already exist and require maintenance, and would be decommissioned after construction of the new facilities, there is no significant practical impact from these costs.



- 5. Approve Resolution No. 1475-2021 pre-designating the City's Wastewater Disposal Field, APN 205-111-039 and intervening Caltrans property to a General Plan Land Use designation of Public Facility (PF) in anticipation of annexing the area into the City;
- Approve Resolution No. 1479-2021 authorizing the filing of the application to LAFCo to annex the City's Wastewater Disposal Field, APN 205-111-039 and intervening Caltrans property into the City;

Background and Discussion

In 2012/2013 the City upgraded the wastewater treatment plant which included the establishment of a wastewater disposal field north of the City. This area is not within the City limits. As such, the City pay's approximately \$2,500 in property taxes annually. Once annexed into the City, the City would no longer have to pay the annual property taxes.

Annexations are subject to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, Government Code Section 56000, et seq. ("CKH Act"). Humboldt LAFCo is responsible for regulating local governmental boundaries and municipal service areas in Humboldt County for purposes of facilitating orderly growth and development. This authority principally involves overseeing city and special district boundaries by approving or disapproving proposed changes of organization as defined by Government Code §56021. Humboldt LAFCo is also authorized to exercise broad discretion in amending as well as establishing conditions in approving changes of organization and outside service extensions as long it does not directly regulate land use, subdivisions requirements, or property development.

The area to be annexed was included in the City's updated Municipal Service Review (MSR) and within the City's Sphere of Influence (SOI) which was adopted by LAFCo in November 2018. Attachment 1 includes a copy of the adopted Sphere of Influence map. Below is the narrative of the area:

City Wastewater Disposal Irrigation Fields Area

The City of Rio Dell has requested that their wastewater disposal irrigation fields, located adjacent to the city limits in the Metropolitan Road area, be included in the city's SOI in anticipation of annexing the parcel into the city. The site is located just north of the Eel River and west of Highway 101 on APN 205-111-039, which was created through a lot line adjustment in 2011 after the city acquired several parcels for disposing of treated wastewater for irrigation purposes during summer months (May-October). The subject parcel has not been pre-zoned by the city and is currently designated Public Facility (PF) under the most recent Humboldt County General Plan, which is used "to classify land appropriate for use by a governmental agency or public agency, which has the purpose of serving the public health, safety, convenience, or welfare

In response to the City' referral, included as Attachment 2, LAFCo staff recommended expanding the area to include the adjacent portions of the Highway 101 Right of Way and APN 205-111-032 which includes the road prism for the southbound lanes. Including these areas

would ensure that the annexation is contiguous to other City lands. Although the City would have no land use control of these lands, including them is consistent with Government Code Section 56741. A map of this area is included as Attachment 3.

The first step in the annexation process is to pre-zone and pre-designate the area to be annexed into the City. Because the lands contain public facilities, staff is recommending that the area be pre-zoned Public Facility. The Public Facility or PF zone is intended to be applied to lands owned by public agencies or to lands upon which such agencies operate public facilities. A copy of the Public Facility development standards is included as Attachment 4.

Once the area is pre-zoned, the City Council must adopt a Resolution initiating the annexation. Once the pre-zoning is complete and the Council adopts a Resolution initiating the annexation, the City is then allowed to make application to LAFCo.

The Planning Commission held a duly noticed public hearing on February 26, 2019, received the staff report considered the facts of the proposed annexation and invited public testimony. The Planning Commission adopted Resolution No. 138-2019 recommending that your Council adopt the pre-zoning Ordinance (Attachment 5), the General Plan pre-designation Resolution (Attachment 6) and a Resolution initiating the annexation application (Attachment 7).

California Environmental Quality Act

The primary purpose of the California Environmental Quality Act (CEQA) is to inform the decision makers and the public of potential environmental effects of a proposed project. Based on the fact that the parcels are developed with public facilities, staff has determined that the project is Categorical Exempt pursuant to Section 15319 of the CEQA Guidelines. Section 15319 provides for Categorical Exemptions for annexations of existing facilities. Based on the nature of the proposed project, staff believes there is no evidence to suggest that the annexation will have a *significant* effect on the environment.



17.20.080 Public Facility or PF zone.

The Public Facility or PF zone is intended to be applied to lands owned by public agencies or to lands upon which such agencies operate public facilities.

- (2) Uses Permitted with a Use Permit.
- (a) Residential uses, limited to caretaker apartment;
- (b) Penal, correctional or detention institutions, and facilities for the care of mental patients;
- (c) Public corporation yards, shops, repair and storage yards and buildings.

Section 1. Area to be Redesignated

The area identified in Exhibit A is hereby designated Public Facility.

Section 2. Severability

If any provision of the ordinance is invalidated by any court of competent jurisdiction, the remaining provisions shall not be affected and shall continue in full force and effect.

Section 3. Limitation of Actions

Any action to challenge the validity or legality of any provision of this ordinance on any grounds shall be brought by court action commenced within ninety (90) days of the date of adoption of this ordinance.


