### RIO DELL CITY COUNCIL REGULAR MEETING MINUTES FEBRUARY 6, 2024

The regular meeting of the Rio Dell City Council was called to order at 6:00 p.m. by Mayor Garnes.

**ROLL CALL:** Present: Mayor Garnes, Mayor Pro Tem Carter, Councilmembers Orr, Wilson, and Woodall

Others Present: Chief of Police Allen, Finance Director Sanborn, Wastewater Superintendent Kelly, Community Development Director Caldwell (Attended Remotely), Water Roadways Superintendent Jensen (Attended Remotely), Senior Fiscal Assistant Maciel, and City Clerk Dunham

Absent: City Manager Knopp (excused)

### **CEREMONIAL MATTERS**

In Appreciation to Sarah Reback for her Dedication to the Community

Mayor Garnes said that the City Council would like to take the opportunity to acknowledge and thank Sarah Reback from the Rio Dell Community Resource Center for her hard work and dedication to the community.

She read a statement on behalf of the City Council (included with these minutes as Attachment 1), thanking her for the amazing job that she and her staff do for Rio Dell and presented her with a Certificate of Appreciation and a Yeti cup with the City's logo that read "Sarah Reback – In Appreciation for your Hard Work and Dedication to the Community."

### PUBLIC PRESENTATIONS

Mayor Garnes invited public comment on non-agenda matters.

**Sharon Wolfe** addressed the Council and thanked Sarah and the Community Resource Center for all that they do. She said that every time the state, county or local government has asked the Community Resource Center to step up for services they have, and gone far beyond. She noted that they will be asking more of the Community Resource Centers as they implement Barely First Prevention Services throughout the County. She said that Rio Dell is in a good position because of having such an awesome community resource center.

**Steven Saunders** addressed the Council regarding his sewer bill and said that he was displaced after the earthquake and has not been able to live in his home yet is still being

billed for sewer service. He presented a utility bill in the amount of \$323.95 (representing charges from September 2023-January 2024). He said that the charges are unfair and requested the Ordinance be amended to include language to allow for an exception to waive the sewer charges in the event of an emergency when the homeowner is not allowed or able to occupy the residence. He requested the matter be placed on a subsequent agenda to address the issue. He also asked for donations from the community to help pay the outstanding bill and asked that donations be left with Sarah Reback at the Community Resource Center.

Consensus of the Council was to place the item on the next agenda for discussion and/or consideration.

### CONSENT CALENDAR

Mayor Garnes asked if any councilmember, staff or member of the public would like to remove any item from the consent calendar for a separate discussion.

Councilmember Woodall asked that Consent Calendar Item #4 be removed for separate discussion.

A motion was made by Carter/Woodall to approve the consent calendar including the following items:

- 1) Minutes of the January 16, 2024 regular meeting;
- 2) Authorizing the City Manager to purchase exercise station equipment in the amount of \$19,258.81; and
- 3) Approving Award of Bid to Hooven Construction for the Clean California Grant Rio Dell Exercise Station in the amount of \$34,945 and authorizing the City Manager to execute an agreement in coordination with the City Attorney

Motion carried 5-0.

### ITEMS REMOVED FROM THE CONSENT CALENDAR

<u>Approve Award of Bid for the Clean California Gateway Landscape Improvement Project to</u> <u>Jagimo Corporation Inc., DBA J & G Lawn and Garden in the amount of \$148,984 and</u> <u>authorize the City Manager to execute an Agreement in coordination with the City Attorney</u> Councilmember Woodall said that in reading the staff report, she realized that the plan is to remove all of the trees in the Gateway under the proposed project. She said that she understood that the original plan was to only remove the trees that were not doing well. She expressed disappointment to learn at the last minute that all the trees would be removed, including the beautiful flowering Cherry trees and others.

Mayor Garnes said that she was also disappointed and explained that under the grant application, all of the trees must be replaced. She said that the City Manager is discussing with the contractor the possibility of removing the trees and replanting them rather than destroying them although the additional cost would be on the City.

Councilmember Wilson asked for clarification on which trees in the Gateway were to be removed.

Mayor Garnes said that it would include all the trees at the beginning of the Gateway from the north end of town to Davis St.

She said that it was her understanding that the State awarded the grant and require that all of the trees identified in the grant application be planted. She said that the concern is not what happens to the existing trees but that all of the trees included in the application be planted.

Councilmember Wilson recommended the Council get better clarification on the terms of the grant before tearing out the trees and noted that this is also his first-time hearing that all of the trees would be removed. He asked if the City was in jeopardy of losing the grant if work does not commence in the next month or so.

Finance Director Sanborn said that the grant expires on June 30, 2024 so the City is on a fairly tight timeline to get the contract executed and get the project started. He explained that as stated in the grant, there are a certain number of trees the City is obliged to plant which requires removal of trees in the median. The City has the choice of uprooting the existing trees and trying to replant them but it would be at the City's expense as the grant would not cover that.

Discussion continued regarding the project timeline and destroying the existing trees versus saving them.

Mayor Garnes pointed out that the issue is timing and if the City starts the project and does not does not meet the timeline for the grant, the City could ultimately owe the State \$148,984. It doesn't matter to the State whether the City decides to save the trees or not. She said that the item before the Council is to award the contract as prescribed by the grant then come back and discuss a possible change order for removal of the trees so that they remain as viable trees as that was not part of the original bid. The additional cost would be at the City's expense. She noted that the City Manager asked the contractor if they had the ability to remove the entire root ball to save the trees and for a cost estimate which had not been determined.

Mayor Pro Tem Carter pointed out that the AdHoc and the City Manager asked the state to approve a change to the scope but they denied the request.

Councilmember Orr said that he understands the idea of trying to save the trees but the bigger picture is why three of the council members didn't find out about this until now.

Mayor Garnes commented that the AdHoc discussed the project with the City Manager and the item was previously agenized and discussed with the Council.

Councilmember Orr expressed concern regarding the communication between the Council, or lack thereof.

Mayor Pro Tem Carter said that the Council can move forward with awarding the bid then come back and discuss the disposition of the trees once the estimate for the tree removal is received since they are two separate issues.

Councilmember Woodall said that she would like the item continued to the next regular meeting.

Motion was made by Orr/Woodall to continue the item to the meeting of February 20, 2024 for further discussion. Motion carried 3-2; with Garnes and Carter dissenting.

### **REPORTS/STAFF COMMUNICATIONS**

Mayor Garnes provided highlights of the staff update and invited questions from the Council.

Mayor Pro Tem Carter commented that she was glad to see the City Manager attending the City Manager's conference which allows him the chance to talk about what the City experienced last winter with the earthquakes and storms.

She asked Wastewater Superintendent Kelly to provide a brief recap of the recent storm event.

Wastewater Superintendent Kelly commented that the extra I & I (inflow and infiltration) has impacted the bugs at the plant and they are doing their best to keep them happy as they do not like the dissolved oxygen that is coming in through the rainwater. Councilmember Woodall commended Superintendent Kelly for her written staff update and said that it was very thorough.

Mayor Garnes acknowledged the Police Department for. recent efforts in helping to clean up the City and getting guns and drugs off the streets.

Mayor Garnes called for public comment on the Staff Update. No public comment was received.

### SPECIAL CALL ITEMS/COMMUNITY AFFAIRS/PUBLIC HEARINGS

<u>Provide Staff Direction Regarding Letter of Opposition on Measure A, the Humboldt</u> <u>County Cannabis Reform Initiative</u>

Mayor Garnes read the City Manager staff report outlining the background of Measure A, the Humboldt Cannabis Reform Initiative and invited public comment on the measure.

**Jesse Jeffries** addressed the Council regarding the origin and impacts of Measure A on small farmers. He said that he is the owner of multiple cannabis farms in Humboldt County and the City of Rio Dell. He said that the proponents of Measure A say that it is to benefit the small famers however, this is far from the truth. He commented that small farmers were not involved in the drafting of this initiative and was an initiative created by two individuals and a San Francisco attorney. He said if the initiative was drafted with the small farmer and environmental concerns in mind then landowners, environmental groups and community members, policy makers and council members would have been involved in the drafting process of Measure A.

He added that it has taken many years to draft the current cannabis ordinance in Humboldt County and the ordinance already addresses all of the things the initiative seeks to change. It portrays that cultivation in Humboldt County is rapidly growing and needs more regulation in an already over-regulated industry. He said that over-regulation has already played a role in putting small farmers out of business.

He said that while the current ordinance is not perfect, it is effective and was created from input from community members, environmental groups, and other regulatory agencies. Environmental policies are already in place to protect residents, neighborhoods, land owners, wildlife, and watersheds. He said that Measure A is not only about the cannabis industry but is an attack on landowner's private property rights and land use designations. They claim that Measure A is to keep mega-grows out of Humboldt County but at the best is disingenuous as there are no mega grows in Humboldt County. He asked the City Council to vote No on Measure A and not let two disgruntled individuals change the course of the cannabis policies in Humboldt County. He finished by saying that this initiative will negatively impact the farmers and the community as a whole.

**Ross Gordon,** policy director with Humboldt County Growers Alliance addressed the Council and said that he opposes Measure A and completely agrees with the comments made by Mr. Jeffries. He said that the County of Humboldt has very comprehensive cannabis regulations and Measure A is 38 pages of very detailed law and rewrites the County ordinance without any public input. He referred to a long list of community members who oppose Measure A including Sheriff Honsal and other local Cities and

Commerce organizations. He expressed concern that the proposed initiative is not about regulating cannabis but more about micro-managing cannabis by restricting water usage, energy usage, or the number or size of structures. He noted that this is extensively discussed in the Humboldt County Planning Department's report. He said that this affects every single farmer within the County's jurisdiction regardless of size and passage of this initiative would have devastating effects on the entire county. He pointed out that the County received \$52 million in cannabis revenue from local farmers and encouraged the City Council to endorse a No vote on Measure A.

**Gabriel Smith,** general manager of Root 101 commented that the cannabis business has been decimated over the past two years and if Measure A passes, as one of the biggest tax payers in Rio Dell, they may be forced to close their doors. He said to please vote No on Measure A.

**Dylan Matole**, a farmer from Honeydew addressed the Council and said that over the last eight years as a farmer and a citizen he has engaged in policy and spent countless hours in front of the County Board of Supervisors and more recently, the Arcata, Eureka, and Fortuna City Councils. He acknowledged the difficulty of being a council member and applauded them for being willing to take on this job and listen to these issues. He pointed out that what Measure A is doing is undoing hours and hours of policy making decisions and it allows two wealthy retired individuals to fund a policy that will negatively impact the County. This will undue and supersede the current policy which is setting a dangerous precedent for establishing complex policies.

**Craig Johnson** said that he owns a small farm in Southern Humboldt under 10,000 square feet which is exactly what the proponents ran this measure on. He referred to a map from the Measure A website which show the concentration of cannabis farms in Humboldt County as far as the different water sheds. He noted that the legend shows that one of the dots reflects 1.5 miles so it represents that the green dots represent miles and miles of farms. However, to date if you add up all the legal farms they would fit into one-half of a square mile. He said that this type of policy is no longer necessary as farms have already been fully regulated. He commented that this community as well as other communities want the farmers to succeed and all have different reasons whether it is the medicine, the economic gain or just the right of private property rights. He asked the City Council to join the farmers in opposing Measure A.

Andy Riggs, a local business owner then addressed the Council in opposition of Measure A and said that he grew up in this area and now lives on his family farm in Stafford where he operates a small 3,000 square foot cannabis farm. He said as a kid growing up here, he attended Fortuna High and imagined himself attending college with a career in forestry, a subject he grew a passion for because of his Ag teacher Mr. Myers. He said that many of his peers also considered a career in forestry and knew they had the mill to fall back on if college didn't work out. Sadly, the decline in the forest industry changed that for many

locals and no matter how anybody feel about cannabis, it is a viable industry. He said that raising a crop has never been easy work yet it is a renewable and sustainable endeavor. The money that used to flow in from cannabis would spread through the County to local establishments such as restaurants and car dealerships and bolster the local economy. He said that although the local cannabis industry is a fraction of what it once was, it still brings money, hope, and opportunity to our local area. He said that he believes that Rio Dell understands this and is something he appreciates. He said that what scares him most about this measure is the precedent it will set as this 38-page initiative will amend 13 pages of the County's General Plan. He said that other industries could be next and urged the City Council to oppose Measure A.

**Cassandra Terrafelo**, said that she is a small farmer and also owns and operates a distribution and processing facility in Eureka. She said that the proponents of this measure have consistently said that the opponents don't understand the intention and are misinterpreting the initiative. She said that if this measure passes, she will have to comply with what the law says but the Humboldt County Planning Department basically said that it will be impossible to enforce. She commented that Ross Gordon is a genius and interprets a lot of this initiative and so they are not misinterpreting it. She provided stickers opposing Measure A.

**Supervisor Bushnell** said that she also spoke at the Fortuna City Council meeting and has taken opposition to Measure A since early on. She indicated that she was part of the AdHoc that worked with Mark and Betsy, the proponents of this measure and tried to work with them to start a change to the County ordinance noting that the ordinance is not perfect and a work in progress. She said that brand new industries grow and change and you need to be able to adapt to those changes but something that is tied to the General Plan does not allow that. She said that one of the things that has been continually said is that it is not the intent to punish cultivators but when you create an ordinance it becomes law which takes a lot of work by attorneys and while it may not be the intent, how you accomplish that doesn't always work out.

She said that what is strange about this initiative is that no other industries have come up against this so why not dairies or other industries. She said that it is not really about cannabis but rather the policies and the way it is being directed. Cannabis is legal whether you like it or not which is understandable but you have to get along to co-exist and it is not fair to punish farmers who have come from 2016 to now and followed every rule and regulation to comply. She said that the sheriff opposes this measure because it will cause farmers to go underground.

She added that the Planning Department will have to create these ordinances and cultivators will have to change according to the new regulations; that cost would be passed onto the cultivators.

**Kelly Flores** from Margro Advisors provided a handout on Measure A (included with these minutes as Attachment 2). She explained some of the technical elements of the measure and said that it would prohibit cultivation expansion or expansion of any new cannabis cultivation related structures including ancillary buildings, water storage tanks, ponds, or solar arrays. It also would limit farmers to no more one cultivation permit with a limit of 10,000 square feet. In addition, farms would be prohibited from being located along unpaved roads. She said this measure is over zealous and over-reaching as well as being over restrictive and does not support local farmers or the County as a whole. She asked that the City Council support the letter of opposition and allow this industry to move forward.

**Suzanne Maese** from Margro Advisors commented that they moved into town two years ago and have made major investments in Rio Dell. She said that they have a very busy cannabis consulting firm here and passage of this measure would dramatically affect their business and require them to close their doors. She urged the City Council to consider the collateral damage and protect the farmers who are taking care of the land. She reiterated that if this measure passes, there will be no amendments or expansions of cannabis activities which is what they help facilitate.

**Mark Thurmond,** one of the co-sponsors of Measure A addressed the Council via Zoom and said that the analysis done by the County is seriously flawed. He indicated that the measure does not prohibit improvements, only expansion of existing cannabis farms. He said that it also does not require existing farms to upgrade the road standards or improve facilities. He asked the City Council to carefully read both the initiative and the Humboldt County Planning Department analysis and compare what each document says. He said that there were many false statements in the analysis and statements made tonight and said that this initiative is not about two old retired fuddy-duddies getting together and writing this initiative as it was crafted in collaboration with the growers. He said that they collected 7,000 signatures from people in support of Measure A.

**Nick Erickson,** resident of Rio Dell since 1996 and owner of a small cannabis farm clarified that Mr. Thurmond indicated that they have 7,000 supporters of Measure A yet at every function he has attended there have only been two or three supporters show up. He also pointed out that when Ordinance 1.0 was formulated, there were public forums where everybody could come together and try to formulate the regulations, none of them showed up. He said that it wasn't until they realized that they might have a farm in their own backyard that they decided to act. He said with regard to obtaining 7,000 signatures in support of Measure A, they presented it as protecting small farms and protecting the environment. He noted that it took the County six weeks to go through the 38-page initiative so the average person signing the petition would not at a glance understand the initiative. He strongly urged the City Council to vote No on the initiative.

There being no further public comment, the public hearing was closed.

Councilmember Orr said that he was raised that you don't share your votes or try to influence people but that you trust them to read and understand things on their own to vote their conscience. He said that he teaches his students the same thing in school. He thanked Supervisor Bushnell for reiterating the same thing. He said that when he came here tonight it was an obvious No vote for him as the measure is decisive and draconian and excessively restrictive. He commented that he read it three times and does not need a legal degree to see what's going on. He said that he doesn't feel qualified to sway anyone's vote or tell them how to vote however, he will vote to oppose this initiative. He added that if passed, it could drive Humboldt County bankrupt.

Mayor Pro Tem Carter said that she read the initiative and has been following this for about two years. She said that she re-read the initiative and the county analysis before the meeting as well as the rebuttals that came from the proponents of Measure A. She pointed out that the legal cannabis industry is relatively new and there is need for flexibility to be able to change with the times. She also said that this would be undoing all of the work that went into transitioning from the black market to a legal market. She noted that to prepare for this meeting, she went out and talked to people in the community including those in support of the measure. She said that the industry is already strained and everyone has worked really hard to come into compliance.

She said that her most important point is that her job as an elected official, regardless of what her own personal opinions about cannabis may be, is that she is here to speak for her constituents and in hearing from the residents and businesses of Rio Dell, nobody wants this so it is her duty as an elected official to speak for those people and vote No in support of Measure A.

Councilmember Wilson said that this discussion takes him back to 2016 with legalization of cannabis and said that his views have changed considerably since then. He said that he was opposed to Rio Dell's cannabis ordinance and Prop 64 through the State. Those things passed and the citizens of Rio Dell spoke. He said that the more conservative people wanted to see money coming into Rio Dell. The City has a very good ordinance which is modeled after the County's ordinance. He said that through all of the work that has been done, he feels that the County and the City of Rio Dell have been successful in making this industry work.

He said that in listening to Sheriff Honsal, who he greatly respects, his big concern was that this initiative would push farmers back into the black market. With the decline in the timber and fishing industries, the only way people were going to make it around here was in the cannabis industry and to push that back into the illegal market is not good. He commented that the illegal grows don't seem to have decreased.

Supervisor Bushnell commented that illegal grows in Humboldt County have decreased from 15,000 to less than 1,000.

Councilmember Wilson said that he trusts the people in this room who are involved in the industry and think that the activities of the County have made it a viable legal industry along with guidelines and it is not productive to push farmers back into the illegal market. He said that the people in support of this initiative don't seem to be around except for on the telephone and he also opposes Measure A and he supports the letter of opposition.

Councilmember Woodall said that she was glad to see people come and voice their concerns to the Council which helps to understand the initiative. She said that she has always supported the cannabis industry and will also vote in support of the letter of opposition to Measure A.

Mayor Garnes noted that the legal farmers in Humboldt County have done everything they could do to be in compliance and that it doesn't seem like there is any more to regulate except some minor tweaks here and there. She commented that Rio Dell had over a hundred meetings before approving the cannabis regulations and the County had many meetings and the County and the Cities came to this decision and feel that the farmers have done everything they could to meet the requirements. She said that everything has already been covered in her opinion but she did ask that the City Manager bring this matter forward and allow the City Council to take a stand for the farmers and for all of the hard work of everyone in developing cannabis regulations.

Councilmember Orr said that he married into Humboldt County so hasn't had a lifetime around this industry. He said that his father-in-law was in the logging industry and he knows people in the fishing industry so it didn't take him long to figure out what happened there. He expressed appreciation to everyone for showing up and keeping the same thing from happening to the cannabis industry.

Motion was made by Carter/Orr to approve the letter opposing Measure A, the Humboldt Cannabis Reform Initiative. Motion carried 5-0.

### **ORDINANCES/SPECIAL RESOLUTIONS/PUBLIC HEARINGS**

### Second reading (by title only) and adoption of Ordinance No. 402-2024 Related to False Alarms and Fees

Chief Allen provided a staff report and explained that the ordinance was introduced at the January 16, 2024 regular meeting and is back for its second ready and adoption. He said that Ordinance 402-2024 establishes false alarms and fees. The Rio Dell Police Department is responsible for responding to both commercial and residential alarms and a majority of those calls they respond to are false alarms due to non-maintenance of the equipment or operator error.

If adopted, it will start in January 2025 and the fees will be \$20.00 every two years with the first two years waived. He explained that false alarms refer to excessive alarms so the first two false alarm calls would not be charged. The third false alarm would result in a fee of \$75.00 and would increase with subsequent false alarm calls.

Mayor Garnes opened the public hearing to receive public input on the proposed ordinance.

Sharon Wolfe said to reiterate, this is for commercial alarms that trigger a police response.

Chief Allen said that it is for commercial and residential alarms that trigger a police response.

Motion was made by Orr/Carter to approve the second reading (by title only) and adoption of Ordinance No. 402-2024 *Related to False Alarms and Fees.* Motion carried 5-0.

Introduction and first reading (by title only) of Ordinance No. 403-2024 Amending the City's Zoning Regulations to 1) define and allow for residential care homes with six or fewer persons by right in all residential zones; 2) update the definition of family to mean one or more persons living together in a dwelling unit, and 3) provide for farm employee housing consistent with state law in zones that allow agriculture as a permitted use pursuant to the State Employee Housing Act (Health and Safety Code of Regulations), Section 5061(b)(3) Community Development Director Caldwell provided a staff report and said that state law and the City's approved Housing Element require that the City identify the City's housing goals, policies, and implementation programs for the planning period 2019 through 2027. He said that the proposed text amendments fulfill some minor implementation measures in the Housing Element. He said that the City has the option to not implement these changes however; would not be eligible for future grant funding.

He reviewed the three proposed zoning text amendments and said that they were presented to the Rio Dell Planning Commission at their meeting of November 28, 2023 and the commission unanimously approved the text amendments as recommended.

Councilmember Woodall noted that the City already has residential care homes and asked if this zoning amendment just incorporates the regulations in the ordinance.

Community Development Caldwell explained that the current regulations refer to Residential Care Facilities as a facility that provides 24-hour non-medical care for more than six persons and this amendment defines residential care homes with six or fewer persons principally permitted in residential zones.

Motion was made by Carter/Orr to approve the introduction and first reading (by title only) of Ordinance No. 403-2024 Amending the City's Zoning Regulations to 1) define and allow for residential care homes with six or fewer persons by right in all residential zones; 2) update the definition of family to mean one or more persons living together in a dwelling unit, and 3) provide for farm employee housing consistent with state law in zones that allow agriculture as a permitted use pursuant to the State Employee Housing Act (Health and Safety Code of Regulations), Section 5061(b)(3) and to bring the ordinance back to the Council at their meeting of February 20, 2024 for tis second reading and adoption. Motion carried 5-0.

### **COUNCIL REPORTS/COMMUNICATIONS**

Mayor Pro Tem Carter addressed the recent head-on collision that occurred a couple miles north of Rio Dell tragically taking the lives of two Rio Dell residents. She said that it not only affected the family members of the victims but it also affected the entire community including the children at school. She extended heartfelt condolences to anyone affected by this tragedy.

She said that the regular meeting of the Rio Dell School Board was moved to February 27, 2024 at 6:00 p.m. as the result of this tragedy and the loss of one of their students.

She also reported on the last Chamber of Commerce meeting and said that they are already discussing plans for Wildwood Days.

Councilmember Orr commented on the recent fatalities and said that Christina Freitas was a bridesmaid in his wedding so he knew her and her family well. He extended special thanks to Officer House for responding to the scene. He said that he attended the funeral and memorial service and it was nice to see how many people showed up

Councilmember Wilson reported that he would be attending an HWMA meeting on Thursday.

Councilmember Woodall reported that she would be attending a Fire Department Board meeting on Thursday.

Mayor Garnes reported that she would be attending an HTA meeting on Wednesday morning.

Chief Allen announced that because this accident was such a tragedy to the community, there would be a candlelight vigil at Memorial Park for Christina and her daughter on Monday at 6 p.m. and invited the community to attend. He commented that Officer House was one of the first responders on the scene and witnessed what officers hope they never have to witness and thanked the City Council for the support.

Supervisor Bushnell asked that the invitation be extended to the Fortuna Fire Department.

Mayor Garnes then reminded everyone of the Disaster Preparedness Academy on March 2, 2024 at the Rio Dell Fire Hall. She urged everyone to go online to the Blue Lake Casino website to register and said there are flyers at City Hall and at the Community Resource Center. They will be giving out first aid kits, disaster preparedness kits and disaster plans and encouraged everyone to attend. She said on March 3, 2024 there will also be a Spanish speaking Disaster Preparedness Academy.

She also reported on the CERT meeting that occurred last night at the Rio Dell Fire Hall with another one scheduled for February 28, 2024. In addition, on February 17, 2024 there will be a CERT training in Blue Lake and at the Fortuna Fire Hall for CERT qualified people on February 22, 2024 at 6 p.m.

### ADJOURNMENT

A motion was made by Carter/Woodall to adjourn the meeting at 7:42 p.m. to the February 20, 2024 regular meeting. The motion carried 5-0.



### IT IS RECOMMENDED THAT THE CITY COUNCIL:

Approve the distribution of the City's Request for Proposal (RFP) for Auditing Services for Fiscal Year 2023-24.

### BACKGROUND AND DISCUSSION


Each year an independent auditing firm audits and prepares financial statements for the City of Rio Dell in accordance with Generally Accepted Accounting Standards (GAAP) and the standards for financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Those standards require that an audit be performed to obtain reasonable assurance about whether the financial statements are free from material misstatement. Per California Government Code 12410.6:

(a) An audit for any local agency, including those submitted to the Controller pursuant to subdivision (a) of Section 12410.5, shall be made by a certified public accountant or public accountant, licensed by, and in good standing with, the California Board of Accountancy.

(b) Commencing with the 2013–14 fiscal year, a local agency shall not employ a public accounting firm to provide audit services to a local agency if the lead audit partner or coordinating audit partner having primary responsibility for the audit, or the audit partner responsible for reviewing the audit, has performed audit services for that local agency for six consecutive fiscal years. For purposes of calculating the six consecutive fiscal years, the local agency shall not take into account any time that a public accounting firm was employed by that local agency prior to the 2013–14 fiscal year. The Controller may waive this requirement if the Controller finds that another eligible public accounting firm is not available to perform the audit.

JJA CPA, Inc. has provided the City with auditing services for 7 consecutive years, from Fiscal Year 2016-17 through 2022/23. Per CA Govt Code 12410.6, the City of Rio Dell is required to find another eligible public accounting firm to perform future City audits. The Controller waived this requirement last year after no other eligible public accounting firms responded to the RFP.

### I. INTRODUCTION

- a. The City of Rio Dell requests proposals from qualified firms of certified public accountants to audit its financial statements for six years, starting with the fiscal year ending 2024. These audits are to be performed in accordance with Generally Accepted Auditing Standards (GAAP), the standards set forth for financial audits in the U.S. General Accounting Office's (GAO) Governmental Auditing Standards, federal single audit requirements, and Governmental Accounting Standards Board (GASB) Pronouncements.
- b. During the evaluation process, the City of Rio Dell reserves the right, where it may serve the City's best interest, to request additional information or clarifications from proposers or to allow corrections of errors or omissions. At the discretion of the City, firms submitting proposals may be asked to make oral presentations as part of the evaluation process.
- c. The City of Rio Dell reserves the right to retain all proposals submitted and to use any ideas in a proposal regardless of whether that proposal is selected. Submission of a proposal indicates acceptance by the firm of the conditions contained in this request for proposals unless clearly and expressly noted in the proposal submitted and confirmed in the contract between the City of Rio Dell and the firm selected.

- e. The City of Rio Dell reserves the right to reject all provisions submitted and waive any irregularity.

- g. It is anticipated that the selection of a firm will be completed by April 16, 2024.

### II. DESCRIPTION OF THE CITY

- a. Rio Dell is located approximately 28 miles south of the City of Eureka in Humboldt County and was incorporated in 1965 as a general law city that operates under the council-manager form of government. The City Council consists of the Mayor, who the Council elects to serve a two-year term, and four members, who are elected at large, serving a staggered term of four years. The City provides a full range of municipal services, including Police, Building, Planning, Water, Sewer, Streets, and Administration.
- b. The City's Fiscal Year 2023-24 Operating and Capital Budget totals \$8.7 million.
- c. The Finance Department performs general accounting, budgeting, accounts payable, accounts receivable, cash receipts, utility billing, business license, payroll, cash management, and debt administration.
- d. The City of Rio Dell uses Accufund software for all accounting functions.
- e. The auditor's principal contact with the City of Rio Dell will be the Finance Director. The contact person will coordinate the assistance the City of Rio Dell provides to the auditor.

### III. SCOPE OF SERVICES

- a. The auditors will perform a financial and compliance audit to determine (a) whether the combined financial statements of the City fairly present the financial position and the results of financial operations in accordance with Generally Accepted Accounting Principles and (b) whether the City has complied with laws and regulations that may have a material effect upon the financial statements.
- b. The auditors will examine the City's internal accounting controls and accounting procedures and render written reports of their findings and recommendations to the Finance Director and the City Manager. The examination shall be made, and reports rendered in accordance with generally accepted government auditing standards.
- c. In the required reports on internal controls, the auditor shall communicate any reportable conditions found during the audit.
- d. Reportable conditions that are also material weaknesses shall be identified in the report. Non-reportable conditions discovered by auditors shall be reported in a separate letter to management, which shall be referred to in the reports on internal controls.

- e. Irregularities and illegal acts: Auditors shall be required to make an immediate, written report of all irregularities and illegal acts or indications of unlawful acts of which they become aware to the following parties:
  - i. City Council
  - ii. City Manager
  - iii. Finance Director
- f. Before issuing their final reports, the auditors will meet with the Finance Director and their designees and conduct an exit interview. All audit reports will be addressed to the City Council.
- g. Field Work: The City of Rio Dell anticipates and expects the primary fieldwork for the City to begin on or near the first week of October of each year. This does not include preliminary fieldwork, which may occur in June or July.
- h. Attendance at Meetings and Hearings: As part of the work scope, and included in the contract price, is attendance by the Contractor at a minimum of one (1) public meeting to present and discuss its findings and recommendations. The contractor shall attend as many "working" meetings with staff as necessary in performing work-scope tasks.
- i. The auditors may be consulted occasionally throughout the year as an information resource. The auditors may be asked to provide guidance on implementing Government Accounting Standards Board (GASB) requirements and specifics of federal and state regulations as they may affect local governmental accounting. They may also be asked to assist with the implementation of new pronouncements.

### IV. DELIVERABLES

- a. Audit and preparation of financial statements.
- b. If the City's federal expenditures meet the required limit, test programs for compliance with the Single Audit Act and applicable laws and regulations and issue the Single Audit Report.
- c. Perform agreed-upon auditing procedures about the City's GANN Limit (Appropriations Limit) and render a letter to the City regarding compliance.
- d. Preparation of the State Controller's Financial Transactions Report.
- e. Electronic copies of the above reports should be emailed to the City staff when completed.

### V. CITY'S RESPONSIBILITIES

- a. City staff will prepare the final closing of the books and provide the Transmittal Letter and Management's Discussion and Analysis (MD & A). The City will provide balance sheets for all funds and detailed subsidiary ledgers.
- b. City staff will produce the confirmation letters that the auditors mail.
- c. The City will provide the auditor with reasonable workspace, desks, and chairs. The auditors will also be furnished access to the internet, telephones, facsimile machines, and photocopying machines.

### VI. COMPENSATION

- a. The City will pay the auditors for those services described in Section III (Auditor's Responsibilities) the not-to-exceed amount contained within the agreement. For additional services required after the agreement's inception, written approval by the City is required before such services are rendered, for which a fee will be paid based on the auditor's quoted hourly rates.
- b. The auditors may submit itemized bills for their services at the end of each calendar month. The City will promptly review and issue payment accordingly.
- c. The City shall receive all final opinions and reports for the City of Rio Dell's financial statements by December of each year, barring any unforeseen City delays.

### VII. PROPOSAL REQUIREMENTS

- a. Independence: The firm should provide an affirmative statement that it is independent of the City of Rio Dell as defined by generally accepted auditing standards. Moreover, the firm must have no conflicts of interest with regard to any other work performed for the entity being audited. It is understood that the services performed by the auditors are in the capacity of independent contractors rather than as officers, agents, or employees of the City of Rio Dell.
- b. License to Practice in California: An affirmative statement indicating that the firm and all assigned key professional staff are appropriately licensed to practice in California should be included.
- c. Firm Qualifications and Experience: The proposal should state the size of the firm, the size of the firm's governmental audit staff, the location of the office from which the work on this engagement is to be performed, and the number and nature of the staff to be so employed on a part-time basis. Please indicate whether

any members of the audit team assigned to the City are reviewers in the GFOA Certificate of Achievement for Excellence in Financial Reporting program or the CSMFO Certificate of Award program.

- d. The firm must also submit a copy of the report on its most recent external quality control review, stating whether it included a review of specific government engagements.
- e. The firm shall also provide information on the results of any federal or state desk reviews or field reviews of its audits during the past three (3) years. In addition, the firm shall provide information on the circumstances and status of any disciplinary action taken or pending against the firm during the past three (3) years with state regulatory bodies or professional organizations.
- f. For the firm's office assigned responsibility for the audit, list the most significant engagements (maximum of 10) performed in the last five years that are similar to the engagement described in this proposal request. Reference contacts should also be included.
- g. Partner, Supervisory, and Staff Qualifications and Experience: The firm shall identify the principal supervisory and management staff, including engagement partners, managers, other supervisors, and specialists, who would be assigned to the engagement and indicate whether each such person is licensed to practice as a certified public accountant in California. The firm also should provide information on the governmental auditing experience, including the scope of audit services requested by the City of each person, information on relevant continuing professional education for the past three (3) years, and membership in professional organizations pertinent to the performance of this audit.
- h. Specific Audit Approach: The proposal should set forth a work plan, including an explanation of the audit methodology to be followed, to perform the services required in Part I, Section III of this request for proposals.
- i. Total All-Inclusive Maximum Price: The bid should contain all pricing information relative to performing the audit engagement described in this proposal request. The total all-inclusive maximum price to be bid is to contain all direct and indirect costs, including all out-of-pocket expenses. Maximum pricing should be included for all years of audits.
- j. Hourly Rate Schedule for key personnel assigned to the City's Project.
- k. Ownership of City-Related Documents: All property rights, including publication rights of all reports produced by the proposer in connection with services performed under this agreement, shall be vested in the City of Rio Dell. The

proposer selected shall only publish or release the results of its examinations with express written permission from the City of Rio Dell.

- I. Acceptance of Proposal Contents: After the City selects auditors, the contents of the submitted proposal will become a contractual obligation. The successful proposer must execute a standard consultant agreement with the City. Failure of the auditors to agree to include the proposal as part of the contractual agreement may result in the cancellation of the award. The City reserves the right to reject those parts that do not meet the City's approval.
- m. Acceptance or Rejection and Negotiation of Proposals: The City reserves the right to reject any or all proposals, waive non-material irregularities or information in the proposal request, and accept or deny any item or combination. By requesting proposals, the City is in no way obligated to award a contract or to pay the expenses of the proposing firms in connection with the preparation or submission of a proposal. Furthermore, the City reserves the right to reject any proposals before executing the contract(s) without penalty to the City of Rio Dell. If the City elects to refuse all proposals, it reserves the right to continue with its current service arrangement.
- n. Insurance Requirements: The Contractor shall provide proof of insurance as specified:
  - i. Commercial General Liability (CGL) with limits of no less than \$1,000,000 per occurrence
  - ii. Workers' Compensation with limits of no less than \$1,000,000 per occurrence
  - iii. Professional Liability with limits of no less than \$1,000,000 per occurrence

### VIII. EVALUATION PROCESS

- a. In reviewing the proposals, a city review team will use the following criteria (not in ranked order):
  - i. Experience and qualification of staff assigned to the engagement
  - ii. References (particularly local government references) and relevant work performed for those references
  - iii. Firm's demonstrated interest in maintaining continuity of auditing staff assigned to clients over time
  - iv. Cost
- b. Proposers may be asked to make oral presentations to supplement the proposal. These presentations will be held after receipt of the proposals and will be part of determining the auditors' qualifications. The oral presentation may result in the City's rejection of the proposal.

### **RE: AT&T COLR application - Oppose**

Dear Members of the Public Utilities Commission,

On behalf of the City of Rio Dell and as a concerned resident of this City and Humboldt County, I write to strongly request your opposition to AT&T California's application to terminate its Carrier of Last Resort (COLR) obligation. The potential implications for our community are deeply concerning, and I urge you to consider the specific challenges faced by residents and businesses in Rio Dell.

AT&T's application seeks relief from its COLR obligations in over 99% of its service territory, where AT&T believes alternative voice providers exist, without requesting a replacement COLR. This proposal, if approved, could allow AT&T to cancel service to its Plain Old Telephone Service (POTS) customers as early as 6 months, leaving rural customers in Humboldt County and Rio Dell particularly vulnerable.

Rio Dell, with its diverse and sprawling landscapes, relies heavily on landline services, especially in remote and rural areas where alternatives may be limited. During emergencies, such as natural disasters or power outages, access to reliable 911 and 211 services is paramount, and POTS remains the most dependable communication tool in our safety net arsenal. The unavailability of cell service after the December 2022 earthquake underscored the importance of maintaining reliable landline services, as many residents were left without means of communication during a time of crisis.

Additionally, alternative technologies proposed by AT&T do not offer commensurate regulatory treatment or consumer protections, further jeopardizing the safety and accessibility of communication services in our community.

Furthermore, AT&T's application fails to address the unique needs of our elderly, vulnerable, and disadvantaged populations, who may struggle to find suitable alternative services in the event of service termination. The potential withdrawal of wireline infrastructure without adequate replacement options could leave entire neighborhoods in Rio Dell without telecommunications options, compromising public safety and economic development. It is imperative that the CPUC prioritize the interests of residents and businesses in Rio Dell by rejecting AT&T's application and preserving the existing COLR obligation. Rio Dell is committed to providing reliable, secure, and open networks to all citizens, and AT&T's proposal undermines these efforts.

In the face of these challenges, the Rio Dell City Council respectfully urges the CPUC help protect the residents of Rio Dell. Rejecting AT&T's application would ensure the continued provision of reliable, accessible, and affordable telephone services for those who depend on the existing COLR obligation.

### PUBLIC PARTICIPATION HEARING

AT&T's Applications for Targeted Relief from its Carrier of Last Resort Obligation and Relinquish its Eligible Telecommunications Carrier Designation (A.23-03-003 and A.23-03-002)

### AT&T's application regarding Carrier of Last Resort Obligations (A.23-03-003)

In this application, AT&T requests to be relieved of its Carrier of Last Resort (COLR) obligations in certain areas of California. If approved, it would no longer be required to offer landline telephone service where it is currently required to offer Basic Service in those areas. Basic Service includes nine service elements such as Lifeline rates for eligible customers, free access to 9-1-1, Telephone Relay Service, and directory and operator services. More information on Basic Service is available at <a href="https://www.cpuc.ca.gov/industries-and-topics/internet-and-phone/broadband-mapping-program/broadband-public-feedback/basic-service-definition">https://www.cpuc.ca.gov/industries-and-topics/internet-and-phone/broadband-mapping-program/broadband-public-feedback/basic-service-definition</a>.

What is a Carrier of Last Resort (COLR)? A COLR is a telecommunications service provider that stands ready to provide basic telephone service, commonly landline telephone service, to any customer requesting such service within a specified area. At least one telephone company in a specified area is legally required to provide access to telephone service to anyone in its service territory who requests it. This is known as the Carrier of Last Resort (COLR) obligation which ensures that everyone in California has access to safe, reliable, and affordable telephone service. AT&T is the designated COLR in many parts of the state and is the largest COLR in California. Where AT&T is the default landline telephone service provider means that the company must provide traditional landline telephone service to any potential customer in that service territory. AT&T is proposing to withdraw as the COLR in your area without a new carrier being designated as a COLR.

What areas are impacted by AT&T's request to withdraw as a COLR? <u>Here</u> is the list of census designated places where AT&T is requesting to withdraw as the designated COLR and <u>here</u> is an online version of the map with address lookup.

What might happen if AT&T withdraws as a COLR? An area without a COLR could mean that there would be no landline telephone company serving that area and that there could possibly be no landline telephone access for customers in that area. If AT&T's proposal were accepted as set forth in its application, then no COLR would be required to provide basic service in your area. This does not necessarily mean that no carriers would, in fact, provide service in your area—only that they would not be required to do so. Other outcomes are possible, such as another carrier besides AT&T volunteering to become the COLR in your area, or the CPUC denying AT&T's proposal.

### AT&T's application regarding Eligible Telecommunication Carrier Designation (A.23-03-002)

On March 3, 2023, AT&T requested to give up its designation as an Eligible Telecommunications Carrier (ETC).

What is an ETC? An ETC is a telephone company operating in a specific geographic area, that receives financial assistance from the federal government-established Universal Service Fund to provide high quality, and affordable telephone service to customers at all income levels in specific geographic areas. One example of a program funded by the Universal Service Fund is federal Lifeline. While funding for this program is provided by the federal government, each state determines a telephone company's eligibility for ETC designation. In California, a company's eligibility for these federal funds is determined by the CPUC.

**Does an ETC provide California LifeLine?** In California, the CPUC also approves and denies applications for state funding for programs to provide universal support, including California LifeLine (California's program is called LifeLine with a capital "L" for "Line"). The California LifeLine program is separate from the federal Lifeline program. An ETC may be a provider of California LifeLine as well as federal Lifeline, but eligibility to provide California LifeLine is no limited to only ETC providers.

What is AT&T's request in this application? AT&T is applying to give up its ETC designation, whi it to no longer offer federal Lifeline, as well as other federal programs designed to subsidize telecommunications support for low-income individuals and individuals located in remote areas. AT&T's participation in the California LifeLine program is a separate matter from this application to give up its ETC designation. AT&T asserts that it is not necessary to keep its ETC designation because it no longer receives any federal high-cost support from the federal government to provide universal service. By relinquishing its ETC designation, AT&T will no longer be eligible to receive federal support to provide Lifeline, which could potentially affect all current AT&T Lifeline customers.

What areas are impacted by AT&T's request to give up its ETC designation? All areas of AT&T's service territory where it currently holds ETC designation, which is the same as its Carrier of Last Resort (COLR) service territory, could be impacted if the CPUC approves AT&T's application. What are the potential impacts on customers' bills? For a household receiving federal Lifeline from AT&T, the bill could increase by \$5.25 per month for voice-only service, or \$9.25 per month for bundled or internet service. In addition to these amounts, a household on Tribal lands receiving federal Lifeline from AT&T could experience an additional \$25 per month bill increase.

What is required of AT&T for the CPUC to approve AT&T's request? AT&T must demonstrate that another ETC provider can provide universal support in the areas where AT&T wishes to surrender its ETC designation.

### BACKGROUND AND DISCUSSION

The Finance Director provides reports on the budget to keep the Rio Dell City Council and the public informed on the status of the City's finances. The attached Mid-Year Financial Report for FY 2023-24 summarizes budgeted versus actual amounts as of December 31, 2023, and describes any significant variances.

FY 2023-24 Mid-Year Financial Report

Mid-Year FY 2023-24

This Mid-Year Financial Report reviews the City's financial condition for fiscal year (FY) 2023-24 as of December 31, 2023. The report describes the revenues received and expenditures incurred and explains any significant budget variances at mid-year or projected to occur at the end of the fiscal year.

### SUMMARY

The FY 2023-24 adopted budget for the City of Rio Dell was \$8.77 million, with estimated revenues of \$7.58 million. Total City revenues received at midyear were \$2.55 million; expenditures totaled \$3.25 million. This difference is primarily due to expenses incurred on capital projects, grants, and Earthquake repairs yet to be reimbursed by the granting or State agency.

**Revenues:** The city's major funds had received 43% of revenues as of mid-year. This compares to 40% for the same period last year. There is a slight increase in the percentage of General Fund revenues received at mid-year; 29% was collected compared to 21% in the last mid-year report. Due to the current uncertainties in the economic climate at the local and State levels, the City budgeted revenues lower, most notably in Sales Tax and Cannabis revenue projections.

**Expenditures:** As of mid-year, City-wide expenditures were \$3.25 million or 37% of the \$8.77 million adjusted budget. Operating expenses were 52% of the budget, 12% more than last year. These increases are directly attributed to the

December 2022 Earthquake disaster. Capital project expenditures are increased due to continued work on large grant-funded projects such as the Eel River Trail.

### **GENERAL FUND**

As of December 31, 2023, General Fund revenues received were \$461,492, and expenditures were \$843,593.


**Revenues:** At mid-year, 29% of budgeted revenues had been received, compared to 21% for the same period last year. Property tax and In Lieu VLF funds are typically received from the County in the second half of the fiscal year, which is the primary reason revenues are below estimates at mid-year.

40% of budgeted cannabis revenues were received at mid-year compared to 55% last year. This is due to Ordinance 397-2023, a local ordinance that allowed cultivators on the Dinsmore Plateau to make a one-time tax payment by March 15 as an alternative to quarterly payments during the fiscal year.

The top three revenue sources in the General Fund are Property Tax In Lieu of Vehicle License Fees, Local Sales Tax Measure J, and Retail Sales Tax. Cannabis revenues exceeded property tax revenues for the first time in FY 2020-21 and, despite the industrywide downturn, are anticipated to do so again in the current fiscal year. 'Other Revenues' include Police Services Fees, rental revenues for cell towers, and gains on disposal of assets.

**Expenditures:** Budgeted appropriations for the General Fund for FY 2023-24 total \$1.97 million. This includes \$198,000 for capital and special projects. Total appropriations spent at mid-year were \$843,593 or 43%.

### **STREETS FUNDS**

**Revenues:** Projected street revenues increased by 3.5% or \$11,846 for the current fiscal year. 59% of those revenues were received by mid-year compared to 37% last year. The most notable increases were in the TDA and SB1 RMRA funds. Gas tax revenues were budgeted 1.7% lower year over year.

**Revenues:** The Sewer fund's total budgeted revenues for FY 2023-24 are estimated at \$1.47 million. This includes all fees, charges, penalties, and new connections for sewer service. Actual revenues received at mid-year were \$749,436, or 51% of the budget. Last year, at this time, revenues were \$697,433. The increase in the current year is primarily due to the revised sewer and water rates. Revenues are on target to end the year as estimated.

**Expenditures:** Total sewer expenditures at midyear were \$888,991, 49% of the budgeted amount. Expenditures in the Sewer Operating fund were at 51%. The treatment plant loan of \$6.6 million with the California State Waterboard will be paid off in 2043.

### WATER FUNDS

**Revenues:** The Water Fund's total budgeted FY 2023-24 revenues are estimated at \$1.29 million. This includes all fees, charges, and penalties. Actual revenues received at mid-year were \$639,117, or 49% of the budget. Water revenues are divided between Operations, Debt Service, Capital Projects, Metro Wells, and Dinsmore Zone.

**Expenditures:** Total water expenditures at midyear were \$720,522, or 52% of the budgeted amount. Expenditures in the Water Capital Fund were at 145%. This increase resulted from emergency earthquake repairs (\$107,813) and the CalOES grant-funded Eel River Pipeline Seismic Retrofit Project (\$67,012). The water plant loan of \$2.7 million with the California State Waterboard will be paid off in 2029.

### **BUDGET OUTLOOK**

The mid-year review indicates that revenues are largely tracked at budgeted levels, and expenditures are generally on course to remain within budget. However, several factors are anticipated to impact the budget outlook, as outlined below.

### **Earthquake**

The December 20th earthquake and its • subsequent aftershock on January 1st inflicted profound hardship upon the City of Rio Dell. Essential utilities like water and power were disrupted for days, and significant structural damage rendered numerous homes uninhabitable. The financial burden of this disaster extends beyond the immediate, impacting future fiscal years. Compounding this challenge, inflationary pressures and escalating service costs cast uncertainty on large-scale infrastructure projects necessitated by the earthquake.

Following CalOES guidelines, Rio Dell is eligible for reimbursement of up to 75% of approved project costs. However, the remaining 25% remains the city's responsibility. Recognizing this fiscal burden, the city has proactively pursued avenues to qualify for CalOES coverage of this 25% share, requiring a caseby-case assessment.

Rio Dell's situation exemplifies the intricate interplay between natural disasters and municipal fiscal constraints. While the earthquake's immediate impact was severe, the city's proactive approach to securing resources and navigating financial complexities underscores its resilience. Moving forward, Rio Dell's ability to secure complete funding and rebuild its infrastructure will be crucial in ensuring a swift and sustainable recovery.

### **Cannabis**

- Recent cannabis pricing declines and reduced market activity have adversely impacted City revenues in the past growing seasons. This volatility was previously communicated to the Council and remains a concern for future fiscal stability. However, staff remains confident in the City's long-term prospects within the cannabis industry due to several key advantages:
  - Comprehensive and strategic local regulations: Our regulatory framework fosters a stable and predictable environment for legal cannabis businesses.
  - Absence of "legacy grow" challenges: Unlike other municipalities, we are not burdened by the complexities and financial liabilities associated with unregulated pre-existing cultivation operations.
  - Robust municipal infrastructure: We possess the necessary infrastructure to support the growth and needs of the legal cannabis industry.
  - Attractiveness to professional legal cannabis operators: These factors position us as a favorable location for established and reputable cannabis businesses, fostering sustainable growth and revenue generation.

### **TPGAA**

 The Taxpayer Protection and Government Accountability Act (TPGAA) initiative, currently proposed for the November 2024 California ballot, has sparked significant debate on its potential impact on small cities in the state. Here's a breakdown of the key arguments and concerns:

### Potential Negative Impacts:

- ✓ Reduced Revenue: The initiative proposes raising the voter approval threshold for local taxes from a simple majority to two-thirds, making it more challenging for small cities to raise funds for essential services like infrastructure, public safety, and programs. This social could exacerbate budget shortfalls and limit their ability to address critical needs.
- ✓ Increased Litigation: The initiative expands the definition of what constitutes a "tax," potentially subjecting more fees and charges to legal challenges. This could lead to costly lawsuits and further strain limited resources in small cities.
- ✓ Reduced Local Control: The initiative imposes restrictions on how local governments can spend certain types of revenue, potentially limiting their flexibility and ability to prioritize local needs. This could hinder their responsiveness to community concerns and hinder innovative solutions.

### Uncertainty and Legal Challenges:

The initiative's potential impact is complex and depends on city size, existing tax structure, and future service needs. Additionally, the initiative faces legal challenges contesting its constitutionality, which could affect its implementation and timeline.

The TPGAA initiative has the potential to significantly impact small cities in California, with both potential negative and positive consequences. It's crucial for residents, businesses, and local officials to carefully consider its potential effects and engage in informed discussions before the November election.

### **Streets Funds**

The City of Rio Dell Street Funds faces challenges from electric vehicles and declining Gas Taxes.

- Existing state-based formulas for street funding are inadequate, failing to cover maintenance costs fully.
- ✓ The COVID-19 pandemic further exacerbated funding shortfalls.
- ✓ The rise of electric vehicles (EVs) and the decline in gas tax revenue create additional challenges.

Impact of EV Adoption:

./

- California's commitment to reducing greenhouse gas emissions through EV mandates and other climate initiatives leads to decreased gasoline and diesel consumption.
- This translates to lower gas tax revenue, impacting state, county, and city funding for streets.

Due to these factors, the Legislative Analyst's Office predicts a \$6 billion decline in gas tax revenue over the next decade.

### Mitigation Efforts:

 ✓ Significant General Fund investments have helped offset the revenue shortfall thus far. However, the long-term sustainability of this approach remains uncertain.

California faces a critical need to reform street funding in light of declining gas tax revenue and the growing adoption of EVs. Sustainable solutions must be identified to ensure adequate funding for essential infrastructure maintenance and improvements.





### BACKGROUND AND DISCUSSION

Following the December 20, 2022, earthquake and subsequent tremors in January 2023, the Rio Dell City Council recognized the significant hardship faced by residents whose homes sustained damage and were deemed uninhabitable ("Red-Tagged"). In response, Resolution 1578-2023 was passed, waiving sewer fees for these residences for a period of 6 months.

Resolution 1578-2023, approved by the Rio Dell City Council, waived sewer fees for "Red-Tagged" residences from December 20, 2022, to June 30, 2023. A total of \$6,321 in customer sewer fees were waived during this period. Subsequent to June 30, 2023, customers were billed at the pre-earthquake rate per Resolution 1578-2023.

At the February 6, 2024, City Council meeting, concerns were raised regarding sewer bill charges for unoccupied, "Red-Tagged" residences. To address these concerns, City staff was directed to revisit Resolution 1578-2023. City staff developed a revised Sewer Bill Adjustment Claim Form allowing ratepayers with "Red-Tagged" residences to apply for a sewer fee waiver from the date of the Declared Local or State Disaster until the residences "Red-Tag" designation is removed.

The eligibility criteria are as follows:

- The residence must have been officially "Red-Tagged" following a declared natural disaster.
- The applicant must be the designated ratepayer for the affected residence.
- The applicant must demonstrate active efforts towards removing the "Red-Tag" designation.
- All completed claim forms will undergo review by the Finance Director and require approval by the City Manager.

WHEREAS, as soon as the 'Red-Tag' designation is removed, customers will return to being billed the sewer rate last registered with the City of Rio Dell prior to the earthquake disaster, and the temporary fee waiver will end for that customer; and

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Rio Dell approve temporarily waiving sewer fees for customers whose residences have been 'Red-Tagged' by a declared Natural Disaster.

### **Background and Discussion**

On April 6, 2021, a Notice of Violation was served on the owner of the parcel that includes both addresses of 267 and 289 Berkeley Street. No significant progress was made on clearing the violations and a Notice of Nuisance and Order to Abate was served to the owner on June 1, 2021. This document was recorded at the Humboldt County Recorder's Office. Most of the original violations were located in proximity to the residence addressed 289 Berkeley and were cleared however, additional trash and solid waste began to accumulate at 267 Berkeley.

In September of 2023, City staff confirmed with the owner that this residence had been abandoned by the former occupants and there were excessive amounts of solid waste, household garbage, and other debris both inside and outside of the structure. In addition, the residence was unsecured and was an attractive nuisance. The Notice of Nuisance and Order to Abate was amended to include violations of City Code dealing with substandard housing and this was served to the owner on October 25, 2023. The owner was unable to conduct the cleanup of the parcel and did not contest the abatement process. On November 13, 2023, an abatement warrant was obtained from the Humboldt Superior Court to remove the solid waste, a violation listed on the original Notice of Nuisance and Order to Abate. On November 14, 2023, the abatement was commenced. Due to the large amount of solid waste and unexpected debris, two additional days were required by the contractor to remove all of the solid waste and the abatement was completed on November 17, 2023. In all, 98 yards of solid waste, mattresses, tires, appliances, green waste, hazardous materials and e-waste were removed from the Property. The City's costs for the abatement were determined to be \$10,650.70. The cost recovery assessment was provided to the property owner in person on November 21, 2024 and sent via mail on November 27, 2024. The property owner has not made any attempt to pay or make a plan with the City for this debt.

On November 20, 2023, City staff received a Notice of Trustee Sale for the parcel. This document informed staff that the mortgage holder intended to auction the property on December 18, 2023. The owner was contacted and agreed to waive the thirty-day period that Rio Dell City Code allows to pay the cost of the abatement as he does not have the resources to do so.

Rio Dell Municipal Code (RDMC) Sections 8.10.310 through 8.10.330 cover the cost recovery process. RDMC Section 8.10.330 references the California Government Code Section 38773.5 which spells out the process for establishing taxes and assessments. This process requires two meetings, a public meeting followed by a public hearing.

### FINDINGS AND ORDER CONFIRMING ACCOUNT AND ASSESSMENT

On February 20, 2024, the Rio Dell City Council convened a hearing under Rio Dell Municipal Code Section 8.10.320 for the assessment of costs related to nuisance abatement activities at the subject premises recited above. At said hearing the Council considered the evidence presented to it concerning the subject premises, including relevant documents, writings, codes, ordinances, as well as oral testimony at the hearing, and now, therefore, it makes the following:

### FINDINGS:

- The property addresses located at 267 and 289 Berkeley Street, Rio Dell, California are located in an Urban Residential zone within the City of Rio Dell, Humboldt County, California and are referred to as Assessor's Parcel Number 053-163-002; and
- The Rio Dell Police Department received a complaint concerning the existence of violations on the property, to wit: Property use in violation of Rio Dell Municipal Code Section 8.10.020(a)(1), solid waste; and Section 8.10.030(7), nuisances; and
- The property owner was served with a Notice of Violation dated April 13, 2021, pursuant to Rio Dell Municipal Code Section 8.10.230, describing the violations and ordering abatement of those conditions; and
- 4. Due to violations not being corrected, the property owner was served with a Notice of Nuisance and Order to Abate dated June 1, 2021, pursuant to Rio Dell Municipal Code Section 8.10.260, giving the property owner additional, significant, and reasonable amount of time to correct the violations; and
- 5. The majority of violations at 289 Berkeley were cleared however, in September of 2023 an excessive amount of solid waste started accumulating in front of 267 Berkeley; and
- 6. On October 25, 2023, the Notice of Nuisance and Order to Abate was amended to reflect the current violations present on the property and served to the property owner; and
- 7. The property owner did not contest the imposition of the amended Notice of Nuisance and Order to Abate; and
- 8. The property owner refused and/or failed to meet the deadlines imposed by the amended Notice of Nuisance and Order to Abate; and
- 9. On November 13, 2023, an abatement warrant was obtained from Humboldt Superior Court; and
- 10. On November 14-17, 2023, the City of Rio Dell did, in fact, abate said nuisances; and
- 11. The City of Rio Dell maintained an accurate and itemized account of the cost of the abatement, pursuant to Rio Dell Municipal Code Section 8.10.310; and
- 12. The property owner was served with a Cost Recovery Assessment outlining the costs incurred by the City and the amount of the assessment proposed to be levied against the property; and

Violations were becoming excessive and new violations were appearing which consequently led to the service of a Notice of Nuisance and Order to Abate on March 29, 2022. Due to continuing to receive multiple complaints and the condition of the property becoming progressively worse, an abatement warrant was sought from the Humboldt County Superior Court on July 24, 2023. The abatement warrant was served to the property owner at the property on July 26, 2023. On July 28, 2023, a crew from Redwood Adult and Teen Challenge and myself conducted an abatement at the property. During the abatement, solid waste, scrap metal and excessive vegetation were removed from the property. The City's cost for the abatement were determined to be \$2,037.12.

The cost assessment recovery was provided to the property owner in person at 601 Gunnerson Lane on November 16, 2023. The property owner has not made any attempt to pay or make a plan with the City for this debt. Rio Dell Municipal Code (RDMC) Sections 8.10.310 through 8.10.330 cover the cost recovery process. RDMC Section 8.10.330 references the California Government Code Sections 38773.5 which spells out the process for establishing taxes and assessments. This process requires two meetings, a public meeting followed by a public hearing.

### BACKGROUND AND DISCUSSION

On November 7, 2023 the City Council authorized staff to rebid the Gateway Landscape Improvement project after initial bids on the first proposal came in too high. Staff worked with the State Clean California Program to dial the project down to the specific grant requirements for the project. Staff received bids back on January 8, 2024 and there was one bidder, J&G Landscaping who has worked for the city before on other projects. The bid came in near the budgeted figure at \$148,984. At this time staff recommends awarding the project to the lone bidder and executing an agreement.

Previous direction from the Council included preserving the existing Cherry trees on Wildwood Avenue. However, Clean California staff made clear that that change was not allowable under the grant. The Gateway Ad Hoc Committee's recommendation was to work with the contractor on a change order to remove the trees and their root balls to give away to the public, instead of simply cutting down the trees entirely. Staff is working with the contractor to develop a proposal for the Council's consideration, however this change order will not be covered by the Clean California Grant and will need to be paid for through City funds. Staff hopes to bring such a potential change order back at the next meeting for Council consideration.

Funds available for the overall Gateway Project total \$240,870 when including a \$5,000 donation from PG&E and the reassignment of a \$38,000 budget allocation of beatification funds towards the project. Based upon all bids received, the current estimated cost of the Gateway project, including landscaping and exercise station are at \$208,929. ///

### IT IS RECOMMENDED THAT THE CITY COUNCIL:

Authorize the City Manager to approve change orders up to \$31,941 for the Clean California Gateway Project; or

Approve the contingency without Cherry Tree Removal for a total of \$21,000.

### BACKGROUND AND DISCUSSION

On January 16, 2024 the Rio Dell City Council approved Resolution 1596-2024 allocating \$38,000 in budgeted City Beautification funds (General Fund) and a \$5,000 donation from Pacific Gas & Electric towards the Clean California Gateway Project. When combined with the \$197,870 grant, the total available balance for this project is \$240,870.

This agenda item includes authorization for construction contingencies and change orders up to \$31,941 for the project. This includes a 10% contingency (\$21,000) on each component of the project. This authorization also includes funding for the excavation and removal of approximately 13 Cherry Trees at an estimated cost of \$546 per tree.

At this time, the contractor does not have specific tree/rootball removal equipment. The change order estimate is based on a time and materials basis of \$110/hr. for hand digging trees and \$375/hr. for the use of excavator equipment which will only need to be used for approximately 5 of the larger diameter trees. The estimate on the total cost of removal is \$7,103 however this amount will vary greatly depending upon experience in the field. This amount does not include costs associated with the rehoming of the trees. Currently, the trees are planned to be donated to any interested party at the time of extraction. Due to the current state of the trees, the contractor also will not provide a guarantee of successful establishment or survival of the trees during the uprooting process or a subsequent transplant.

### **Recommendation:**

That the City Council:

- Allow staff to briefly discuss the proposed text amendments to the City's Zoning Regulations; and
- 2. Receive comments from the public; and

3. If there are no recommended changes to the Ordinance, approve and adopt Ordinance No. 403-2024 codifying the recommended changes.

### **Discussion:**

As discussed at the City Council meeting of February 6, 2024, State law and the City's approved Housing Element require that the City identify the City's housing goals, policies, and implementation programs for the planning period 2019 through 2027. The proposed text amendments fulfill some minor implementation measures. Below are the Zoning Amendments Implementation Programs in B-2 of the Housing Element.

### **ORDINANCE NO. 403-2024**



AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIO DELL APPROVING AMENDMENTS TO THE RIO DELL MUNICIPAL CODE TO (1) DEFINE AND ALLOW FOR RESIDENTIAL CARE HOMES WITH SIX OR FEWER PERSONS BY RIGHT IN ALL RESIDENTIAL ZONES SUBJECT ONLY TO THE SAME RESTRICTIONS IN THAT ZONE.; (2) UPDATE THE DEFINITION OF FAMILY TO STATE THE FOLLOWING. FAMILY -- "ONE OR MORE PERSONS LIVING TOGETHER IN A DWELLING UNIT."; AND (3) PROVIDE FOR FARM EMPLOYEE HOUSING IN ZONES THAT ALLOW AGRICULTURE AS A PERMITTED USE PURSUANT TO THE STATE EMPLOYEE HOUSING ACT (HEALTH AND SAFETY CODE SECTIONS 17021.5 AND 17021.6.

### THE CITY COUNCIL OF THE CITY OF RIO DELL ORDAINS AS FOLLOWS:

**WHEREAS** State law and the City's approved Housing Element require that the City identify the City's housing goals, policies, and implementation programs for the planning period 2019 through 2027; and

**WHEREAS** some of the implementation programs are minor in nature and others are more complicated; and

WHEREAS the proposed text amendments fulfill some minor implementation measures; and

**WHEREAS** the Housing Element and State law requires the City to amend the Zoning Ordinance to define and allow for residential care homes with six or fewer persons by right in all residential zones subject only to the same restrictions in that zone; and

**WHEREAS** the Urban Residential (UR), Suburban Residential (SR). Suburban Medium (SM) and Residential Multifamily (RM) zones are the City residential zoning districts that need to be amended to principally permit Residential Care Facilities; and

**WHEREAS** the Housing Element and State law requires the City to amend the Zoning Ordinance to update the definition of family to mean one or more persons living together in a dwelling unit; and

**WHEREAS** the Housing Element and State law requires the City to amend the Zoning Ordinance to comply with Health and Safety Code Sections 17021.5 and 17021.6 regarding farm employee housing; and

**WHEREAS** notices were posted on November 20, 2023 in conspicuous locations including City Hall and the City website, specifying the availability of the proposal, and the date, time, and location of the public hearing for this Code amendment.

**WHEREAS** the proposed action is exempt from the requirements of the California Environmental Quality Act (CEQA) in that it is not a Project which has the potential for causing a significant effect on the environment under Title 14 of the California Code of Regulations, Section 15061(b)(3).

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the City Council of the City of Rio Dell does hereby ordain as follows:

### Section 1.

Title 17 of the Rio Dell Municipal Code is hereby amended to read in as follows:

Definitions – Section 17.10.010

"Agricultural employee housing" means housing occupied by agricultural employees regulated by the California Department of Housing and Community Development under the Employee Housing Act (California Health and Safety Code 17000 – 17062.5).

"Family" means a person living alone, or two or more persons related by blood, marriage or adoption, or a group of not more than five unrelated persons living together as a single nonprofit housekeeping unit in a dwelling unit.

### "Family" means one or more persons living together in a dwelling unit.

#### 17.20.020 Suburban residential or SR zone.

The purpose of the suburban residential or SR zone is to provide land for low-density residential uses. The following regulations shall apply in all suburban residential or SR zones:

- (1) Principal Permitted Uses.
- (a) Single-family dwellings.
- (b) Residential Care Facilities with six or fewer persons.

### 17.20.030 Urban residential or UR zone.

The purpose of the urban residential or UR zone is to provide neighborhood residential areas with varying densities for single-family dwellings. The following regulations shall apply in all urban residential or UR zones:

- (1) Principal Permitted Uses.
- (a) Detached single-family dwellings.
- (b) Residential Care Facilities with six or fewer persons.

#### 17.20.035 Residential multifamily or RM zone.

The purpose of the residential multifamily or RM zone is to provide land suitable for higher density residential uses. The following regulations shall apply in all residential multifamily or RM zones:

- (1) Principal Permitted Uses.
- (a) Detached single-family dwellings, multiple dwellings and dwelling groups;
- (b) Community care facility for six or fewer individuals;

(c) Family day care home for 12 or fewer children, including children who reside at the residence;

(d) Emergency shelters/transitional housing subject to the operational standards in RDMC <u>17.30.120;</u>

- (e) Low barrier navigation centers.
- (f) Residential Care Facilities with six or fewer persons.

### Section 17.20.070 Rural or R zone.

The Rural or R zone is intended to provide for agricultural and very low-density residential uses. The following regulations shall apply in all rural or R zones:

- (1) Principal Permitted Uses.
- (a) General agricultural uses, including crop production and animal grazing;

(b) <u>Detached single-family dwellings, including farm dwellings, including detached residential</u> dwelling units.

(c) Agricultural employee housing with no more than 36 beds in a group quarters or 12 units or spaces designed for use by a single family or household, or that is approved pursuant to Section 17021.8 of the Health and Safety Code.

#### 17.20.130 Suburban medium or SM zone.

The suburban medium zone provides for low-density residential areas. The following regulations shall apply in all suburban medium zones:

- (1) Principal Permitted Uses.
- (a) Residential uses, including detached residential units.
- (b) Residential Care Facilities with six or fewer persons.

17.30.045 Agricultural Employee Housing.

Agricultural employee housing shall comply with the following:

1. Location. Agricultural employee housing may, but is not required to, be developed or provided by the employer, or located on the same lot where the qualifying agricultural work is being performed.

2. Evidence of Valid Permit. Within 30 days after obtaining the appropriate permit from the California Department of Housing and Community Development (HCD) to operate the agricultural employee housing, and thereafter on an annual basis, the applicant shall submit evidence that the HCD permit for the agricultural employee housing is current and valid.

3. Deed Restriction.

a. Within 30 days after receiving approval for permanent or seasonal employee housing from the Community Development Department, and before issuance of the final Zoning Clearance Certificate, the applicant shall record with the County Recorder, a deed restriction in a form approved by the City that runs with the land on which the agricultural employee housing is located declaring that:

i. The agricultural employee housing will continuously be maintained in compliance with this section and all other applicable sections of the Zoning Code; and

 ii. The applicant will obtain and maintain, for as long as the agricultural employee housing is operated, the appropriate permit(s) from HCD pursuant to the Employee Housing Act and the regulations promulgated thereunder.

b. The deed restriction shall not be amended, released, terminated, or removed from the property without the prior written consent of the City. In the event the agricultural employee housing use is terminated and/or structures are removed in accordance with the Zoning Code and other applicable law as confirmed in writing by the Community Development Director, the deed restriction that accompanies the development shall be released and removed from the property.

4. Signed Affidavit for Temporary Employee Housing. Within 30 days after receiving approval for temporary employee housing from the Community Development Department, the applicant shall submit a signed affidavit, in a form approved by the City, affirming that:

a. The agricultural employee housing will only be used as temporary employee housing; and

b. The applicant will obtain and maintain, for as long as the temporary employee housing is operated, the appropriate permit(s) from HCD pursuant to the Employee Housing Act and the regulations promulgated thereunder.

#### Section 2. Severability

If any provision of the ordinance is invalidated by any court of competent jurisdiction, the remaining provisions shall not be affected and shall continue in full force and effect.

### Section 3. Limitation of Actions

Any action to challenge the validity or legality of any provision of this ordinance on any grounds shall be brought by court action commenced within ninety (90) days of the date of adoption of this ordinance.

### Section 4. Effective Date

This ordinance becomes effective thirty (30) days after its approval and adoption.

Subject: Text Amendments to the Rio Dell Municipal Code (RDMC) to establish a Cannabis Cultivation Tax Guarantee.

### **Recommendation:**

That the City Council:

- 1. Allow staff to introduce Ordinance No. 404-2024 amending the Rio Dell Municipal Code (RDMC) to establish a Cannabis Cultivation Tax Guarantee; and
- 2. Receive comments from the public; and
- 3. Direct staff to make any recommended changes to the Ordinance; and
- 4. Continue the public hearing to the March 5, 2024 meeting for approval and adoption of Ordinance No. 404-2024.

#### **Discussion:**

Proposition 64, the Adult Use of Marijuana Act, was approved by California voters in November of 2016. It legalized the recreational use of marijuana in the state of California. In 2017 the City of Rio Dell was considering establishing commercial cannabis regulations to allow for cultivation and value-added (e.g., manufacturing, processing, distribution, and retail sales) businesses. At that time, the City Council was only interested in allowing cannabis activities if those activities provided some financial benefit to the City and its residents.

In November 2017 the City placed Measure X on the ballot. Measure X was designed to allow the City of Rio Dell to tax cannabis businesses at either a percentage of their gross revenue or by the square footage of their operations for cultivation. The intent was if Measure X was approved by the residents, the City would allow for commercial cannabis activities. Almost 81% of those who voted on the Measure, voted to tax cannabis activities. As such, the City developed and adopted the Commercial Cannabis Land Use Ordinance (CCLUO).

As the Council is aware the City currently taxes cultivators at \$2.00 per square foot. For the most part, the City's cultivators have paid their taxes except for Dinsmore Plateau Farms for the 2022 growing season. The City worked with the owners to reduce the tax amount by 50% to \$71,600 and waive the late fees resulting in a total reduction of \$89,500. Dinsmore Plateau Farms leased the operations to a new operator, New Earth Farms, for the 2023 growing season. Before the City would allow cultivation on the site, the City required that the outstanding tax amount of \$71,600 be paid in full, which it was.

Staff recently reached out to the new operator and was told that the 2023 crop had mold and fungus issues that impacted the overall production and he would not be farming in the 2024 season. Staff reminded the operator that he is still responsible for the taxes and requested that he provide the City with details surrounding the issues and challenges faced with the 2023 operation, including images and any supporting documentation he can provide, including crop loss figures. Once received, the City will review the information and provide an updated tax liability if deemed appropriate.

This situation highlighted the need to ensure that the City gets paid its cannabis taxes. A significant concern is the real possibility that a farmer can "grow and go" without paying

their cultivation taxes. Due to this concern and the instability of the outdoor cannabis market, staff is recommending that the City amend the City's Cannabis Tax regulations to establish a tax guarantee.

Attachment 1 includes a draft Ordinance which if approved and adopted would allow the City, at its sole discretion, to require either a surety bond, a deposit in escrow, or a letter of credit from a bank or other responsible financial institution authorized to do such business in the state.

### **ORDINANCE NO. 404-2024**



# AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIO DELL APPROVING AMENDMENTS TO THE RIO DELL MUNICIPAL CODE TO ESTABLISH A CANNABIS CULTIVATION TAX GUARANTEE.

### THE CITY COUNCIL OF THE CITY OF RIO DELL ORDAINS AS FOLLOWS:

**WHEREAS** the City established commercial cannabis regulations, Section 17.30.090 of the Rio Dell Municipal Code (RDMC); and

**WHEREAS** in 2017 approximately 81% of the voters of Rio Dell approved Measure X which requires the City to tax cannabis operators at either a percentage of their gross revenue or by the square footage of their operation; and

WHEREAS the City currently taxes cultivators at \$2.00 per square foot; and

WHEREAS for the most part, the City's cultivators have paid their taxes; and

**WHEREAS** Dinsmore Plateau Farms did not pay their cultivation taxes and late charges for the 2022 growing season; and

**WHEREAS** the City worked with the owners to reduce the tax amount by 50% to \$71,600 and waive the late fees resulting in a total reduction of \$89,500; and

**WHEREAS** Dinsmore Plateau Farms leased the operations to a new operator for the 2023 growing season; and

**WHEREAS** the new operator paid the outstanding balance of \$71,600 before the 2023 growing season; and

WHEREAS the new operator reported that they intended to cultivate 21,000 square feet; and

**WHEREAS** the 2023 operator recently informed the City that they are no longer involved with the Dinsmore Plateau Farms property; and

**WHEREAS** the City inquired about the taxes for the 2023 growing season and the operator reported that the crop had mold and fungus issues that impacted overall production; and

**WHEREAS** at this point the City hopes to work with the operator but is not expecting to receive the entire \$42,000 in taxes for the 2023 growing season; and

WHEREAS the City currently does not require security to ensure the payment of taxes; and

WHEREAS staff recommends to ensure that a cultivator performs its fiduciary responsibility to timely remit taxes, the cultivator shall provide a guarantee by one or more of the methods specified in this section in the amount of \$2.00 per square foot of cultivation as identified in the annual cultivation declaration. The requirement for a guarantee shall remain in force at the sole discretion of the City; and

**WHEREAS** staff recommends that the cultivators either provide a surety bond, a deposit in escrow, or a letter of credit from a bank or other responsible financial institution authorized to do such business in the state, a letter of credit in a form acceptable to the City attorney; and

**WHEREAS** the proposed action is exempt from the requirements of the California Environmental Quality Act (CEQA) in that it is not a project that has the potential to cause a significant effect on the environment under Title 14 of the California Code of Regulations, Section 15061(b)(3).

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the City Council of the City of Rio Dell does hereby ordain as follows:

### Section 1.

Article II of Title 5 of the Rio Dell Municipal Code is hereby amended to read in as follows:

5.40.260 Security for fiduciary performance.

(1) Surety Bond for Cultivation Activity

(a) The City at its sole discretion may require a surety bond for the payment of cultivation taxes, based on the annual cultivation declaration.

(b) Guarantee required. To ensure that a cultivator performs its fiduciary responsibility to timely remit taxes levied by this chapter, the cultivator shall provide a guarantee by one or more of the methods specified in this section in the amount of \$2.00 per square foot of cultivation as identified in the annual cultivation declaration. The requirement for a guarantee shall remain in force at the sole discretion of the City.

(c) Persons to provide guarantee. The guarantee required under this section shall be provided before March 1<sup>st</sup> of each year by the cultivator or by a personal guarantee from an owner(s), partner(s), member(s), officer(s), director(s), or responsible party(ies) of the cultivator, or any combination thereof.

(d) Methods. The cultivator shall include one or more of the following methods to guarantee the performance of its fiduciary responsibilities at the time of application for a certificate of registration:

(i) Surety bond. The cultivator may elect to provide a surety bond, as defined by section 995.120 of the Code of Civil Procedure, in an amount defined in subsection (a) of this section, from a company authorized to do such business in the state. The bond shall be in a form acceptable to the City attorney. The bond shall be payable to the City and shall be conditioned upon payment in full of the tax, including penalties and interest due and to become due and owing to the City by said cultivator during the effective period of the bond under the provisions of this chapter. The surety may terminate this bond, except as to any liability already incurred or accrued, and may do so upon giving the cultivator and the Finance Director written notice to that effect. The surety shall provide written notice to the chief fiscal officer not less than 30 days before the expiration, non-renewal, lapse, termination, or other similar event affecting such surety bond. Thirty days after receipt by the Finance Director of such notice or upon a later date specified in the notice, or upon the filing and acceptance of a new bond, the existing bond shall terminate and be of no more force and effect, except as to any liabilities or indebtedness incurred or accrued thereunder as of the date of termination.

(ii) Deposit in escrow. The cultivator may elect to deposit a cash sum, in an amount defined in subsection (a) of this section, either with the City or in escrow with a responsible financial institution authorized to do such business in the state. In the case of an escrow account, the cultivator shall file with the City an escrow agreement, which includes the following terms:

Funds of the escrow account shall be held in trust until released by the City and may not be used or pledged by the cultivator as security in any matter during that period other than payment of the tax, penalties, and interest due and to become due and owing to the City under this chapter; and

In the case of a failure on the part of the cultivator to remit taxes due under this chapter by the required due date, the institution shall immediately make all funds in such account available to the City for use in satisfying those taxes due, along with any related penalties and interest as provided for in this chapter.

(iii) Letter of credit. The cultivator may elect to provide, from a bank or other responsible financial institution authorized to do such business in the state, a letter of credit in a form acceptable to the City attorney. Such letter shall be filed with the City and shall certify the following:

a. The financial institution irrevocably guarantees funds in an amount defined in subsection (a) of this section; and

b. In the case of failure on the part of the cultivator to remit taxes due under this chapter by the required due date, the financial institution shall pay to the City immediately and without further action such funds as are necessary to satisfy those taxes due, along with any related penalties and interest as provided for in this chapter, up to the limit of credit stated in the letter.

### Section 2.
