RIO DELL CITY COUNCIL REGULAR MEETING FEBRUARY 16, 2010 MINUTES

The Regular Meeting of the Rio Dell City Council was called to order at 6:30 P.M. by Mayor Woodall.

ROLL CALL: Present: Mayor Woodall, Councilmembers Dunker, Marks and Thompson

Absent: Councilmember Barsanti (excused)

CEREMONIAL

<u>Proclamation in Recognition of Engineer's Week February 14-20th, 2010</u> Mayor Woodall read the proclamation in recognition of Engineer's Week declaring the week of February 14th, 2010 as Engineer's Week in the City of Rio Dell.

CONSENT CALENDAR

Councilmember Marks requested two items be removed from the Consent Calendar for separate discussion under Special Call Items: agreement with Winzler & Kelly for services related to Scotia CSD/Annexation; and approval of the Final Pay Request to Wendt Construction Co. for work related to the Safe Routes to School Improvement Project.

Motion was made by Dunker/Thompson to approve the consent calendar including the approval of minutes of the February 2, 2010 Regular Meeting; approval of minutes of the February 9, 2010 Special Meeting; approval of the appointment of Stephanie Beauchaine as Brownfield's Trainer/Coordinator; and approval of the re-appointment of Dave Gonzales and Denise Sweaney to the Rio Dell Planning Commission for three year terms ending December 31, 2012. Motion carried 4-0.

ORDINANCES/SPECIAL RESOLUTIONS

Approve Resolution No. 1070-2010 authorizing the County of Humboldt to apply on behalf of the City for North Coast Integrated Regional Management Plan (NCIWMP) Energy Efficiency and Conservation Block Grant (EECBG) Funding

Interim City Manager Stretch explained this resolution would replace Resolution 1063-2009 previously approved by the Council authorizing the County of Humboldt to apply for EECBG funding on behalf of the City as it was determined that there were some minor technicalities in that resolution that needed to be corrected before the application could proceed. He noted the application is for up to \$25,000 and would be used to replace the antiquated heating/cooling systems in City Hall.

Motion was made by Thompson/Marks to approve Resolution No. 1070-2010 Authorizing the County of Humboldt to Apply on Behalf of the City of Rio Dell for North Coast Integrated Regional Water Management Plan (NCIRWMP) Energy Efficiency and Conservation Block Grant (EECBG) Funding. Motion carried 4-0.

SPECIAL CALL ITEMS

<u>Approve Agreement with Winzler & Kelly for Services Related to Scotia CSD/Annexation</u> Councilmember Dunker suggested this action be postponed until representatives of The Town of Scotia are present and said he also thought it would be best to have discussions with them during a pre-meeting before any action is taken.

Councilmember Marks stated she understood the reason we were doing this is because the CSD application was going before LAFCo and by the City taking some movement, we would be able to participate in discussions with LAFCo regarding the formation of a Community Services District in Scotia; City Manager Stretch explained the City did not take an active role in the County Planning Commission and Board of Supervisors hearings on the general plan and zoning amendments, or the tentative map approval because the service delivery issue was not within their purview.

He said the City can take the initiative when it is believed that the integration of the communities would be more cost effective. The proposed agreement with Winzler & Kelly in the amount of \$5,000 (or less) is for services for the City, related to the proposed formation of a CSD for the Town of Scotia, and/or for services for the annexation of the Town of Scotia to the City of Rio Dell.

Motion was made by Thompson/Marks to approve the agreement with Winzler & Kelly for services related to Scotia CSD/Annexation. Motion carried 4-0.

Approve Final Progress Payment Request to Wendt Construction Co. in the amount of \$38,270.45 for work related to the Safe Routes to School Improvement Project

Councilmember Marks said her only question was whether the project stayed within Budget; Acting Public Works Director Jensen stated that it did.

Motion was made by Thompson/Marks to approve the Final Progress Payment Request to Wendt Construction Co, in the amount of \$38,270.45 for work related to the Safe Routes to School Improvement Project. Motion carried 4-0.

<u>Receive Presentation from Planwest Partners and Winzler & Kelly and Direct City staff to</u> <u>initiate the annexation process and return to Council with a schedule and costs for the annexation</u> <u>effort</u>

City Manager Stretch stated at the request of Councilmember Thompson, this item was placed on the agenda. He further stated that a letter dated February 9, 2010 was sent to Frank Bacik with the Town of Scotia to express the City's interest in annexing Scotia to the City of Rio Dell and inviting him to attend the Council meeting. He said that although the letter was delivered on February 11th, Mr. Bacik indicated in his response letter received today that he did not receive the letter until today and because of the short notice, was not able to attend.

City Manager Stretch commented that he felt it would be more expeditious for the Town of Scotia to go through annexation rather than a CSD.

The City Clerk was asked to accept the response letter from the Town of Scotia into public record.

George Williamson, Contract Planner made a couple of observations: 1) in 2006, the City made a considerable effort to study this proposed annexation, conducting engineering studies, considering the necessary general plan and zoning amendments, initiating the Municipal Services Review and Sphere of Influence Update necessary for LAFCo review, and having an independent Fiscal Study prepared and at the last minute, the former owners (Palco) withdrew the annexation application due to infrastructure cost issues; and 2) for the past three years, the County has been working through the proposed Tentative Map for subdivision of the parcels in Scotia as well as working on General Plan amendments and appropriate Zoning designations. He said the County conditioned the map to say that they must have a service provider and either way the land is going to be subdivided, with new land use and zoning designations.

He further stated that the City is on record at the appropriate time in regard to commenting on the EIR.

Councilmember Dunker commented that the community of Scotia has not had the opportunity to support either the formation of a CSD or annexation and in talking to community members, it seems that a lot of residents are in favor of annexation; Neal Carnam, Winzler & Kelly explained the property owner has to either accept or not accept the CSD and basically there are only two property owner in Scotia, that being the Town of Scotia, LLC and Humboldt Redwood.

Neal Carnam stated that both Winzler & Kelly and City staff did a lot of work analyzing infrastructure improvements and in the end the total costs were broken down to around \$30 million and Palco at that time was only willing to put approximately \$10 million on the table which he said probably would not change. Another aspect is that CSD's struggle to make it financially in today's world with the extensive cost of providing services and while a new CSD could be formed, it would probably not be in the best interest of the County or the residents of Scotia economically speaking. He said there would be significant financial impacts to proceed with annexation after the CSD is formed.

Mr. Carnam said the intent of the City's response now is to stand up and say that the City of Rio Dell thinks it would be in the best interest of the City and the residents of Scotia to proceed with annexation of the two communities.

Councilmember Dunker stated he agreed completely and reflected back to 2006 when Palco was going through bankruptcy proceedings stating that impacted the decisions made at that time. He said another point is that forming a CSD is a new experience for the Town of Scotia and they may not know all the challenges that face them.

Neal Carnam commented that he thought the issue is to convince LAFCo that annexation is the best solution; not to convince the Town of Scotia.

Councilmember Dunker pointed out that we need to consider the other relationships the City has with Scotia such as the Chamber of Commerce and come together and communicate in a positive manner to ensure those relationships are not jeopardized.

George Williamson stated that the letter sent to the Town of Scotia was very positive and what the Council needs to determine now is whether or not they want to provide direction to staff to initiate the annexation process and make a presentation to LAFCo.

Sharon Wolfe, 3 Painter St., stated when the annexation was being considered previously, infrastructure costs were a big issue and asked what has changed from then to now: Neal Carnam stated that Scotia's opinion about that annexation had not changed and that the City would be making its case to LAFCo. Sharon also asked where the \$30 million in infrastructure improvements would come from; Neal Carnam stated the City would be in the seat to develop a plan on how to accomplish that and with a larger rate base it would be easier to spread the costs and essentially subdivision fees would help to pay those costs.

Sharon Wolfe said she was exceedingly nervous about those cost being placed as a burden on the rate payers and said for the most part, there would only be one rate payer in Scotia since there were no homeowners yet; it was noted that the rate formula would be based on the number of connections rather than the number of property owners.

Councilmember Dunker stated that Mr. Bacik made some good points in his response letter to the City but made it sound like the Water Quality Control Board was going to give them their blessing on their current wastewater treatment facility which he said is probably not the case.

Neal Carnam pointed out that Scotia's treatment facility is located within the flood plain and would more than likely need to be relocated.

City Manager Stretch commented that the City's Infiltration Gallery is down stream from Scotia's wastewater treatment facility which is a concern. He noted that the City has made great advances with the entire wastewater system since annexation discussions first began and have been awarded a \$2.4 million grant for infrastructure improvements at the wastewater treatment facility including upgrade of the headworks. He said the City is ready, willing and able to provide the necessary municipal services to Scotia and feels that annexation is the most practical, efficient, and effective way of providing those services.

George Williamson further pointed out that the City updated it's Zoning Ordinance and General Plan to include industrial/commercial land use designations and in a land use way, Scotia would complete Rio Dell as far as potential employment areas.

Councilmember Thompson said in 2006 he took the time and walked Scotia with the proposed subdivision map and identified numerous problems and asked if the same tentative map was being proposed; Neal said he believed it was changed slightly to be in compliance with the Subdivision Map Act.

Thompson commented that water, sewer and power lines would need to be relocated to the public right-of-way as the parcels are sold. Neal explained those type of issues are addressed with the final subdivision map.

Al Petrovich, 1231 Eeloa Ave. said he was not up to speed with the annexation process but had heard that if annexed, we would be gaining the industrial mill site; Neal said the annexation would include the area from the bridge to the Tree Farm and involved two property owners; the Town of Scotia and Humboldt Redwood.

Neal Carnam then reviewed the history of annexation proceedings and the LAFCo application process.

Motion was made by Dunker/Marks to direct staff to initiate the annexation process and return to Council with a schedule and costs for the annexation effort. Motion carried 4-0.

<u>Approve Scope of Work from Planwest Partners, Inc. for Public Safety Element Update</u> City Manager Stretch stated that upon review of the May 19, 2009 minutes of the City Council, he learned that the subject of General Plan Element updates was discussed with the focus of the

discussion being the Circulation and Public Safety Elements. At that time, Council determined that the Public Safety Element was the priority and directed that it be updated upon appropriation of funds. During the 2009-2010 budget discussions, the funding was not allocated for this purpose. His recommendation was that funds be transferred from the General Fund Reserves to cover the cost, followed by update of the Circulation Element during the next budget year. He noted that Planwest Partners, the City's contract planner had prepared a Scope of Work to update the Public Safety Element in the amount of \$12,680 and estimated it would take 18 weeks to complete the update.

Mayor Woodall pointed out that two of the City's top priorities are redevelopment and economic development and in talking with the City Manager he indicated that the Circulation Element is more important in that respect.

Councilmember Marks stated that the Planning budget was overspent by \$42,000 last year and asked what the return or benefit would be for updating those elements; George Williamson explained the advantage of updating the Safety Element is that the City would be more informed of potential public safety hazards, including known faults, steep slopes, areas subject to erosion, flood zones, high fire hazard areas, locations of known hazardous materials, and use of hazardous substances. It would also include the update of the Hazards Map prepared for the 2009 Annexations and General Plan Amendments, from the City GIS database. He said with the current Safety Element we would be hard pressed to stop development of certain potentially hazardous areas. When development occurs, we would be able to do a much better job in protection against erosion. Also, in regard to emergency services, we could be in a much better position with the Office of Emergency Services (OES).

Councilmember Dunker stated that he had extensive training in safety and risk management and with the number one priority being health and safety; the Public Safety Element should be top priority due to potential liability.

Dunker asked if there were laws pertaining to timely update of elements of the General Plan; George said there are State Standards but the State cannot mandate the update with the exception of the Housing Element.

City Manager Stretch said in the May 19th minutes, the Planner indicated that in his opinion, it would be more efficient to do the Circulation Element first, followed by the Public Safety Element however, a majority of council members thought the Public Safety Element should be done first. At that meeting the Council merely established a priority list and did not authorize the work to proceed.

City Manager Stretch explained the Circulation Element would define a circulation system including pedestrian roadways, bike lanes and transit plans and put the City in a better position to

secure transportation grants. He said in his opinion the City would get the most benefit with update of the Circulation Element.

Councilmember Marks asked if the *Standard Improvements and Specifications* would part of the Circulation Element; George Williamson said that is a separate document and explained during the update of the Circulation Element we would look at how our current circulation system is working, point out deficiencies and add new streets into the system such as the annexed areas of Blue Slide Road and Northwestern Ave. He said it also would help with advance planning.

Councilmember Thompson pointed out that there was a Public Safety Element Update prepared by the City in 2001 including rather extensive research but because no CEQA document was prepared, the update was not valid. George Williamson said this update will not minimize the work that was done prior and stated that relevant items will be folded in to the update as well as information obtained in 2006. He noted the cost estimate was based on those factors.

Councilmember Marks stated that after hearing again the key points of each element, it seem to be to the City's advantage to proceed with update of the Circulation Element first.

City Manager Stretch said he had also received a Scope for update of the Circulation Element and offered to provide Council with a copy at this time or at the next meeting.

The consensus of the Council was that the Circulation Element be updated first, using General Fund Reserves; followed by the Public Safety Element with the next budget year. City Manager Stretch was directed to bring the Scope of Services for update of the Circulation Element back at the next meeting for approval.

Approve comments on the Notice of Preparation on the Bear River Ridge Wind Power Project and authorize the City Manager to send a letter to the County of Humboldt, Community Development Services Department

City Manager Stretch stated the Humboldt County Community Development Services Department is soliciting comments as to the scope and content of the environmental information to be included in the Environmental Impact Report (EIR) and Environmental Impact Statement (EIS) for the proposed Bear River Ridge Wind Power Project. He noted the item was placed on the January 27, 2010 Planning Commission agenda for discussion and comment and those comments were incorporated into the response letter.

Discussion continued regarding the scope of the project and the environmental effects it may have on the City of constructing and operating the proposed transmission line from the wind turbines to the PG&E substation and of any new or improved power transmission lines from the substation. City Manager Stretch advised the Council to focus on the EIR and to consider potential effects such as traffic, construction and operational noise, visual impacts, and potential electromagnetic-related adverse effects.

Councilmember Thompson stated he would like to see an alternate route considered due to the size and weight of the trucks transporting the wind turbine components and suggested the logging road above Webster St. as a possible alternate route. He said it would provide better flow of traffic and at the same time provide an alternate access to the Dinsmore Plateau. He said we also may be able to negotiate some infrastructure improvements to Belleview Ave. such as drainage.

Councilmember Dunker stated he preferred Monument Road as the designated route and said improvements to Monument Road would be a great benefit to the residents and the City. It could potentially become a "scenic route" for the City which could generate revenue and allow for various activities such as car and bike rallies.

Councilmember Marks asked if there is the possibility for the transmission lines to be placed underground; City Manager Stretch stated he wasn't sure if that large of lines (34.5 kilovolt) could be placed underground.

Al Petrovich, 1231 Eeloa Ave. said he was wondering where the funding was coming from, referring to a similar wind project that created an increase in PG&E rates. He asked if the Council was supporting removal of revenue from residents.

Discussion continued regarding the controversy over global warming and greenhouse gas emissions under AB-32.

Al Petrovich commented that enforcement of AB-32 would put him out of business due to the cost of retro-fitting his equipment to comply with new emissions requirements.

Motion was made by Marks/Thompson to approve the letter, to include comments from the City Council, on the scope and content of the Environmental Impact Report and Statement for the Bear River Ridge Wind Power Project, to be sent to the County of Humboldt, Community Development Services Department as lead agency. Motion carried 4-0.

Consider Endorsement of State Parks and Wildlife Conservation Initiative for November 2010 Statewide Ballot

City Manager Stretch stated information was received from the "Yes for State Parks Initiative" committee to promote a park funding initiative measure for the November 2010 ballot. He noted that nearly 150 state parks have been either closed entirely, or shut down part-time as a result of state budget cuts. The proposed initiative would generate a new revenue source dedicated primarily to fund the State Parks system and proposes an \$18 increase in vehicle license fees for all non-commercial vehicles. He said the Council is requested to determine whether to endorse and support this initiative in ways other than financial. He said one thing the City could do is send a letter stating that with the decline in the timber industry and fishing industry, tourism is the one thing that our community has left and our parks play an important role in promoting tourism.

Councilmember Dunker stated he was somewhat undecided about this issue because in order to balance the State Budget, drastic changes are necessary and we do depend on tourism as a main revenue source for our community. On the other hand, we will be voting for a new Governor in November and he or she may have other ideas about balancing the budget.

City Manager Stretch said he could get more information and bring the matter back to the Council for further discussion.

Al Petrovich, 1231 Eeloa Ave. stated he was in favor of keeping parks open however not by increasing fees or taxes and said the State is asking to free up dedicated revenue and down the line something else will come up and DMV fees will be increased again. He said the State is in peril due to chronic overspending; not under funding. He encouraged the City Council to quit accepting grants because ultimately the taxpayers are the ones paying for them.

City Manager Stretch stated he had personally drafted numerous pieces of initiatives over the years and there are ways to draft the language so that the funds go into a trust fund and cannot be used for other purposes down the road. The only way it can change is through the voters with another initiative.

Motion was made by Councilmember Thompson to direct staff to format a letter to endorse and support the statewide November 2010 ballot initiative entitled "State Parks and Wildlife Conservation Trust Fund Act of 2010", in ways other than financial, and direct staff to communicate that endorsement to the community, appropriate legislative representatives and the initiative campaign committee.

Councilmember Marks suggested the matter be researched further and brought back for further discussion; Council concurred and Councilmember Thompson withdrew his motion.

Authorize the City Manager to proceed with purchase of Meter Reading Equipment from National Meter & Automation, Inc. in the amount of \$13,580.00

Acting Public Works Director Jensen stated the City installed a new radio meter reading system in 2004 and at that time, it was the state of the art system. Since then, there have been many upgrades to the system including newly designed ERT's (electronic radio transmitters) because of battery failures with the original equipment. With the new equipment, comes an improved technology that requires improvements on the programming and reading devices as well. In addition, a meter programmer that was on loan to the City from National Meter and Automation was stolen from the City Corporation yard and never recovered.

His recommendation was that the City Manager be authorized to execute the purchase of the new system along with replacement of the meter programmer. He further recommended that the Council authorize a Capital Budget amendment in the amount of \$13,580 to appropriate Water Fund Reserves for the purchase since the item was not budgeted.

Councilmember Thompson questioned insurance reimbursement; City Clerk Dunham noted that the loss was reimbursable through insurance less a \$2,500 deductible.

Motion was made by Thompson/Marks to authorize the City Manager to proceed with the purchase of the new Meter Reading Equipment from National Meter & Automation, Inc. for the amount of \$13,580.00 to replace the original failed system. In addition authorize a Capital Budget amendment in the amount of \$13,580.00 to appropriate Water Fund Reserves for the purchase of the equipment. Motion carried 4-0.

PUBLIC PRESENTATIONS

John Lane, 1249 Riverside Dr. said he wanted to congratulate the person who came up with the idea of changing the layout of the Council Chambers; City Manager Stretch said we were also getting quotes on new carpeting and microphones to improve the public address system.

REPORTS/STAFF COMMUNCIATIONS

Interim City Manager Stretch reported on recent meeting and activities and announced he would be preparing a letter of intent for the 24 acre Mozzetti parcel needed for our wastewater irrigation site. He said it would basically lay out the principles and be non-binding but would lead to a formal agreement. He also announced the Budget document would be on the City website the following day.

Acting Public Works Director Jensen reported on recent activities in the public works department and said in addition to general maintenance they were in the process of replacing 12 street signs that had been pushed over; was getting caught up on year-end reports; said the gate on Edwards would be installed in approximately 2 weeks; and had installed a fire hydrant on Center and Rigby.

COUNCIL REPORTS/COMMUNICATIONS

Councilmember Thompson reported on the Redwood Coast Energy Authority (RCEA) meeting and announced that the State granted an extension to all of the cities and other agencies who had submitted grant applications under the Stimulus Program. He said the application for funding under the Energy Efficiency and Conservation Block Grant in which the City was requesting up to \$25,000 for a new heating/cooling system in City Hall. Was submitted and we were awaiting the State's response. He also reported RCEA's audit was coning along well.

Mayor Woodall commented that she visited the Wastewater Treatment Plant today and looked at the work done on the headworks and was very impressed.

Interim city Manager Stretch reported on the completion of the CDBG portfolio review by RCAA stating that there are now only two applicants that are out of compliance with the terms of the program.

ADJOURNMENT

There being no further business to discuss, the meeting adjourned at 9:05 P.M. to the February 23, 2010 Special Meeting.

The Solids and Disinfection Management Project is well underway. Over the last month, the contractor has begun installing the new headworks structure. The three out of an anticipated eight concrete pours were completed, including form work and rebar. Pressure testing on the new manholes was completed. The pump controllers for the headworks pumps were also installed. One change order was processed for \$1,000 to address a change in the fiberglass reinforced grating covering the headworks. This change was reviewed and approved by City staff. The next piece of work anticipated is continued concrete and rebar work to form the new headworks. A second change order for 438.88 is in process to address the need for additional rebar around the grit removal chamber. This change was reviewed and approved by City staff.

Progress Payment Request No. 3 for KG Walters Construction Co., Inc is attached to this memo. The pay request is based on the bid schedule lump sum breakdown provided by the Contractor and the actual quantities of work completed. A summary table is attached that includes my calculation for the payment due to the contractor as well as the contractor's original invoices and detailed cost breakdown. The accuracy of the percent complete on each item was reviewed by the construction management field staff.

SUBJECT: Support of ballot measure "Local Taxpayer, Pubic Safety, and Transportation Protection Act of 2010"

IT IS RECOMMENDED THAT THE CITY COUNCIL:

- 1. Adopt the enclosed resolution supporting the League of California Cities initiative Local Taxpayer, Public Safety, and Transportation Protection Act of 2010, and
- 2. Direct staff to forward the resolution to Rio Dell legislative delegation in Sacramento, the Governor and the League of California Cities.

BACKGROUND AND DISCUSSION

This item is placed on the agenda at the request of Council Member Dunker

The State of California is currently facing one of the most significant fiscal shortfalls ever and will most likely continue to rely on borrowing, diverting and claiming of local agency monies until an action is taken that forbids it. It is claimed by the State that Cities are political subdivisions of the State; therefore the State can determine how local revenues will be used. We have seen how the State takes advantage of the situation and balances their budget on the backs of cities and counties, who historically do not have strong constituencies.

A coalition of local government, transportation and transit advocates recently filed a constitutional amendment with the California Attorney General, called the *Local Taxpayer*, *Public Safety, and Transportation Protection Act of 2010*, for potential placement on California's November 2010 statewide ballot. The approval of this ballot initiative will further prevent the State of California from seizing, diverting, shifting, borrowing, transferring, suspending or otherwise taking or interfering with tax revenues dedicated to the funding local government services, including redevelopment, transportation improvement projects and mass transit.

The Local Taxpayer, Public Safety and Transportation Act of 2010 covers the following provisions:

- <u>Protects Locally Imposed Taxes such as Utility User Tax, Transient Occupancy, and</u> <u>Sales Taxes</u>: The measure prevents the legislature from taking or directing how these local taxes may be spent.
- <u>Property Tax Borrowing</u>: The measure repeals the State's authority to borrow local property taxes.
- <u>Reallocation of Property Tax or Vehicle License Fees</u>: The measure prohibits the State's ability to reallocate these revenues to pay off state mandates.
- <u>Borrowing or Stealing Local Highway User Tax Act (HUTA)</u>: The measure provides protection to local highway user taxes and requires hearings and study before state and local shares are changed.
- <u>Borrowing or Stealing or Proposition 42 Gas Tax</u>: The measure also provides the same protection as HUTA taxes.
- <u>Borrowing or Stealing Public Transit Account (PTA) funds</u>: The measure restricts the use of PTA funds only for transportation planning and mass transportation purposes and requires "Spillover" sales tax to be deposited in transit accounts.
- <u>Redevelopment Agency (RDA) Funds</u>: The measure prohibits taking, borrowing or directing spending of RDA funds.
- <u>Enforcement</u>: The measure provides a remedy requiring the state to re-pay funds taken illegally if a court so finds.

During the League of California Cities General Assembly at the League's Annual Conference in September 2009, city officials from throughout California unanimously voted in support of this measure. At this time, League staff, in conjunction with their coalition partners, is working to lay the groundwork for a successful signature gathering and fundraising effort for this measure to be placed on the November 2010 ballot.

It is recommended that the Council adopt the Resolution and forward it to our legislative representatives, the Governor and the League of California Cities

This measure amends the Constitution to constrain the state's authority to redirect or make changes to state and local resources and their allocation after October 21, 2009. Under the measure, the State Controller would reimburse affected local governments or accounts within 30 days if the state were found to have violated any of its provisions. Funds for these reimbursements, including interest, would be continuously appropriated from the state General Fund and do not require legislative approval. Any statute enacted between October 21, 2009 and the effective date of this measure that would have been prohibited under this measure would be repealed.

RESOLUTION NO. 1070-2010

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIO DELL IN SUPPORT OF THE LOCAL TAXPAYER, PUBLIC SAFETY AND TRANSPORTATION PROTECTION ACT OF 2010

WHEREAS, California voters have repeatedly and overwhelmingly passed separate ballot measures to stop State raids of local government funds, and to dedicate the taxes on gasoline to fund local and state transportation improvement projects; and

WHEREAS, these local government funds are critical to provide the police and fire, emergency response, parks, libraries, and other vital local services that residents rely upon every day, and gas tax funds are vital to maintain and improve local streets and roads, to make road safety improvements, relieve traffic congestion, and provide mass transit; and

WHEREAS, despite the fact that voters have repeatedly passed measures to prevent the State from taking these revenues dedicated to funding local government services and transportation improvement projects, the State Legislature has seized and borrowed billions of dollars in local government and transportation funds in the past few years; and

WHEREAS, this year's borrowing and raids of local government, redevelopment and transit funds, as well as previous, ongoing raids of local government and transportation funds have lead to severe consequences, such as layoffs of police, fire and paramedic first responders, fire station closures, stalled economic development, healthcare cutbacks, delays in road safety improvements, public transit fare increases and cutbacks in public transit services; and

WHEREAS, State politicians in Sacramento have continued to ignore the will of the voters, and current law provides no penalties when state politicians take or borrow these locally-dedicated funds; and

WHEREAS, a coalition of local government, transportation and transit advocates recently filed a constitutional amendment with the California Attorney General, called the Local Taxpayer, Public Safety, and Transportation Protection Act of 2010, for potential placement on California's November 2010 statewide ballot; and

WHEREAS, approval of this ballot initiative would close loopholes and change the constitution to further prevent State politicians in Sacramento from seizing, diverting, shifting, borrowing, transferring, suspending or otherwise taking or interfering with tax revenues dedicated to funding local government services, including redevelopment, or dedicated to transportation improvement projects and mass transit.

THEREFORE, BE IT RESOLVED that the City Council of the City of Rio Dell formally endorses the Local Taxpayer, Public Safety and Transportation Protection Act of 2010, a proposed constitutional amendment.

BE IT FURTHER RESOLVED that we hereby authorize the listing of the City Council of the City of Rio Dell in support of the Local Taxpayer, Public Safety and Transportation Protection Act of 2010 and instruct staff to fax a copy of this resolution to campaign offices at 916.442.3510.





IT IS RECOMMENDED THAT THE CITY COUNCIL:

1. Direct the City Manager to file an application with Humboldt LAFCo for the annexation of the Town of Scotia and adjacent area.

BACKGROUND AND DISCUSSION

At the February 16th meeting the Council authorized staff to prepare an application with Humboldt LAFCo for the annexation of the Town of Scotia. In that regard, the materials that must be prepared are as follows:

A. Humboldt LAFCo Application Form

The application form identifies the propose annexation action and provides information the Commission would consider during their review. A partial draft application is attached.

B. General Plan and Zoning Ordinance Amendments

The General Plan and Zoning Amendment would apply City General Plan and Zoning designations to the portion of the Town of Scotia proposed for annexation. The proposed plan and zoning designations map was distributed to the Council at the February 16th meeting.

C. Plan for Services

The Plan for services includes the following information:

- The statutory section under which the formation would occur;
- An enumeration description and justification of services to be extended;
- The level and range of those services;
- Phasing of services;
- Structure and facility improvements, upgrades and required operating conditions;
- Improvement financing, with operating budget/ revenues and expenditures; and
- City limits/ Sphere of Influence (SOI) and related services strategy.

D. Municipal Services Review Update

Annexing the Town of Scotia requires the City's updating of its 2009 Municipal Services Review (MSR) and Sphere of Influence (SOI) Update. As part of LAFCo review, the Commission shall then prepare a written statement of determinations on the following six subject areas:

- 1. Growth and population projections for the affected area;
- 2. Present and planned capacity of public facilities and adequacy of public services, including infrastructure needs or deficiencies;
- 3. Financing ability of agencies to provide services;
- 4. Status of, and opportunities for, shared facilities;
- 5. Accountability for community service needs, including governmental structure and operational efficiencies; and
- 6. Any other matter related to effective or efficient service delivery, as required by Commission policy.

E. Fiscal Impact Study

In 2007 a Fiscal Impact Study was prepared by MuniFinancial Consultants to provide an assessment of the fiscal impact of the annexation of the Town of Scotia to the City of Rio Dell and the Rio Dell Fire Protection District. The annexation would result in the transfer of the municipal services currently provided by the Town of Scotia Company, LLC, (then identified as PALCO) to its employees and other residents to the City of Rio Dell and the Rio Dell Fire Protection District. The 2007 Study examines the fiscal impact to the Rio Dell general fund and road fund, and the general fund of the Fire Protection District, of the proposed annexation under various economic scenarios. This study will be submitted in its current form.


F. CEQA Compliance

The County of Humboldt prepared a Program Environmental Impact Report (PEIR) for the Town of Scotia General Plan Amendment, Zone Reclassification, and Tentative Map (SCH #2007052042). Because of Rio Dell's proximity to Scotia, the City took a strong interest in the proposed actions by the County. The City commented on the adequacy of the PEIR, including both the PEIR Summary and the analysis. In its comments, the City took the position that Alternative A, annexation to Rio Dell, is the environmentally superior alternative. The PEIR would be used, with adaptations as necessary, in the annexation application

IT IS RECOMMENDED THAT THE CITY COUNCIL:

- 1. Approve the attached scope of services with Winzler & Kelly (\$33,082) to complete addendum #2 to the EIR for the Rio Dell Wastewater Reuse Project.
- 2. Direct the transfer of \$33,082 from the wastewater reserve fund to the wastewater budget to fund the scope of work, said fund to be reimbursed by the planning loan

BACKGROUND AND DISCUSSION

Rio Dell has a completed Environmental Impact Report (EIR) for the City's wastewater project, certified in May 2008 and amended with a certified addendum in June 2009. The existing EIR assumed that the wastewater treatment plant would be relocated to a parcel in the Eel River Industrial Park north of town, and that the treated wastewater would be reused by a Type I irrigation system on approximately 150 acreages near the new facility.

On January 12, 2010 the City Council amended that plan in order to expedite the project and save several millions of dollars. Those changes, including the construction of the new treatment facility on the existing site and the reuse of the treated wastewater north of the City by way of a Type II irrigation method, require another addendum to the EIR. The addendum would also include information collected as part of the subsurface investigation report and anti-degradation analysis now being completed.

The good news is that it is not anticipated that the addendum will require any further evaluations since the changes in the plan actually reduce the environmental impacts identified in the original EIR.

Winzler & Kelly have prepared a scope of work addendum #2 (attached) to the EIR as follows:

- Task 1: Update project description
- Task 2: Prepare administrative draft EIR addendum

- Task 3: Prepare EIR addendum
- Task 4: Prepare revised mitigation monitoring and reporting plan

The estimated cost to prepare the addendum is \$ 33, 082, to be completed by the end of April 2010. The wastewater operating budget will need to be augmented in the above noted amount by the wastewater reserve account, which will be reimbursed by the planning loan.

The timely preparation of the addendum to the EIR will keep the project plan moving forward on the accelerated timetable that the Council desires.

The City of Rio Dell And Winzler & Kelly For Addendum 2 to the Environmental Impact Report for Rio Dell Wastewater Reuse Project

This scope relates to a prime agreement dated 10-10-03 between the City of Rio Dell and Winzler & Kelly. All provisions of the prime agreement apply to this scope of services unless noted otherwise herein.

INTRODUCTION

This scope of services is to complete an addendum to the City of Rio Dell's certified Environmental Impact Report (EIR) for the City's Wastewater Improvement Project. The addendum is needed to address changes in City's preferred project adopted in the EIR certified May 2008 and modified by the addendum certified in June 2009. Table 1 attached to this scope reviews the proposed changes to the preferred project. The most extensive proposed change is the reuse system method of irrigation, which may be changed from Type I to Type II as indicated by the City in March 2009. Revision of the project description for the preferred project and evaluation of potential environmental impacts in the EIR Addendum is required to finalize project funding with either the State Water Resources Control Board (SWRCB) or USDA Rural Utilities Service (RUS) and for the City's permit with the North Coast Regional Water Quality Control Board (RWQCB).

The SWRCB and USDA RUS will be reviewing the EIR Addendum as a part of the funding process for this project. The subtasks necessary to complete the preparation of the EIR Addendum in a logical fashion, with appropriate review and coordination included are laid out below. Per CEQA, no public review period is required.

Under this scope of services, Winzler & Kelly will complete the EIR addendum, update the mitigation monitoring and reporting program, prepare the Notice of Determination (NOD) for county clerk approval, submit the NOD and Notice of completion to the State Clearinghouse, and submit final documents to the SWRCB for review. The effort to complete the addendum has been included in the City's environmental planning loan with Rural Community Assistance Corporation.

SCOPE OF SERVICES

Task 1: Update Project Description

In collaboration with City of Rio Dell staff, Winzler & Kelly will prepare a revised project description and figure(s) of the City's preferred improvement project as indicated at the January 12, 2010 wastewater special meeting for use in the EIR Addendum.

Task 2: Prepare Administrative Draft EIR Addendum

Winzler & Kelly will prepare the Administrative Draft EIR Addendum which includes information collected as part of the subsurface investigation report and anti-degradation analysis. The addendum will address changes primarily in the following impact areas:

- Cultural Resources: Cultural survey of Proposed Irrigation site will be conducted, as permission was not previously given to conduct the survey on the Mozzetti site.
- Hydrology and Water Quality: Results of Anti-Degradation Analysis will be presented here in support of the evaluation. The 100-year flood plain potential impacts will also be re-evaluated.

It is anticipated that there will be no additional evaluation needed for the following sections, because the proposed changes to the project description are expected to result in reduced impacts or no change to impacts: Aesthetics, Agricultural Resources, Air Quality, Biological Resources, Cultural and Historic Resources, Geology and Soils, Hazards and Hazardous Materials, Land Use and Planning, Mineral and Energy Resources, Noise, Population and Housing, Public Services, Recreation, Transportation, Utilities and Service Systems, and cumulative impacts. If during the preparation of the EIR Addendum, additional evaluations for the above impact categories are found to be necessary, the effort to conduct evaluations would be presented as a separate scope.

Deliverables: One electronic copy and eight Administrative Draft Addendum copies will be provided to the City for review, and one hard copy each will be provided to the RWQCB, SWRCB and USDA/RUS.

Task 3: Prepare EIR Addendum

Winzler & Kelly will update the Draft EIR Addendum based on comments received by the City of Rio Dell, RWQCB, SWRCB, and USDA RUS. The Addendum will be presented to City Council at a regular meeting. Winzler & Kelly will prepare the resolution approving the EIR Addendum and prepare and file the Notice of Determination with the Humboldt County Clerk and forward to the State Clearinghouse

Deliverable: One electronic copy and eight Addendum copies will be provided to the City, and one hard copy each will be provided to the RWQCB, SWRCB and USDA/ RUS.

Task 4: Prepare Revised Mitigation Monitoring and Reporting Plan

The Mitigation Monitoring and Reporting Plan (MMRP) details all the mitigation measures for the proposed project and will be prepared under this task. This plan also includes reporting forms for use during the project. This document is required as part of CEQA.

Deliverable: One electronic copy and eight MMRP copies will be provided to the City, and one hard copy each will be provided to the RWQCB, SWRCB and USDA/RUS.

ITEMS NOT INCLUDED IN THIS SCOPE OF SERVICES

This Scope of Services is limited to the items outlined above. The following are not included in this Scope of Services:

- Water quality analysis beyond that already included in the scope of work for the Antidegradation Analysis.
- Recordation or further investigation of sites identified in the cultural resources site survey.

SCHEDULE AND BUDGET

It is anticipated that this Scope of Services can be completed according to the following schedule.

April 2010	Prepare EIR
April 2010	Certify Final EIR Addendum

The actual effort that will be required to complete the tasks and schedule presented in this Scope of Services are contingent upon the actions of others or what is determined during the analysis process. The initial budget allowances presented are initial allocations and the actual cost may be more or less depending on many factors over which neither Winzler & Kelly nor the City has control. Therefore, the tasks in this Scope of Services shall be completed on a time and materials as required basis. The initial total allowance for this scope of services is \$33,082.

The appropriate level of effort will be expended to accomplish the tasks necessary to move the City's wastewater compliance project forward. We will keep the City informed on the progress of the work and any changes in scope, status of the budget, and schedule.

Invoices shall be prepared each month for services provided and shall be due and payable within 30 days of the date of the invoice. Interest at the rate of 1-1/2% per month shall be charged on all outstanding balances.

IT IS RECOMMENDED THAT THE CITY COUNCIL:

- 1. Approve the attached scope of work from PLANWEST PARTNERS, INC. to prepare an update for the Circulation Element of the Rio Dell General Plan.
- 2. Authorize the City Manager to execute an agreement with the above noted planning firm in the amount of \$26,142.
- 3. Direct that funds for the update be transferred from the General Fund Reserve to the Planning budget unit in the amount of \$26,142.
- 4. Direct the City Manager to include the update of the Public Safety Element of the General Plan (\$12,680) in the Proposed 2010-11City Budget for Council's consideration.

BACKGROUND AND DISCUSSION

On the Council's February 16, 2010 agenda was an agenda item concerning the update of the Public Safety Element of the General Plan. The recommendation was that the scope of work prepared by PLANWEST PARTNERS, INC. be approved and funded. During that discussion the Council revisited the discussion that occurred on May 19, 2009 when the priority for updating various elements was made.

Reflecting on its recent goal setting session where redevelopment and economic development was given top priority, the Council deferred on the Safety Element update and requested that scope of work for updating the Circulation Element be brought back for reconsideration at the next meeting. The Circulation Element was last updated in 1977 and Planner George Williamson advised the Council that the completion of this element ties in more closely with the goals of the City than the Public Safety Element, though also important.

PLANWEST PARTNER, INC. has prepared the attached scope of work for your consideration at a cost of \$26,142. George Williamson will be available for questions.

City of Rio Dell General Plan - Circulation Element Update 2010

The Circulation Element of the Rio Dell General Plan was last updated in October 1977. The Circulation Element is one of seven required General Plan elements. Circulation Elements are required to contain "the general location and extent of existing and proposed major thoroughfares, transportation routes, terminals, and other local public utilities and facilities, all correlated with the Land Use Element of the Plan." Planwest Partners proposes the following Circulation Element update scope.

Task 1 Assess Existing Circulation System and Needs

Revise existing circulation system mapping and review data with City staff to ensure accuracy. Prepare circulation base maps for use by traffic engineering and transportation planning subconsultant. Evaluate roadway traffic volumes and capacity, research accident data, compile additional intersection traffic data as necessary based on initial evaluation of circulation system, evaluate system condition, and prepare overall needs assessment.

Budget: \$ 3,078.00

Task 2 Prepare Draft Circulation Goals and ObjectivesBudget: \$ 3,196.00

Facilitate circulation element study sessions with the City of Rio Dell Planning Commission and City Council. The first study session will include a presentation regarding the completed Task 1 assessment of the existing circulation system, discussion of circulation element requirements, and a discussion of needs. The second and third study sessions are intended to identify system needs and circulation element goals and objectives.

Task 3 Update Street, Roadway, and Pathway Classification System and Prepare Draft Circulation Diagram Budget: \$ 3,062.00

Evaluate the existing road and street classification system contained in the Rio Dell Circulation Element. Based on this evaluation and other small city street classification systems, W-Trans and Planwest Partners will revise the classification system and incorporate pedestrian and bicycle facility classifications that better reflect the City's circulation objectives. Prepare a draft Circulation Diagram that attributes the proposed street, road, and pathway classifications to each street in Rio Dell using the City's parcel level and street GIS database.

Task 4 Prepare Draft Plan with Policies, Programs and Recommended RoadwayImprovementsBudget: \$ 5,716.00

The proposed Circulation Element contents are:

- A. Introduction and Circulation Characteristics
- B. Circulation Goals and Objectives

The relevant sections of the City's Scenic Highway Element, last updated in July 1975, are proposed to be incorporated into the updated Circulation Element

Task 5 Prepare Environmental Document for CEQA ComplianceBudget: \$ 6,126.00Evaluate the potential impacts of the draft Circulation Element with respect to the Rio DellGeneral Plan 2015 Program Environmental Impact Report. To the extent that the policies of the
Circulation Element or portions of the Circulation Diagram are beyond the scope of the General
Plan Program EIR, additional environmental review will be required. Additional environmental
review would include the preparation of an initial study and could range from a negative
declaration to some form of supplement to the existing environmental impact report.

Task 6 Planning Commission and City Council HearingsBudget: \$ 1,256.00

Attend two Planning Commission and two City Council Hearings regarding the draft Circulation Element.

Task 7 Prepare Circulation Development StandardsBudget: \$ 3,708.00

It is recommended that the detailed street cross-sections and subdivision street standards be removed from the Circulation Element in the proposed update. The existing street crosssections and development standards will be evaluated as part of the update, and revised diagrams and standards that conform to the circulation element will be proposed for adoption separately in ordinance form.

IT IS RECOMMENDED THAT THE CITY COUNCIL:

Uphold the denial of the Business License application for Eel River Motocross Park for the operation of a dirt bike race course at the former Eel River Saw Mill site.

BACKGROUND AND DISCUSSION

The applicants, Josh Cathy and Bryan Hall applied for a Business License to establish a dirt bike race course on a parcel of land at the former Eel River Saw Mill. The specific parcel there for which the Business license was sought is Assessor's Parcel Number 205-181-001, 1 of the 2 parcels that the City had identified as a potential site for the placement of its new wastewater treatment plant. As such, the site has Public Facility (PF) General Plan and zoning designations.

The proposed business is a private for profit business where a member of the public would pay a fee to use the course for dirt bikes and/or quads. A number of different courses would be created with jumps and moguls ranging from ¹/₄ mile to 1 mile in length. Organized events are envisioned to draw riders from across the north state, perhaps several hundred for a weekend.

The business is represented as being able to draw significant crowds of riders and spectators to the area, benefitting the City through the generation of increased sales tax and transient occupancy tax revenues.

The business license was denied by the Interim City Manager because it is not a use that is permitted in the PF zone, not even with a use permit. Furthermore, the proposed use is not permitted on any parcel at the mill site because if the land is not zoned PF, it is zoned Industrial/Commercial (IC) and the use as described is not permitted in that zone either. There is no zone in the City of Rio Dell that allows for a motocross race course/track use.

Enclosed for the Council's information is the relevant PF Zone Section 4.16 from the City of Rio Dell Zoning Ordinance 252-2004, as amended through January 6, 2009. You will note that the PF zone is intended to be used by public agencies for the operation of public facilities, like a wastewater plant. Neither the Permitted Uses in 4.16 (A) or the Uses Permitted with a Use Permit in 4.16 (B) are available to the proposed use since they are not operated by a public agency. The applicants contend that these sections are applicable to their proposal because the public could use the site, which they term a facility.


In addition, the Rio Dell General Plan Land Use Element defines the following uses for lands designated PF in the Land Use Diagram:

- Residential uses restricted to a caretaker apartment.
- Commercial uses including gift shops and restraints that are part of the civic or cultural use.
- Office uses including civic and cultural uses.
- Lodging uses including lodging as part of the civic or cultural use.
- Civic and cultural uses including governmental services, city parking facilities, conference centers, museums, libraries, day care centers and parks.
- Water and wastewater systems.
- Parks, ball fields and recreational facilities; and
- Recreational uses.

These uses are for civic purposes which are public.

The Business License Ordinance does not provide for an appeal from the City Manager's decision. Notwithstanding, they have been allowed to appeal the decision so that they may be heard by the City Council, the legislative body that adopted the Zoning Ordinance and has the authority to amend it. The appeal of this matter is not been noticed as a public hearing. But that administrative process before the Council would provide a good framework for the applicants to make their case, sans the opening and closing of the public hearing.



Recreational Vehicle

Recreational vehicle" means both of the following:

(a) A motor home, travel trailer, truck camper, or camping trailer, with or without motive power, designed for human habitation for recreational, emergency, or other occupancy, that meets all of the following criteria: (1) It contains less than 320 square feet of internal living room area, excluding built-in equipment, including, but not limited to, wardrobe, closets, cabinets, kitchen units or fixtures, and bath or toilet rooms. (2) It contains 400 square feet or less of gross area measured at maximum horizontal projections. (3) It is built on a single chassis. (4) It is either self-propelled, truck-mounted, or permanently towable on the highways without a permit.

(b) A park trailer, as defined in California Health and Safety Code Section 18009.3, as amended. (California Health and Safety Code Section 180010, as amended)

The average number of dwelling units per one acre of land.

The term second dwelling unit", as used in Section 6.17.5 of the Rio Dell Zoning Ordinance, shall mean an additional living unit on any one lot or parcel within a single-family residential district which is clearly ancillary and subordinate to a principal dwelling unit on the same lot or parcel.
