The Council recessed into Closed Session at 5:00 p.m. to discuss the above matters.

The Council reconvened into open session at 6:30 p.m.

Mayor Wilson announced there was no reportable action taken in closed session.

# PUBLIC PRESENTATIONS

**Nick Angeloff,** Rio Dell-Scotia Chamber of Commerce President addressed the Council and reported on the Chamber meeting held earlier in the day with the City Manager and a representative from Caltrans. He said there was discussion regarding the impacts to local

businesses because of the bridge closure. He commented that the representative went to each of the downtown businesses to explain why the City or the businesses were not notified about the scheduled repairs beforehand. He said the Chamber will be working on ways to make it right and will continue to address the issues on behalf of the businesses.

On the subject of Christmas decorations, he thanked the City for the \$1,500 contribution and reported that they committed to spending \$3,000 on lights and decorations this year. He said they would be ordering shooting stars with interchangeable bulbs so red, white and blue bulbs could be turned on for the July 4<sup>th</sup> holiday.

# CONSENT CALENDAR

City Manager Knopp withdrew item 3 from the Consent Calendar, amending the Position Allocation Table to include the position of Police Corporal.

Motion was made by Johnson/Marks to approve consent calendar items 1, 2 and 4 as presented. Motion carried 4-0.

# **REPORTS/STAFF COMMUNICATIONS**

## City Manager/Staff Update

City Manager Knopp referred to the staff update provided in the Council packet and noted that staff was available at this time to answer any questions from the Council.

He provided an update under the title of <u>Human Resources, Risk & Training</u>, and said the reason for withdrawing item 3 from the Consent Calendar was because Officer Brady submitted his 2-week notice and would be leaving the department to take a job in Willits.

Mayor Wilson asked that staff let him know on behalf of the Council that he will be missed on the force.

Mayor Wilson questioned staff regarding upgrade of the chlorine system.

Wastewater Superintendent Trainee Purvis explained that the repairs were part of the budget adjustment recently approved by the Council. Telstar analyzed and performed necessary repairs to the system and determined that a chlorine cell will need to be replaced for proper operation of the system and further reduction of chemical costs. He noted that the existing cell has two years left on the 7-year warranty so the cost of the new cell will be pro-rated. He added that Telstar would be performing annual inspections of the system.

Mayor Wilson also questioned the status of the Metropolitan Wells Project.

Water/Roadways Superintendent Jensen reported that the wells have been operational since the weekend.

## SPECIAL CALL ITEMS/COMMUNITY AFFAIRS

### Approve Placement of Eagle Sculpture

City Manager Knopp provided a staff report and said last year the artist, Bryan McWaters and Dennis Wendt approached the Council regarding an offer from Wendt Construction to gift the City an Eagle Sculpture. He noted that Dennis requested the sculpture be placed on or near City Hall grounds but no final location was determined. He said the sculpture was estimated to be five (5) feet tall with a wingspan of ten (10) feet. He noted that because of the size of the sculpture, staff could not recommend that it be placed in one of the medians. As such, three (3) potential locations on City Hall grounds were identified for Council's consideration. He noted that there are a couple of details to work out with the artist and recommended the Council either choose one of the three (3) suggested locations, or wait to see photos of the sculpture first.

Mayor Pro Tem Johnson reminded the Council that the Sculpture Committee was established over a year ago and it was his understanding part of the committee's responsibility was to review things such as this and come back to the Council with a recommendation. As such, he would like to see the matter referred to the Committee for recommendation to the Council.

Mayor Wilson said as a member of the Sculpture Committee, this is the first time this issue has come to his attention. He added that his understanding is that Dennis preferred the sculpture to be placed on the front lawn of City Hall.

Councilmember Strahan said she preferred the sculpture be placed on the south corner of the lawn (identified as location C on the map) so as not to detract from the City Hall sign on the north side of the lawn.

Consensus of the Council was to refer the matter to the Sculpture Committee for recommendation to the Council at a subsequent meeting.

Community Development Director Caldwell agreed to schedule a meeting of Sculpture Committee.

Approve Display of the Motto "In God We Trust" in City Council Chambers

City Manager Knopp provided a staff report and said at the October 17, 2017 meeting the Council approved the display of the motto above the City seal in the City Council Chambers. He said the final motto, donated by Councilmembers Johnson and Marks has been completed and delivered to the City. Staff is asking for direction from the current Council to confirm the placement above the City seal or an alternate location in the Council Chambers.

Consensus of the Council was to place the motto above the City seal as previously agreed.

Discuss and Set Priorities for 2018

City Manager Knopp provided a staff report and said at the March 6, 2018 regular meeting, staff held a priority setting session to discuss the priorities of the City Council for 2018. He said the top five (5) priorities fell under the topical headings of **Public Works, Public Safety, and City Transparency.** Specific priority projects included the following:

- Street Work
- River Access
- Habitat Parcel
- Code Enforcement
- Access Humboldt

He provided a review of some of the specific details of each of the selected priority projects and asked for direction from the Council on whether they accept the prioritization process as presented or want to amend it. He noted that staff would include project updates in the regular bi-weekly staff reports to keep the Council apprised on the status of the projects.

Mayor Pro Tem Johnson thought the bi-weekly update was a good idea.

City Manager Knopp said related to Street work, staff's recommendation is to bring back to Council a list of potential road repair options for incorporation into the FY 2018-19 budget. He suggested looking into the possibility of "piggy-backing" on with other local agencies to get some slurry sealing done which may require a budget amendment if the work occurs before the end of the fiscal year.

Mayor Wilson asked if staff is looking for a long-range solution related to Police Department staffing due to the recent resignation of Officer Brady.

City Manager Knopp commented that the resignation was not positive news for the department since the background on the other police officer position is still underway, noting that it takes time to go through the recruitment process. He said when Chief Conner returns from training he will discuss the situation with him and see if he would like support from the City Council to address the issue.

Mayor Wilson called for public comment related to priorities for 2018.

**Sharon Wolfe** expressed appreciation for the Council's willingness to make transparency a priority and possibly bring in Access Humboldt to video tape meetings. She encouraged the Council to make the investment in the necessary equipment to make it work.

Motion was made by Johnson/Marks to accept the 2018 priority list as presented. Motion carried 4-0.

Introduction/First Reading (by title only) of Ordinance No. 365-2018 Amending the City's Commercial Cannabis Regulations, Section 17.30.195 of the Rio Dell Municipal Code to Eliminate the City's Requirement for Background Checks

Community Development Director Caldwell provided a staff report and explained that the City was recently contacted by Attorney Paul Gallegos regarding the differences between the City's and the State's regulations related to disqualifying offenses for owners, operators, officers or directors. He said staff consulted with the City Attorney and the Police Chief and everyone feels that it would be in the best interest of the City to defer the determination of disqualifying offenses to the State, as it could be problematic or potentially litigious if the City made a disqualification determination and the State did not. As such, staff is recommending that Section 17.30.195(9)(j) be eliminated thereby relying on the State to make the determination of disqualifying offenses.

He provided a handout of the City Attorney's comments to the Council for review.

Mayor Wilson commented that the State is still under emergency rules and is not expected to have new regulations in place until July 1, 2018. He expressed concern that in the last round there was going to be a 1-acre cap on cultivation, which everyone had a good feeling about then at the last minute, it changed, and the 1-acre cap was lifted. He suggested the Council wait to see what the State is going to do before amending the ordinance. He added that he does not want to run the risk of being bound to what the State is ultimately going to do down the road.

Community Development Director Caldwell said one concern is that if the Chief of Police were to make a determination of a disqualifying offense and the State did not make the same determination, it could potentially put the City in litigation. He noted that the County of Humboldt eliminated the background check requirement and will be relying on the State.

He pointed out that revisions to most ordinances occur regularly due to changes in State law and this is an evolving process and 90% of it is predicated on what the State does.

Mayor Pro Tem Johnson said the Council needs to protect the Police Chief and the City and agreed with the recommendation of the City Attorney and revision of the Ordinance amendment as presented.

### Councilmember Garnes arrived at this time, 7:05 p.m.

Motion was made by Johnson/Garnes to approve introduction and first reading (by title only) of Ordinance No. 365-2018 Amending the City's Commercial Cannabis Regulations to Eliminate the City's Requirement for Background Checks Subsequent Determinations of Disqualifying Offenses and Rely on the State to Make Such Determinations, and to continue consideration and approval of the proposed amendment to the April 3, 2018 regular meeting. Motion carried 4-1; Mayor Wilson dissenting.

# Discussion and Possible Action Regarding Agenda Publication Deadline

The staff report was included in the Council packet but the item was inadvertently omitted from the agenda. As such, the item was continued to the meeting of April 3, 2018.

# **COUNCIL REPORTS/COMMUNICATIONS**

Mayor Pro Tem Johnson reported on his attendance at the first Quarterly League of California Cities meeting in Cloverdale on March 9<sup>th</sup> and said the legislative committee took action on two Senate bills. The first was a Planning/Zoning bill that would give a great deal of power to private developers and take away a great deal of power from cities. In transit-rich areas, it would disregard local planning and zoning with regard to adopting such things as height limitations, density, parking and design review guidelines. He said the committee voted unanimously to oppose that bill.

He reported that the committee also took action on a bill proposed by Senator McGuire because of the fires last October. He said the process for notifying people to get out of their homes was a disaster because the phone lines and cell towers were down. He said the bill proposes to establish a uniform, consistent emergency notification standard, which the commission unanimously supported.

He added that Assemblyman Wood took an hour to listen to the Cities concerns and pointed out that since he has represented the City on the League both he and Senator McGuire have been very responsive and are two very hard working representatives at the State level.

Mayor Wilson reported on his attendance at the Humboldt Waste Management Authority (HWMA) meeting and said the board approved moving forward with Requests for Proposals (RFP's) for Regional Curbside Recycling. He noted that recycling has taken a big change over the last year and many items thought to be recyclable are no longer recyclable. The problem with that is that the State is still requiring cities to meet certain waste reduction levels and reduce the landfill footprint but is actually telling cities to put items that are no longer considered recyclable into the landfill. As such, the process is not working as originally designed.

Mayor Pro Tem Johnson then announced that he would be attending the bi-monthly LAFCo meeting and one of the items in the packet was facts about how the footprint of usable agricultural land is shrinking. He said that one of LAFCo's requirements is to keep agricultural land in California yet approximately one square mile of high-value agricultural land is converted to residential uses each month.

He also reported that there will be a number of vacancies coming up on the LAFCo board in June as well as his position at the end of the year should anyone be interested in applying.

# DESCRIPTIONS:

# 1. Fortuna Ace Hardware - Hardware - Door Knob \$21.69

Replacement of the Chlorine building door knob to allow for security as the prior installed one was unable to be locked properly.

# 2. Hach - pH EQUIPMENT - \$878.91

The addition of the pH monitoring probe is to allow for continuous monitoring of the combined finished water's pH to ensure the quality of treated water while operating the Rio Dell Metropolitan well site.

# 3. Hach – DPD Free Reagent – \$26.95

The DPD Free Reagent is necessary to allow for the operator to take grab samples of the finished treated water to determine the Chlorine residual and make any adjustments prior to being pumped into the City of Rio Dell distribution system.

# 4. Hach – D900 Analyzer - \$1644.10

The D900 analyzer is a crucial piece of equipment that will be used at the City of Rio Dell Metropolitan well site to test for water parameters such as Chlorine residual (free and total), Turbidity, Iron and Manganese (both low and high concentrations) along with many other parameters that may be necessary to monitor water quality.

# 5. Hach - Reagents - \$154.48

For use with the D900 analyzer in order to perform the necessary testing for Chlorine, Iron and Manganese...etc.

# 6. Freshwater Environmental Services – Testing Consulting Fees - \$1485.00

Freshwater Environmental Service has assisted in the coordination, planning and sampling of the of the ground water around the area of the City of Rio Dell Metropolitan Wells site. Freshwater Environmental Services also coordinated the testing required with Test America Labs to analyze the samples for TCP and Dioxins that were known to be found at the Brownfield site that is located to the West of the City of Rio Dell Metropolitan Wells site.

# 7. Test America (B of A) – Well Testing - \$1925.00

Laboratory cost for sample testing of the Ground water around the Rio Dell Metropolitan Wells Site.

# 8. Test America (B of A) – Well Testing - \$2257.50

Laboratory cost for sample testing of the Ground water around the Rio Dell Metropolitan Wells Site.

# 9. North Coast Labs – Well Testing - \$2000.00

Laboratory cost for sample testing of the Ground water around the Rio Dell Metropolitan Wells Site.

# 10. Freshwater Environmental Services – Letters and Information - \$4140.00

Freshwater Environmental Services provided information regarding the Brownfields Site and surrounding area with historical data as they were involved in the sampling of the area in the past. G3 Engineering provided the new Chlorine Chemical Feed Pump for the Rio Dell Metropolitan Wells site. An addition part (smaller tubing) was needed to allow for more adjustable controls on the dosing of the pump.

The replacement of the undersized 4"x 6" touch screen to a larger 10"x 12" was required to allow for all the necessary information and controls being displayed while still being legible.

The addition of the Red Lion component was used to connect the WesTech Filter control panel to Aqua Sierra's Control panel for an improved method of control of the Rio Dell Metropolitan Wells system thru the Scada system.

Aqua Sierra Controls is the City of Rio Dell's Scada system provider. Aqua Sierra developed some additional necessary programming to allow for local and remote controls (via through the Scada system) of the Rio Dell Metropolitan Wells site in order to operate and monitor more effectively.

### Pay Recommendation

Wahlund Construction's Pay Requests No. 11-13 are attached to this memo. Pay Request 11 (\$66,242.89) covers the 5% retention that has been held from previous pay requests throughout the project. Because additional change order work occurred after the retention was requested, Pay Request 11 was withheld until the construction was complete. Pay Request 12 (\$1,512.28) covers the cost of Change Order #7, and Pay Request 13 (\$7,889.92) covers Change Orders #7-8. No retention was withheld from Pay Requests 12-13, as they will be paid to Wahlund concurrently with Pay Request 11.

We recommend payment to Wahlund Construction for Pay Requests No. 11-13 in a total amount of \$75,645.09.

Once the project is approved by City Council, GHD will prepare a Notice of Completion for the project that is to be signed and filed by the City. The retention can be released to the Contractor 35 days after the Notice of Completion is filed. Please contact me if you have any questions.

### RE: Metropolitan Wells Redevelopment Project Progress Payment Requests No. 11-13 for Wahlund Construction

Dear Kyle,

Construction of the Metropolitan Wells Redevelopment Project is complete. The Contractor executed a process performance test on the treatment system December 12-14, and the system produced potable water that met the performance requirements for the system and State water quality standards. Wahlund was paid for the full amount of the contract, less the 5% retention, after this performance test was completed (Pay Request 10). After some final outstanding miscellaneous submittals were provided by Wahlund, they requested a release of the retention (Pay Request 11, \$66,242.89). After this request was made, it was determined that three additional change orders were required:

- 1. Change Order #7 (\$1,512.28) New chemical feed pump
  - a. The original pump was defective and not working properly, so it was returned to the manufacturer. In the meantime, the City decided that they would prefer a slightly different pump for this application. A credit was provided for the original pump, so the change order amount included the difference in cost between the new pump and the original pump.
- 2. Change Order #8 (\$4,135.20) Clear well transducer interference
  - a. The level transducer in the clear well was giving unstable and erratic clear well level readings when Booster Pump #1 was running, but not when Booster Pump #2 was running. Flow meters in a separate area of the project were giving erratic readings as well. This Change Order included running a new conduit up the interior building wall from the PLC panel and around the building interior to the northwest corner of the building, closest to the clear well. The conduit exited the wall and transitioned underground to a pullbox. It was then run underground to the clear well, and new signal wires were installed.
- 3. Change Order #9 (\$3,754.72) Well flow meters interference
  - a. The flow meters from Wells #1 and #3 were giving unstable and erratic flow readings. After extensive field troubleshooting with the design engineer and the electrical subcontractor, a grounding issue with the flow meters was identified, and when it was rectified, the flow meters performed as required. However, operations staff desired an alternative conduit to provide additional system redundancy. This was a prudent decision, as the flow meters are an integral part of the overall system control. Change Order #8 included running a new conduit up the interior building wall from the PLC panel and around the building interior to the northwest corner of the building, closest to the clear well. The conduit then exits the wall and transitions underground to a new pullbox. The new conduit and pullbox installed under Change Order #8 were utilized for the work that occured under Change Order #9. Signal cables for the flow meters were pulled

IT IS RECOMMENDED THAT THE CITY COUNCIL:

Authorize the Mayor to sign letter of support.

BACKGROUND AND DISCUSSION

From the League of California Cities:

Cities are encouraged to support <u>AB 2598 (Quirk)</u>, which will assist cities' ability to enforce local ordinances and building codes by updating the existing statutory fine caps for inflation.

The bill also establishes a higher maximum fine for commercial property owners who repeatedly fail to maintain their property and adds a hardship process for repeat violators.

The statutory fine amounts for violations of local ordinances and building codes have not been updated for many years, and are losing their deterrent effect. Inadequate available penalties can erode respect for the law. If the consequences for violating a local ordinance or building standard are deemed to be minimal then some community members will ignore the law and create inequities in its application.

For instance, if an ordinance requires dry brush to be cleared for fire protection, and a property owner chooses not to do so, they could be placing the homes of their neighboring properties at risk. If one property owner allows trash and junk to build up on their property, it could attract vermin and devalue adjacent properties.

In brief, AB 2598 would accomplish the following:

- Update for inflation the fine levels for repeated violations, while continuing to keep the initial fine lower because the object of such laws is securing compliance with local requirements to uphold community requirements, not collecting fines;
- Authorize a \$2,500 fine for commercial property owners who repeatedly fail to maintain their properties; and

• Establish a hardship waiver process for repeated violators who have made a bona fide effort to comply with the first violation and payment of the additional fines would create an undue financial hardship.

# IT IS RECOMMENDED THAT THE CITY COUNCIL:

Authorize staff to submit applications.

# BACKGROUND AND DISCUSSION

On May 6, 2003 the City Council authorized execution the RCEA Joint Powers Agreement (JPA) via Resolution No. 842-2003 and the City of Rio Dell has been a member ever since. RCEA was established to provide regional development and implementation of energy programs that reduce demand, increase efficiency and advance the use of renewable resources for the benefit of local residents, businesses and institutions.

RCEA has been authorized to implement a Public Agency Pilot Solar Program with the intended purpose of offsetting electrical load at public facilities. The program is supported by net revenue from the Community Choice Energy (CCE) program that Rio Dell joined via Ordinance No. 345-2016 on November 15, 2016. Because of these actions, Rio Dell (and other member agencies) will be given a priority for assistance that we would not otherwise receive.

The concept of adding renewable energy at City facilities has been explored before but has not proceeded due to lack of staff resources and other competing priorities, such as regulatory compliance. While a solar project is not required by any State regulatory agency, there are several potential advantages to be gained by adopting these technologies. RCEA has recently approved \$170,000 in resources to help provide assistance to applicants with regard to planning, financing and implementation of these projects. Utilizing the resources of RCEA could help expedite the realization of these projects and leverage the Authority's expertise in this subject area.

## Potential projects:

Wastewater Treatment Plant: Prior exploration of this project involved the demolition of the old wastewater treatment system to create a "solar field." However, that demolition has been replaced by a project to recycle the old wastewater plant for use in pre-treating water system

backwash from the filtration process prior to the water being introduced into the WWTP. The new solar concept involves placing a solar array directly above the WWTP itself, thereby reducing algae growth at the plant and improving its performance and environmental regulatory compliance – thereby accomplishing two important tasks with one project. The WWTP consumes large amounts of electricity and energy enhancements would be important to containing the cost of electricity and the potential implementation of an Ultraviolet disinfection system which would improve regulatory compliance and staff safety.

**City Hall Roof:** The City Hall roof could be an ideal location for a relatively straight-forward solar installation.

Rio Dell qualified as a low income area so low income residents will be eligible for the maximum funding for replacement of any non-EPA certified wood stove with cleaner, more fuel-efficient wood heating devices or other less polluting heating appliances including gas, electric, propane or pellet stoves. As part of the community outreach they asked that staff get the word out to local residents; possibly with the next City Newsletter. Funds for this program will be available during the summer-fall enrollment period. They will be sending out additional information about the program as it becomes available.

During the period of March 14, 2018 to March 27, 2018, there were fifty-four calls for service generating eighteen reports and eight arrests.



On March 27, 2018, a woman driving west of Monument Road from Wildwood in a Nissan Murano, collided with a parked car, overcorrected, jumped the sidewalk and struck the remainder of the concrete retaining wall at 61 Monument Road. Fortunately, the car did not roll down the embankment. The driver suffered minor injuries and the car was rendered inoperable. The driver was evaluated for driving under the influence and arrested. The wrecked car was removed and Public Works replaced/repaired the barriers that block access to the damaged portion of the sidewalk.

The Police Department's two requests for Measure Z funding both passed the first round of cuts. # BACKGROUND AND DISCUSSION

The contract work for the Metro Wells Project has been completed. The final treatment system has undergone the required performance testing and the final results have been approved by the Division of Drinking Water.

Staff is assembling the final paperwork to be submitted to USDA. One of the items required by USDA is acceptance of the project. This will be followed by the recording of the Notice of Completion and then 35 days later, the release of the final contractor retention by the City. Once approved, the City engineer (GHD) will file the Notice of Completion and will submit on behalf of the City all required documents to USDA Rural Development.

The Metropolitan Wells project was developed as a backup water supply system and City staff is currently integrating the use of the new facility into the City's water supply and treatment systems.

1. Suggestions for Improving Public Awareness: with the waste and recycling industry changing year to year and more and more environmental regulations being added all the time. It's hard to keep up with. Educating the public of what is and is not recyclable is an ongoing issue.

Prior to Recology's acquisition, Eel River Disposal primarily utilized the Rio Dell Newsletter to let residents keep up with what is going on in the waste and recycling industry.

Recology is still transferring over the customer data base. The transfer will happen Summer 2018. Once that is finished, future billing can contain messages related to our services.

The Recology Eel River website is also being updated, so that once the customer addresses are uploaded, the customer or anyone in Rio Dell can enter their address to find out which can to use for each piece of recycling or waste they generate. They simply only need to press the "Whatbin" option. Using the website the public will also have the ability to email questions to our staff that will be answered within a day or two. The website will also have news articles and resources about waste and recycling for people to access.

Recology also maintains a Facebook page that relays what Recology information on our services, laws and regulations and what the is doing in the community.

- 2. Prior Year Participation Rate: The average recycling participation rate for the year was 90%. Recycling is offered to curbside garbage customers who subscribe to 20, 32, and 45 gallon service and no extra charge. Not all of the customers take advantage of the program. There are additional accounts of people who only subscribe to curbside recycling. Over the past year, Eel River Disposal did not track "set-out" rates. Random survey weeks are performed instead to count how many of the known customers are setting out the recycling carts at a given date.
- 3. Amount of Material Diverted from the Waste Stream: Rio Dell residential curbside recycling was 143.1 tons for 2017. Recycling collected behind Rio Dell City Hall totaled 181.74 tons.

Using US EPA conversion table for loose yard waste, another 203.02 tons was collected from the curbside yard waste program. Additional recycling tonnage was collected at City Hall.

4. Significant Highlights, Noteworthy Experiences with Recology Eel River (Eel River Disposal):

These are some of the highlights from last year.

Recology, a 100% employee owned San Francisco based company, purchased Eel River Disposal in 2017 and took over operation of their facilities and contracts September 1, 2017.

Recyclables diverted off the Recology Eel River transfer station (in Fortuna) floor 1,011.23 tons.

Paint recycled through the PaintCare program **18.09 tons.** Paint may be dropped off at the Recology Eel River transfer station (in Fortuna) at no charge.

Used oil, 3,295 gallons were dropped off to the Recology Eel River transfer station (in Fortuna).

*E-waste* **162** *tons. E-waste may be dropped off at the Recology Eel River transfer station (in Fortuna) at no charge.* 

Household batteries **3.83 tons.** Household Batteries may be dropped off at the Recology Eel River transfer station (in Fortuna) at no charge.

Florescent Bulbs **2.48 tons.** you can drop off up to 6 Florescent Bulbs may be dropped off at the Recology Eel River transfer station (in Fortuna) at no charge.

# BACKGROUND AND DISCUSSION

Every regular meeting of a legislative body of a local agency—including advisory committees, commissions, or boards, as well as standing committees of legislative bodies—must be preceded by a posted agenda that advises the public of the meeting and the matters to be transacted or discussed. The agenda must be posted at least 72 hours before the regular meeting in a location "freely accessible to members of the public." The courts have not definitively interpreted the "freely accessible" requirement. The California Attorney General has interpreted this provision to require posting in locations accessible to the public 24 hours a day during the 72-hour period, but any of the 72 hours may fall on a weekend. Posting may also be made on a touch screen electronic kiosk accessible without charge to the public 24 hours a day during the 72-hour period. However, only posting an agenda on an agency's Web site is inadequate since there is no universal access to the internet. The agenda must state the meeting time and place and must contain "a brief general description of each item of business to be transacted or discussed at the meeting, including items to be discussed in closed session.

Current State law requires agendas for the regularly scheduled City Council and Planning Commission meetings be published no more than 72 hours prior the meeting. Typically this is between 5:00pm and 6:30pm on a Saturday. Current agenda publications have typically been out by 4:00pm on Fridays.

# BACKGROUND AND DISCUSSION

The Metropolitan Wells Project is nearing completion. In the past water system staff has expressed the need for an emergency generator and the Council has expressed its desire to purchase a generator. Staff currently estimates the cost of a 100kw generator at \$80,271 including tax, delivery and a contingency. It is recommended that the Council authorize staff to purchase a CAT XQ125 portable generator, due to the City's ownership of another CAT product, thereby creating efficiencies in equipment maintenance. There is approximately \$38,347 in remaining project funds dedicated to the Metropolitan Wells Project. Staff has submitted a change in the scope of the project in order to obtain approval for the purchase of a generator from our funding partners at the Department of Water Resources. That approval is still pending and no purchase will occur until that approval is secured. If approval is denied, staff will return to the Council for further direction. Staff estimates an additional \$41,924 of water system capital funds will be needed to complete the purchase. This expenditure brings the City's contribution to the Metropolitan Wells project to an estimated 5.28% of the project total. Use of the generator will be restricted to the water system.

# **Recommendation:**

- 2. Open the public hearing, receive public input and deliberate; and
- 3. Adopt Ordinance No. 365-2018 amending the City's Commercial Cannabis Regulations to eliminate the City's requirement for background checks subsequent determinations of disqualifying offenses and rely on the State to make such determinations.

# **Background and Discussion**

As was as reported at your meeting of March 20, 2018, the City was recently contacted by Attorney Paul Gallegos regarding the City's and the State's regulations related to disqualifying offenses for owners, operators, officers or directors. Mr. Gallegos pointed out that there are a number of differences between the City's regulations and the State's regulations. Again, as the Council is aware the City's regulations predated the State MAUCRSA regulations.

Again staff's recommendation is based on discussions with the City Attorney and the Police Chief. We all feel that it would be in the City's best interest to defer the determination of disqualifying offenses to the State. It could be problematic and potentially litigious if the City made a disqualification determination and the State did not. As such, we are recommending that the City's current background and determination of disqualify offenses regulations, Section 17.30.195(9)(j) be eliminated and rely on the State to make the determination.

The Council voted 4-1 with Mayor Wilson dissenting to approve the first reading of the proposed amendments. A copy of the recommended amendments is included in Attachment 1.

# **Text Amendment Required Findings:**

# 1. The proposed amendment is in the public interest.

The proposed amended regulations are in the public interest in that they are consistent with the new State regulations.

# 2. The proposed amendment is consistent and compatible with the General Plan and any implementation programs that may be affected.

There are no General Plan goals, policies or discussions that are contrary to the recommended amendment. Therefore, staff believes the proposed amendment is consistent with the General Plan.

# 3. The proposed amendments have been processed in accordance with the California Environmental Quality Act (CEQA).

The primary purpose of the California Environmental Quality Act (CEQA) is to inform the decision makers and the public of potential environmental effects of a proposed project.

Based on the minor nature of the proposed amendment, staff has determined that the project is Statutorily Exempt pursuant to Section 15061(b) (3) of the CEQA Guidelines, Title 14, Chapter 3 of the California Code of Regulations. Pursuant to Section 15061(b) (3) of the CEQA Guidelines this exemption is covered by the general rule that CEQA applies only to projects which have the potential for causing a *significant* effect on the environment. **WHEREAS** the City was recently contacted by a local Attorney regarding the City's and the State's regulations related to disqualifying offenses for owners, operators, officers or directors; and

**WHEREAS** it was brought to the City's attention that there are a number of differences between the City's regulations and the State's regulations; and

WHEREAS the City's regulations predated the State MAUCRSA regulations; and

**WHEREAS** staff consulted with the City Attorney and the Police Chief and we believe it would be in the City's best interest to defer the determination of disqualifying offenses to the State; and

**WHEREAS** It could be problematic and potentially litigious if the City made a disqualification determination and the State did not; and

**WHEREAS** the City has reviewed and processed the proposed amendment in conformance with Sections 65350 – 65362 of the California Government Code; and

**WHEREAS** the City Council finds that based on evidence on file and presented in the staff report that the proposed amendments are consistent and compatible with a comprehensive view of the General Plan and any implementation programs that may be affected; and

**WHEREAS** the City Council finds that based on evidence on file and presented in the staff report that the potential impacts of the proposed minor amendments have been assessed and have been determined not to be detrimental to the public health, safety, or welfare; and

WHEREAS the proposed amendments have been processed in accordance with the applicable provisions of the California Government Code and the California Environmental Quality Act (CEQA); and

**WHEREAS** the City Council has determined that the proposed amendments are Statutorily Exempt pursuant to Section 15061(b) (3) of the CEQA Guidelines, Title 14, Chapter 3 of the California Code of Regulations.

- 3. Finds that based on the nature of the proposed amendments, the project is Statutorily Exempt pursuant to Section 15061(b) (3) of the CEQA Guidelines, Title 14, Chapter 3 of the California Code of Regulations. Pursuant to Section 15061(b) (3) of the CEQA Guidelines this exemption is covered by the general rule that CEQA applies only to projects which have the potential for causing a *significant* effect on the environment; and
- 4. Approves and adopt Ordinance No. 365-2018 amending the City's Commercial Cannabis Regulations to eliminate the City's requirement for background checks subsequent determinations of disqualifying offenses and rely on the State to make such determinations

**BE IT FURTHER RESOLVED,** that the City Council of the City of Rio Dell does hereby ordain as follows:

Section 1

Section 17.30.195(9)(j) of the Rio Dell Municipal Code is hereby amended as follows:

(9) Application Requirements for All CCLUO Conditional Use Permits:

(j) Owner(s) or employee(s) who makes or will make operational or management decisions that directly impact the business shall consent to a background check pursuant to Section 19322(a)(1)(A) of the Business and Professions Code, including submitting to the Department of Justice fingerprint images and related information required by the Department of Justice for the purpose of obtaining information as to the existence and content of a record of State or Federal convictions and arrests, and information as to the existence and content of a record of State and Federal convictions and arrests for which the Department of Justice establishes that the person is free on bail or on his or her own recognizance, pending trial or appeal. The applicant shall be responsible for the costs associated with the required background check.

(i) No Owner or employee who makes or will make operational or management decisions that directly impact the business shall have been convicted of an offense, or is currently free on bail or on his or her own recognizance pending trial or appeal for an offense, that is substantially related to the qualifications, functions, or duties of the business or profession for which the application is made, including but not be limited to, the following:

- (A) A felony conviction for the illegal possession for sale, manufacture, transportation, or cultivation of a controlled substance;
- (B) A violent felony conviction, as specified in subdivision (c) of Section 667.5 of the Penal Code.
- (C) A serious felony conviction, as specified in subdivision (c) of Section 1192.7 of the Penal Code.

#### (D) A felony conviction involving fraud, deceit, or embezzlement.

The applicant or any of its officers, directors, owners or licensee shall be subject to the background checks related to the qualifications, functions or duties of the business required by the Medicinal and Adult Use Cannabis Regulation and Safety Act (MAUCRSA). The City shall rely on the State in making disqualifying determinations regarding substantially related offenses pursuant to Section 26057 of the Business and Professions Code.

#### Section 2. Severability

If any provision of the ordinance is invalidated by any court of competent jurisdiction, the remaining provisions shall not be affected and shall continue in full force and effect.

# Section 3. Limitation of Actions

Any action to challenge the validity or legality of any provision of this ordinance on any grounds shall be brought by court action commenced within ninety (90) days of the date of adoption of this ordinance.

# Section 4. CEQA Compliance

The City Council has determined that the adoption of this ordinance is exempt from review under the California Environmental Quality Act (CEQA), subject to Section 15061 of the CEQA Guidelines. Due to the nature of the proposed code revisions, there is no evidence that any significant impact to the environment would occur as a result of adoption of the Ordinance.

# **Background and Discussion**

Staff recently discovered that the City's Flood Regulations still refer to the Federal Emergency Management Agency (FEMA) 1982 Flood Insurance Study and the associated Flood Insurance Rate Maps (FIRM). FEMA updated the 1982 Study and Maps in 2016. As such, we need to amend the City's Flood Damage Prevent Regulations to reflect the updated information. Below are the recommended changes.

# 15.15.070 Basis for establishing areas of special flood hazard.

The areas of special flood hazard identified by the Federal Emergency Management Agency of the Federal Insurance Administration in a scientific and engineering report entitled "Flood Insurance Study for the City of Rio Dell dated November **3** <u>4</u>, <u>1981</u>, <u>2016</u> with an accompanying Flood Insurance Rate Map dated <u>May 3</u>, <u>1982</u> <u>November 4</u>, <u>2016</u>," and all subsequent amendments and/or revisions are hereby adopted by reference and declared to be a part of this chapter. This flood insurance study is on file at the Rio Dell City Hall. This flood insurance study and attendant mapping is the minimum area of applicability of this chapter and may be supplemented by studies for other areas which allow implementation of this chapter and which are recommended to the City Council by the Floodplain Administrator. [Ord. 235 § 3.2, 1999.]

In addition, staff is recommending changes to the regulations regarding the required elevations for structures located within a flood zone. The City's current regulations require that the lowest floor of a structure to or above the base flood elevation. Although this is consistent with FEMA's regulations, the California Building Code (CBC) refers to the American Society of Civil Engineers (ASCE) regulation 24-14, Table 2-1 which requires that the lowest floor be one (1) foot above the base flood elevation. As such, staff is recommending that the City's Flood Damage Prevent Regulations be amended to be consistent with the CBC. Below are the recommend changes.

# 15.15.150 Standards for construction.

In all areas of special flood hazard, the following standards are required:

(3) Elevation and Floodproofing.

(a) New construction and substantial improvements of any structure shall have the lowest floor, including basement, elevated to **or** <u>one (1)</u> <u>foot</u> above the base flood elevation. Nonresidential structures may meet the standards in subsection (3)(b) of this section upon the completion of the structure. The elevation of the lowest floor including basement shall be certified by a registered professional engineer or surveyor and verified by the community building inspector to be properly elevated. Such certification and verification shall be provided to the Floodplain Administrator.

# 15.15.180 Standards for manufactured homes.

All new and replacement manufactured homes and additions to manufactured homes shall:

(1) Be elevated so that the lowest floor is **at or <u>one (1) foot</u>** above the base flood elevation; and

(2) Be securely anchored to a permanent foundation system to resist flotation, collapse or lateral movement. [Ord. 235 § 5.4, 1999.]
